Item No. 1 Call to Order

The meeting was called to order at 5:49 p.m. with the following members present: Brian Dale (chair), Nancy Joslin, Bill Fraser, Tim Bennett, and Ron Tykoski. The following members were absent: David Downs, Steven Bolen, and Dollie Thomas. Collin County staff present: Jeff Durham, Teresa Nelson, and Tracy Homfeld. Clarence Daugherty was present for a brief introduction and announcement that Jeff and Teresa were retiring. Guests: none.

Item No. 2 Approval of August 13, 2020, Minutes

Nancy made a motion to approve the minutes, second by Ron, which passed unanimously.

Item No. 3 Discussion of the email distribution of quarterly progress reports (if any) and discuss the status of funded projects through the Project Funding Assistance Program

Jeff gave an overview of the progress reports received since our last meeting in March.

The following submitted report(s): City of Richardson (Breckinridge Park), City of Plano (Cottonwood Creek Greenbelt Trail); City of Melissa, City of Allen (Exchange Pkwy Community Park Trails), and City of Allen (Eugene McDermott Park/Rowlett Trail).

Item No. 4 Final review, discussion and any action regarding the Project Funding Assistance Program, 2nd Series, 2018 Bond (\$2 million)

Jeff informed the board that a need for fence repair/replace and paint at Myers Park had been identified and was directed to seek recommendation from this board to utilize the parks/open space bond funds. Therefore, added for consideration is an application from Myers Park.

A total of fifteen applications were reviewed with a total project cost of \$23,611,216.32 and a total funding request amount of \$5,637,579. This series has a total of \$2 million available for award. An initial review and discussion was held during the August board meeting. The following are the results and action taken for each project:

Myers Park – Tim made a motion to recommend \$60,000; second by Nancy, passed unanimously
Heard Natural Science Museum – Nancy made a motion to recommend \$16,000, second by Bill, passed unanimously

City of Allen – Bill made a motion to recommend \$379,200, second by Brian, passed unanimously

City of Anna (Downtown Slayter Creek Park Trail Extension) – Brian made a motion to not recommend funding, second by Ron, passed unanimously

City of Anna (Phase I Slayter Creek Park and Natural Springs Park Connection) – Nancy made a motion to not recommend funding, second by Ron, passed unanimously

City of Anna (Phase 2 Slayter Creek Park and Natural Springs Park Connection) – Nancy made a motion to not recommend funding, second by Ron, passed unanimously

City of Anna (Phase 1, Option A) Pecan Grove Park Trail Extension – Nancy made a motion to not recommend funding, second by Ron, passed unanimously

City of Anna (Phase 1, Option B) Pecan Grove Park Trail Extension – Nancy made a motion to not recommend funding, second by Ron, passed unanimously

City of Celina – Bill made a motion to fund \$1.5M, second by Ron, passed unanimously

City of Frisco – Nancy made a motion to fund \$100,000 toward project elements 7, 8, 9; second by Tim, passed unanimously

City of McKinney – Tim made a motion to not recommend funding; second by Nancy, passed unanimously

City of Plano – Brian made a motion to fund \$200,000; second by Nancy, passed unanimously with an abstention from Tim

City of Princeton – Bill made a motion to not recommend funding, second by Nancy, passed unanimously

Town of Prosper – Nancy made a motion to not recommend funding, second by Brian, passed unanimously

City of Richardson – Tim made a motion to not recommend funding, second by Nancy, passed unanimously
