

September 9, 2021**

Item No. 1 Call to Order

The meeting was called to order at 6:00 p.m. with the following members present: Steve Bolen (chair), Bill Fraser, Tim Bennett, David Bell, David Downs and Chris Catullo. The following members were absent: Dollie Thomas, Ron Tykoski, and Carson Underwood. Collin County staff present: Tracy Homfeld and Dawn Redwine. Guests: none.

Item No. 2 Approval of August 12, 2021, Minutes

David D. made a motion to approve the minutes, second by Tim, which passed unanimously.

Item No. 3 Update and discussion, if applicable, of the status of funded projects through the Project Funding Assistance Program

Dawn stated that there were no updates since the Aug. meeting.

Item No. 4 Review, discussion and any action regarding the Project Funding Assistance Program, 3rd Series, 2018 Bond (\$2 million)

A total of sixteen applications were reviewed with a total project cost of \$21,820,465.00 and a total funding request amount of \$6,573,037.16. This series has a total of \$2 million available for award. An initial review and discussion was held during the August board meeting. The following are the results and action taken for each project:

City of Allen – David D. made a motion to fund \$134,176 toward project elements 8 and 9, second by David B., passed unanimously

City of Fairview – David D. made a motion to fund \$44,915 towards all project elements except 9, second by David B., passed unanimously

City of Frisco – David B. made a motion to fund \$211,920 toward project elements 4 and 5; second by Tim, passed unanimously

City of Farmersville – David D. made a motion to not recommend funding; second by David B., passed unanimously

City of Josephine-Chris made a motion to fund \$45,464.50, which is entire request; Chris then amended his motion to \$45,464; second by David B., passed unanimously

City of Lavon-David B. made a motion to fund \$233,250 toward project elements 1-5; seconded by Tim, passed unanimously

City of Lowry Crossing-David D. made a motion to fund \$412,067, which is entire request; seconded by Tim, passed unanimously

City of Melissa-David D. made a motion to fund \$146,666, which is entire request; seconded by Tim, passed 5/1

City of McKinney – David B. made a motion to fund \$396,000 towards project elements 1, 10 and 11; second by David D., passed unanimously

Town of New Hope-Chris made a motion to fund \$43,846, which is entire request; seconded by David B., passed unanimously

City of Plano – David B. made a motion to not recommend funding, seconded by Chris, passed unanimously

City of Princeton – David B. made a motion to fund \$354,362 towards project elements 2 and 5; seconded by David D., passed unanimously

Town of Prosper – Bill made a motion to fund \$200,550 towards project elements 2 and 4; seconded by David D., passed unanimously

City of Royse City – David D. made a motion to not recommend funding; seconded by David B., passed unanimously

City of Sachse-David D. made a motion to fund \$161,294 toward project elements 25, 27 and 29; seconded by David B., passed unanimously

City of Wylie-David B. made a motion to not recommend funding; seconded by Chris., passed unanimously

Item No. 5 Possible future agenda items

- Regional trail map needs to be updated. If we can get consent to update by October, then we will have an October meeting to discuss a plan to move forward. If not, then we will meet in November.
- Need for application workshop to invite cities in to see the application process.
- Reevaluate items that are required to be submitted with the applications and update as needed.
- Discuss the possibility of changing the regulations for applying for land acquisition. Possibly allow to reimbursement of land that was purchased previously.
