**1. Call Meeting to Order**

Carson Underwood called the meeting to order at 5:34 PM with the following members present in person: Carson Underwood ('22 chair), Chris Catullo ('22 Vice Chair), Bill Fraser, Ron Tykoski, and Jennifer Irwin; Via Webex: Dollie Thomas, David Bell, absent: Steve Bolen; Collin County staff present: Tracy Homfeld and Dawn Redwine; Guests: none.

**2. Approval of August 11, 2022 Minutes**

**3. Review and discuss current projects funded through the Project Assistance Program**  
No updates at this time.

**4. Review, discussion and any action regarding the Project Funding Assistance Program, 4<sup>th</sup> Serest, 2018 Bond (\$2 million)**

A total of fourteen applications were received with a total project cost of \$16,323,243 and a total funding request amount of \$4,851,510. This series has a total of \$2 million available for award with an additional \$28,414 in contingency that can be used. An initial review and discussion was held during the August board meeting. The details of each project and the recommended amounts for funding can be found on the attached Excel Spreadsheet titled “2022 4<sup>th</sup> Series\_Board Meeting”.

2. **City of Allen (Molsen Farm Acquisition III)**—Fund in full
3. **Chase Oaks Church (Local Good Community Recreational Park)**—No Funding
4. **Town of Fairview (Stacy Rd to Monarch Park Trail Connection)**—Fund in full
5. **City of Farmersville (City Park Acquisition)**—Fund in full, contingent on receiving Resolution before Commissioners Court vote.
6. **City of Farmersville (City Park Retaining Wall Improvements)**—No Funding
7. **City of Farmersville (Rambler Park)**—Fund in full
8. **City of Farmersville (Onion Shed Improvements)**—Fund in full
9. **City of Farmersville (CORP of Eng. Caddo Park Improvements)**—Fund in full
10. **City of Frisco (Powerline Hike & Bike Trail)**—Partial funding
11. **City of Lucas (Central Trail Loop Segment)**—No funding
12. **City of McKinney (Wilson Creek Greens Trail)**—Partial funding
13. **City of Plano (Los Rios Park Trail)**—Partial funding
14. **Town of Prosper (First Street Pedestrian & Bicycle Tunnel and Trails)**—Partial funding
