

1. Call Meeting to Order

2. Approval of March 16, 2023 Minutes

Bill made a motion to approve, second by Harshad, which passed unanimously.

3. Review and discuss current projects funded through the Project Assistance Program

Staff gave a verbal update stating that one project had fully funded and closed since the last meeting.

4. Review proposed trail alignment change for City of Frisco-Independence Hike & Bike Trail

Dawn explained the designed changed and maps were given to those in attendance. Bill made a motion to approve proposed change, second by Carson, which passed unanimously.

 - Add one pager about open space to plat applications
 - Accommodate trails into the Subdivision Regulations.
