1. Call Meeting to Order

2. Approval of January 11, 2024 Minutes

Carson made a motion to approve, second by Chris, which passed unanimously.

3. Review and discuss current projects funded through the Project Assistance Program

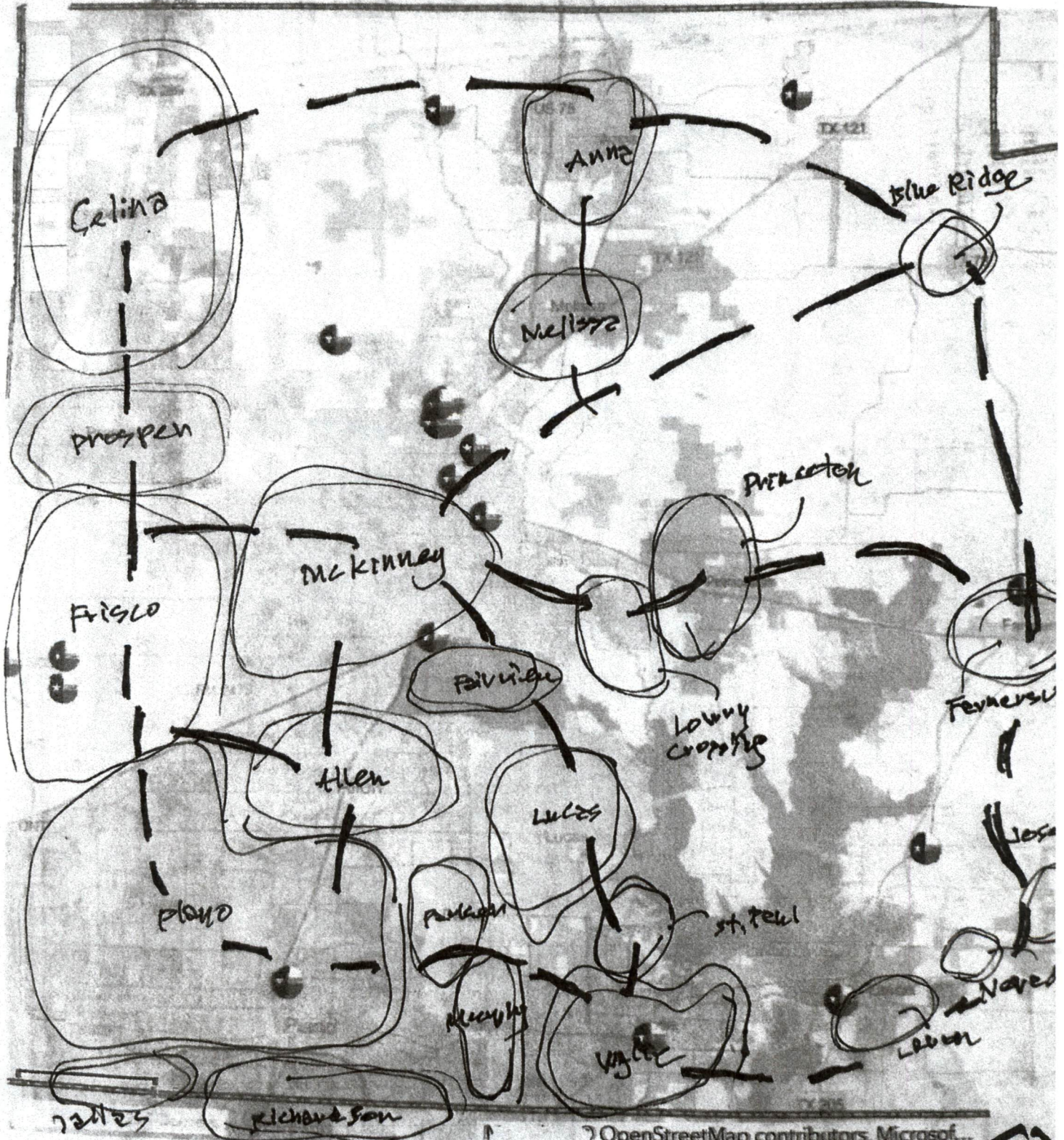
Chris made a motion to adjourn and second by Carson. The meeting adjourned by Ron at 7:26PM

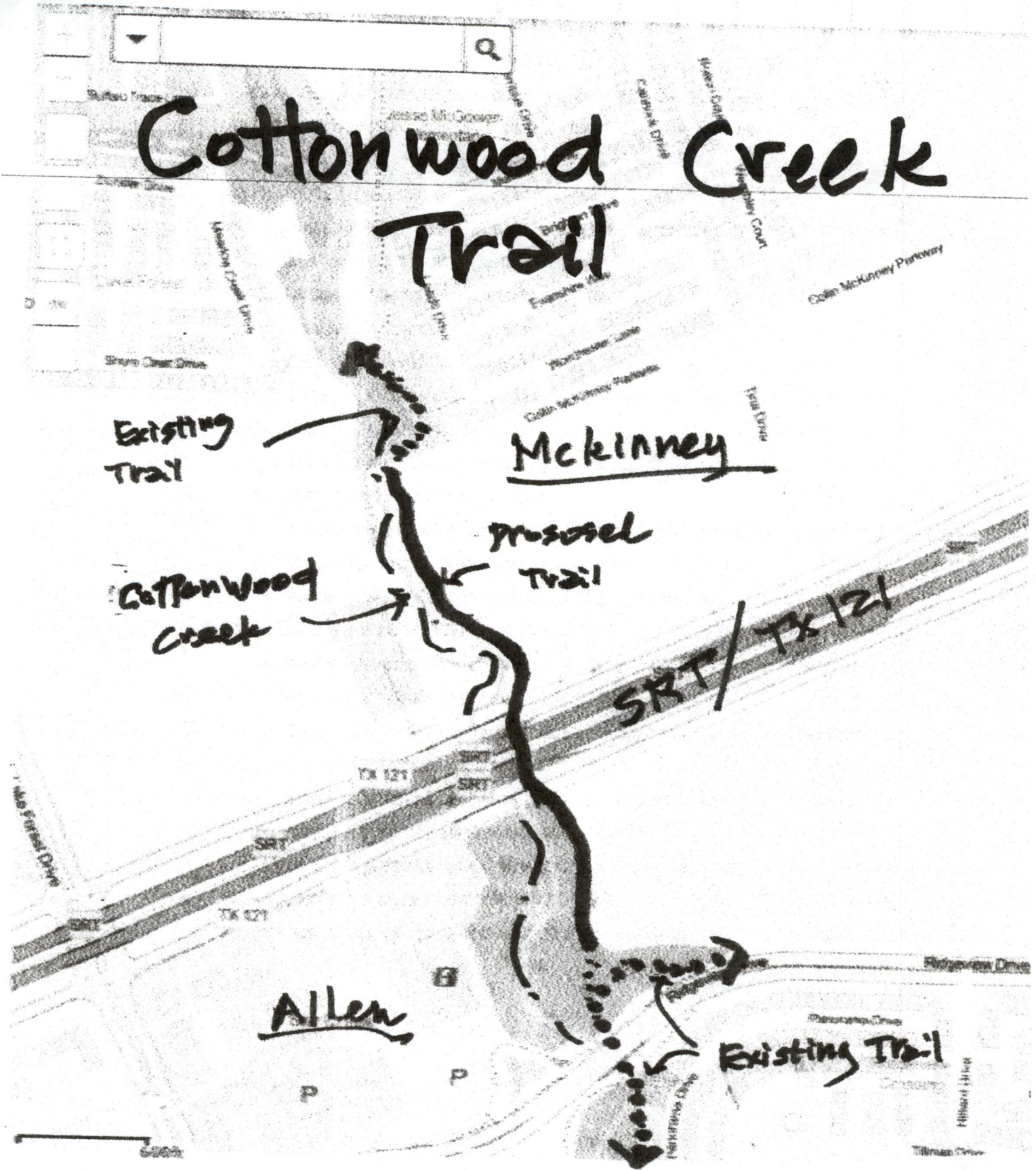
I'd like to continue my presentation on Future Trail Developments since most of the Board weren't at our Oct. Meeting. My new and revised presentation will contain some of the first session, but also presents new plans for several new trails.

Keeping with my proposal to develop a network of trails that link neighboring Cities together, I'm suggesting that the Board partner with Plano, McKinney, Prosper, Celina, and Farmersville on the following:

Cottonwood Creek Trail linking McKinney and Allen- Develop a short trail (approximately 3,000 feet) along Cottonwood Creek that links McKinney's trail network with Allen's trail network. I'd like to explore a partnership for funding with the County paying 50% and each City paying 25% each. The project would address design, any land acquisition necessary, and all trail construction.

Wilson Creek Trail Planning Study - Complete a Planning Study for future development of the Wilson Creek corridor that would someday link McKinney's Wilson Creek Trail to the Cities of Prosper and Celina. This Planning Study would identify the trail alignment, identify required land acquisition, and other improvements, possible phasing for a completed and continuous trail network for Wilson Creek. Future possible trail corridor links to Frisco and Weston could be documented. Suggested project funding could be 40% by Collin County and 20% by McKinney, Prosper, and Celina.

Farmersville Trail Planning Study - Complete a Planning Study for future Trail linking the existing Northeast Texas Trail to Farmersville South Lake Park, with a possible alignment along an existing High Power Line, a flood plain corridor (North Lake Park), an underpass on proposed U.S. 380 Bypass (currently planned), and existing South Lake Park property. The Planning Study would develop a trail alignment, identify potential land acquisition or easements required, and other items to complete the Study.
