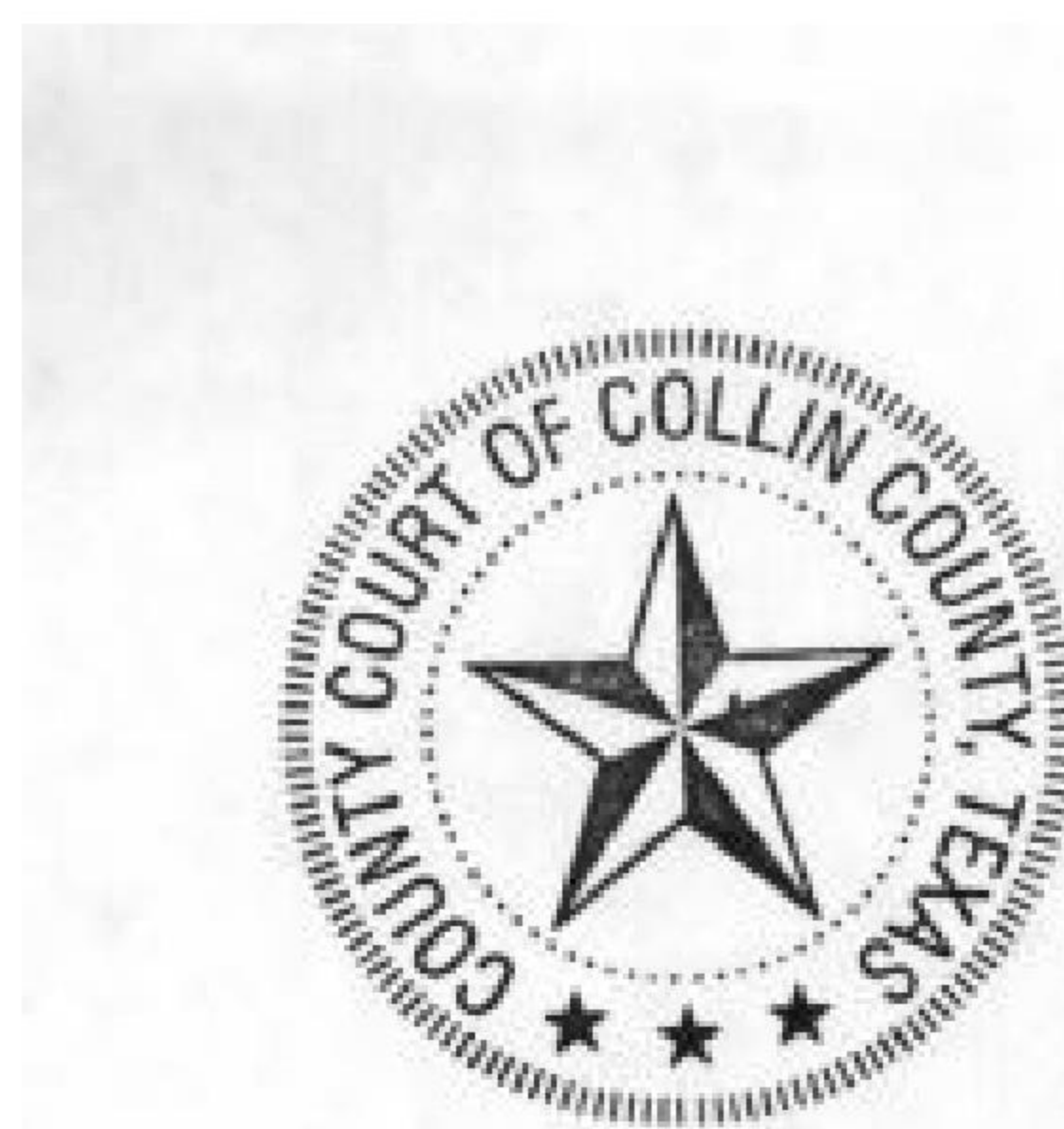

1. Call Meeting to Order

2. Approval of November 13, 2024 Minutes
