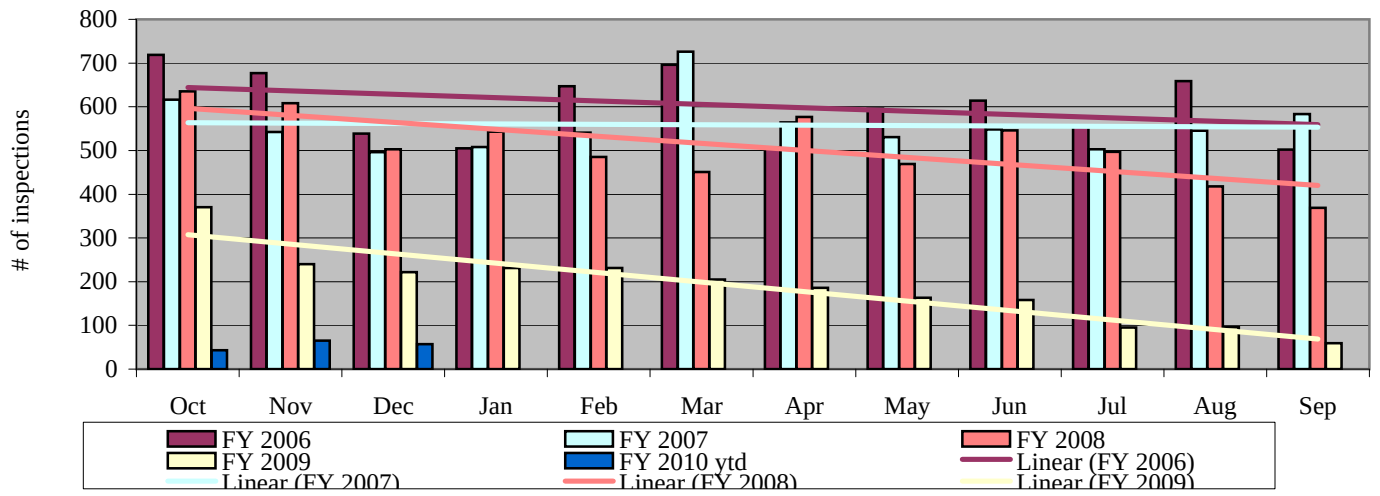


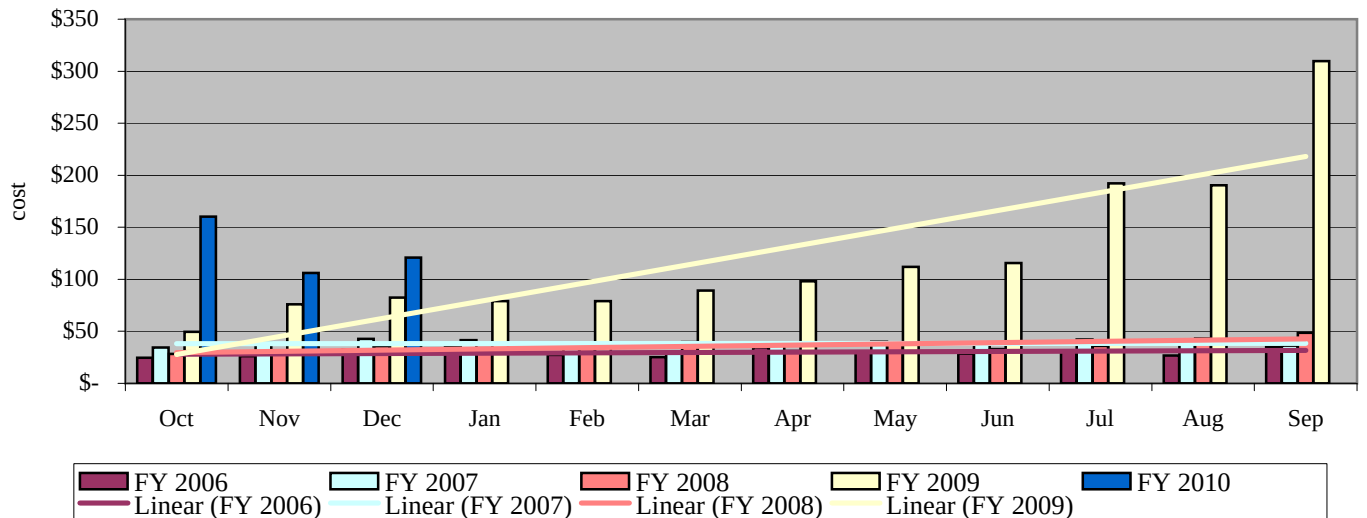

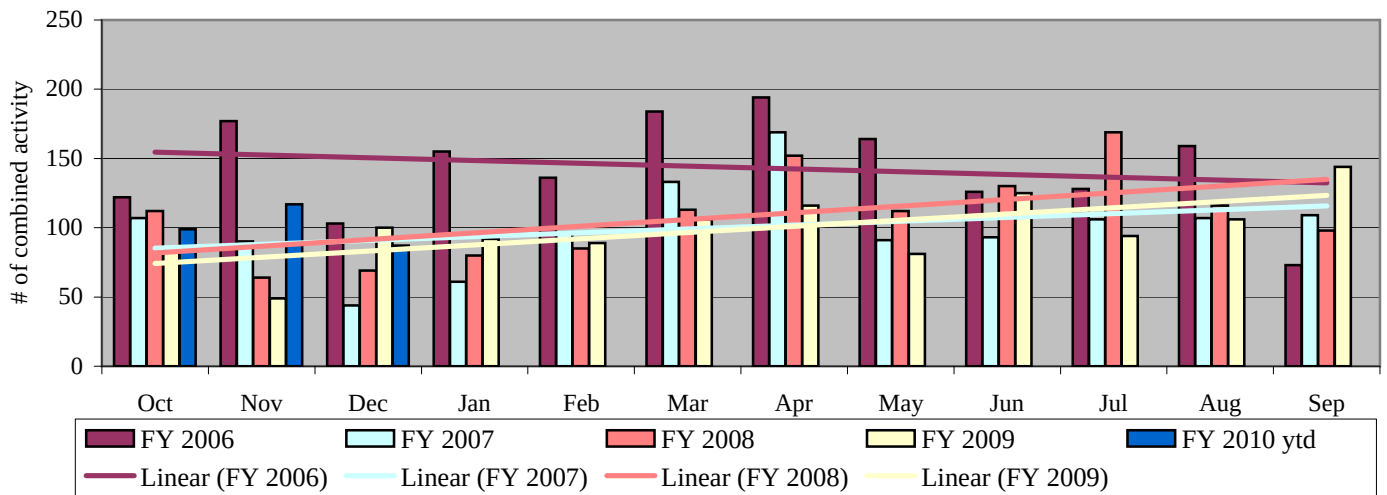

On-Site Sewage Facility (OSSF) Combined Activity

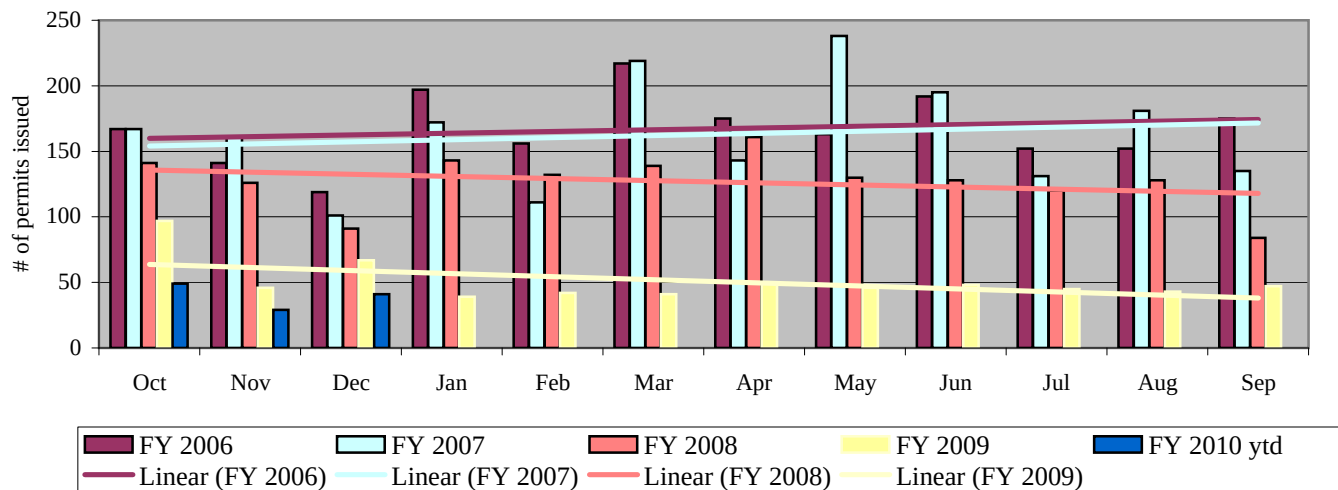

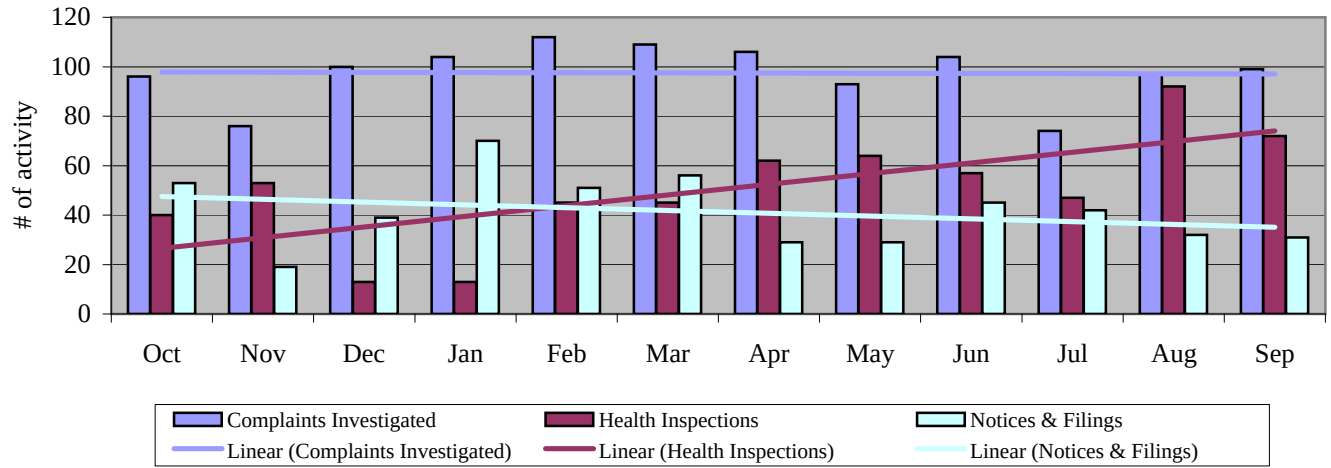

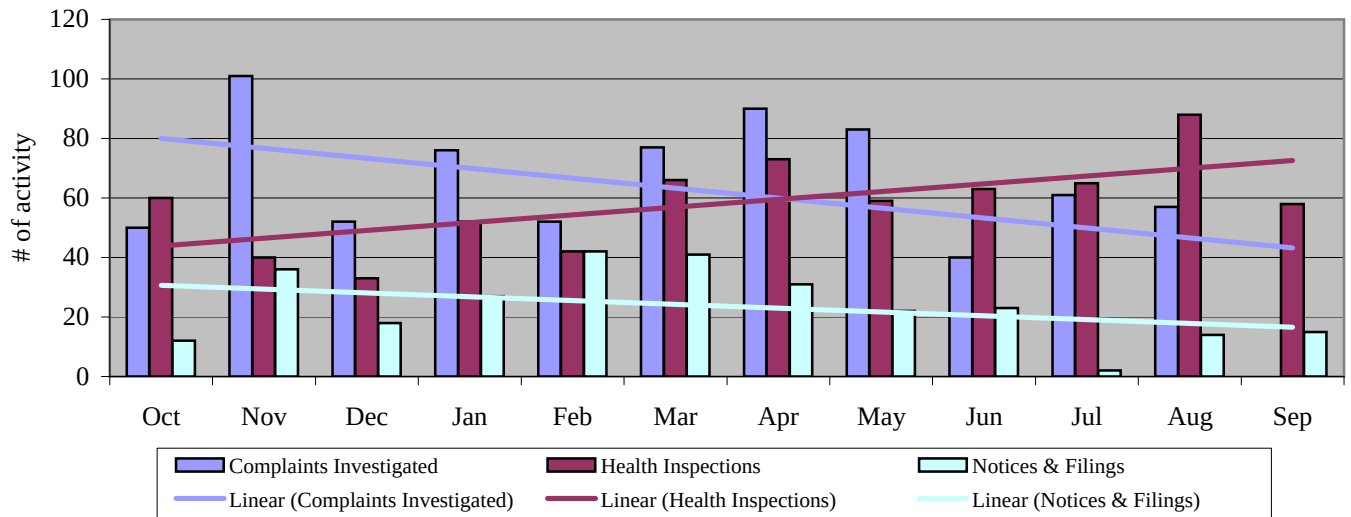

On-Site Sewage Facility (OSSF) by Activity FY 2005

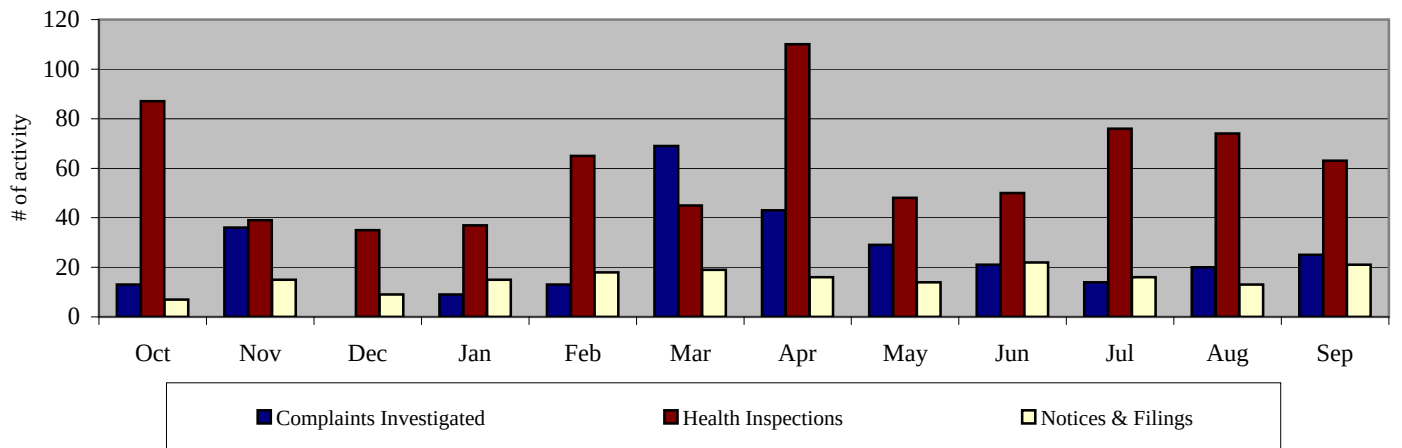


On-Site Sewage Facility (OSSF) by Activity FY 2006

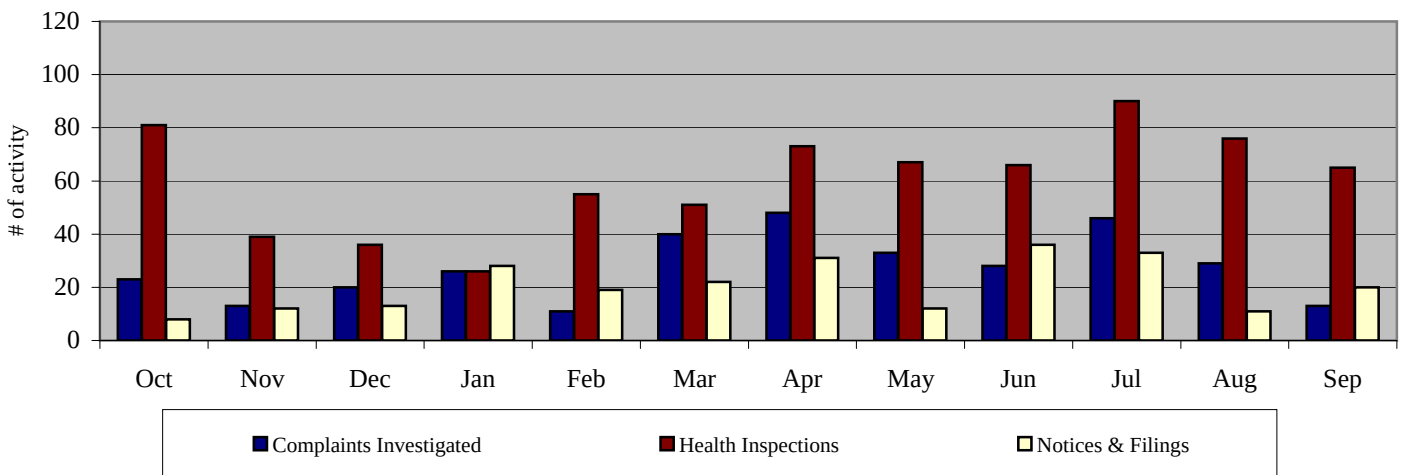

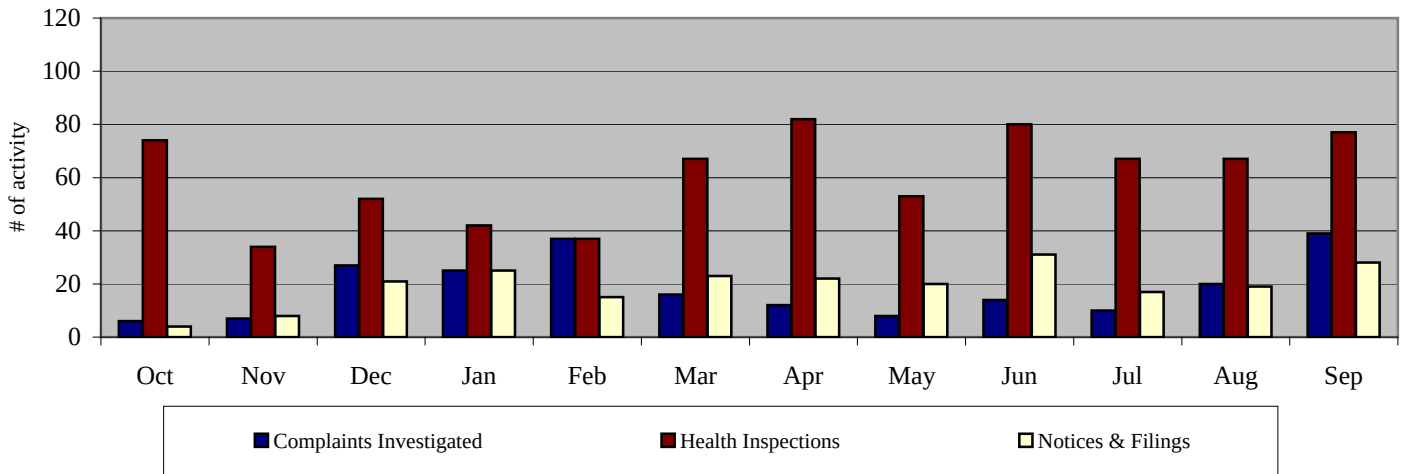


On-Site Sewage Facility (OSSF) by Activity FY 2008
