DESCRIPTION

Death Investigations

- Any cause or manner of death is investigated by the Medical Examiner's office. This chart illustrates the number of deaths that were investigated by the Medical Examiner.
- Ratio of death investigations per field agent is 1:504 in fiscal year 2007, a decrease from fiscal years 2004 to 2006

External Exams

- Autopsies are not performed on all deaths; in this case external only exams are completed. This chart illustrates the number of external only exams performed.

Death Certificates

- Death certificates are issued at the time of body release. The number of death certificate is directly tied to the number of deaths investigated.

Field Agents Overtime

ANALYSIS

Death Investigations (Totals)

- FY 2006 = 1,902 2% increase
- FY 2007 = 2,014 6% increase
- FY 2008 = 2,215 10% increase
- FY 2009 = 2,335 5% increase
- FY 2010 = 2,613 12% increase

Death Investigations per Field Agent (Totals)

- FY 2006 = 634
- FY 2007 = 504 20% decrease
- FY 2008 = 554 10% increase
- FY 2009 = 584 5% increase
- FY 2010 = 653 12% increase

External Exams Only (Totals)

- FY 2006 = 173 7% increase
- FY 2007 = 155 10% decrease
- FY 2008 = 174 12% increase
- FY 2009 = 179 3% increase
- FY 2010 = 181 1% increase

Death Certificates (Totals)

- FY 2006 = 383 13% decrease
- FY 2007 = 415 8% increase
- FY 2008 = 486 17% increase
- FY 2009 = 536 10% increase
- FY 2010 = 556 4% increase

Field Agents Overtime (Totals)

- FY 2006 = 711 1% increase
- FY 2007 = 276 61% decrease
- FY 2008 = 112 60% decrease
- FY 2009 = 112 no change
- FY 2010 = 211 89% increase
