ANIMAL SHELTER/CONTROL STATISTICS

DESCRIPTION

FY 2011 All Animals Processed

- Displays the total monthly count of all animals processed by Collin County Animal Control; utilizing their database. It details the count of all intakes versus transfers out.
- Animal intake categories = Owner Relinquish, Stray Relinquish, Code Impound and Stray Impound.
- Animal transferred out categories = Redemption, Adoption, Ownership Change and Euthanization.

Owner Relinquish

- Shows the monthly count of animals brought in by owners that could no longer care for the animals.

Stray Relinquish

- Shows the monthly count of animals brought in by non-owners who could not care for the animals.

Code Impound

- Shows the monthly count of animals on a 10-day hold for rabies evaluation (possibly bit someone).

Stray Impound

- Shows the monthly count of animals brought in by Animal Control Officers.

Redemption

- Shows the monthly count of animals picked up by owners.

Ownership Change

- Shows the monthly count of animals transferred to SPCA or Rescue Agencies.

Euthanized

- Shows the monthly count of animals euthanized, including those caught in traps like skunks/squirrels.

Average Daily Holding for Dogs Only

- Shows the average daily count of dogs (only) held for the month.
- Includes an average daily cost per dog held.
- *Note: Does not include dogs held in Rabies Quarantine or DOA.*

ANALYSIS

All Animals Processed (Totals)

- FY 2007 = 13,325
- FY 2008 = 13,488 1% increase
- FY 2009 = 13,622 1% increase
- FY 2010 = 12,920 5% decrease
- FY 2011 YTD = 5,740

Owner Relinquish (Totals)

- FY 2007 = 883
- FY 2008 = 975 10% increase
- FY 2009 = 1,077 10% increase
- FY 2010 = 947 12% decrease
- FY 2011 YTD = 434

Stray Relinquish (Totals)

- FY 2007 = 40
- FY 2008 = 49 22% increase
- FY 2009 = 66 3% increase
- FY 2010 = 15 77% decrease
- FY 2011 YTD = 11

Code Impound (Totals)

- FY 2007 = 160
- FY 2008 = 201 25% increase
- FY 2009 = 281 39% increase
- FY 2010 = 167 40% decrease
- FY 2011 YTD = 61

Stray Impound (Totals)

- FY 2007 = 5,548
- FY 2008 = 5,411 2% decrease
- FY 2009 = 5,157 4% decrease
- FY 2010 = 5,135 no change
- FY 2011 YTD = 2,205

Redemption (Totals)

- FY 2007 = 1,245
- FY 2008 = 1,379 10% increase
- FY 2009 = 1,459 5% increase
- FY 2010 = 1,319 10% decrease
- FY 2011 YTD = 653

Ownership Change (Totals)

- FY 2007 = 3,833
- FY 2008 = 3,878 1% increase
- FY 2009 = 3,776 2% decrease
- FY 2010 = 3,247 14% decrease
- FY 2011 YTD = 1,332

Euthanized (Totals)

- FY 2007 = 1,610
- FY 2008 = 1,580 1% decrease
- FY 2009 = 1,746 10% increase
- FY 2010 = 1,940 11% increase
- FY 2011 YTD = 744

Average Daily Count of Dogs Held (Totals)

- FY 2007 = 12
- FY 2008 = 12 no change
- FY 2009 = 12 no change
- FY 2010 = 11 8% decrease
- FY 2011 YTD = 10

Average Daily Cost per Dog Held (Totals)

- FY 2007 = \$59
- FY 2008 = \$73 23% increase
- FY 2009 = \$64 12% decrease
- FY 2010 = \$63 1% decrease
- FY 2011 YTD = \$66
