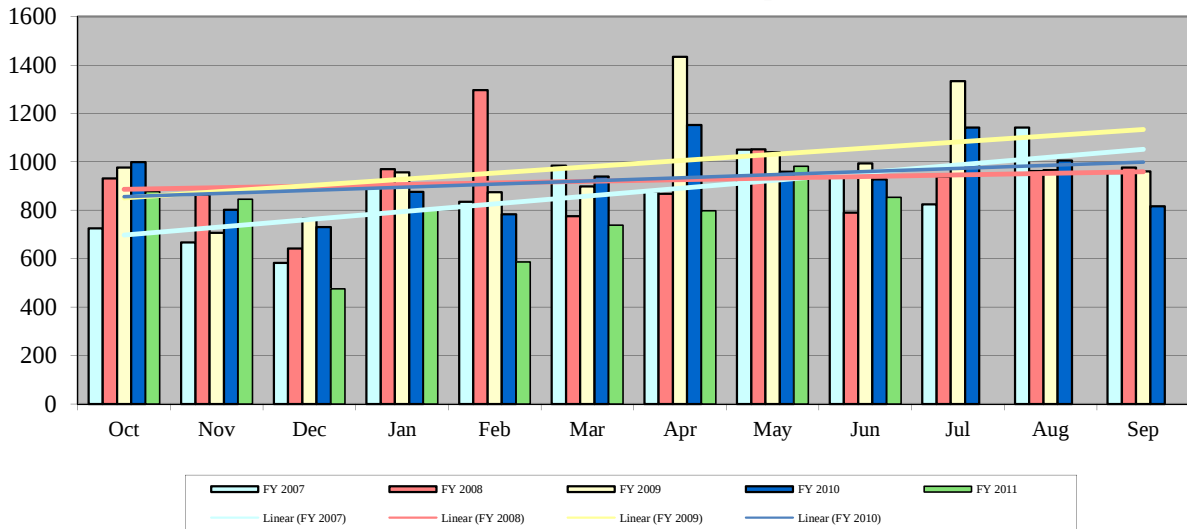

County Courts - Total Criminal Dispositions



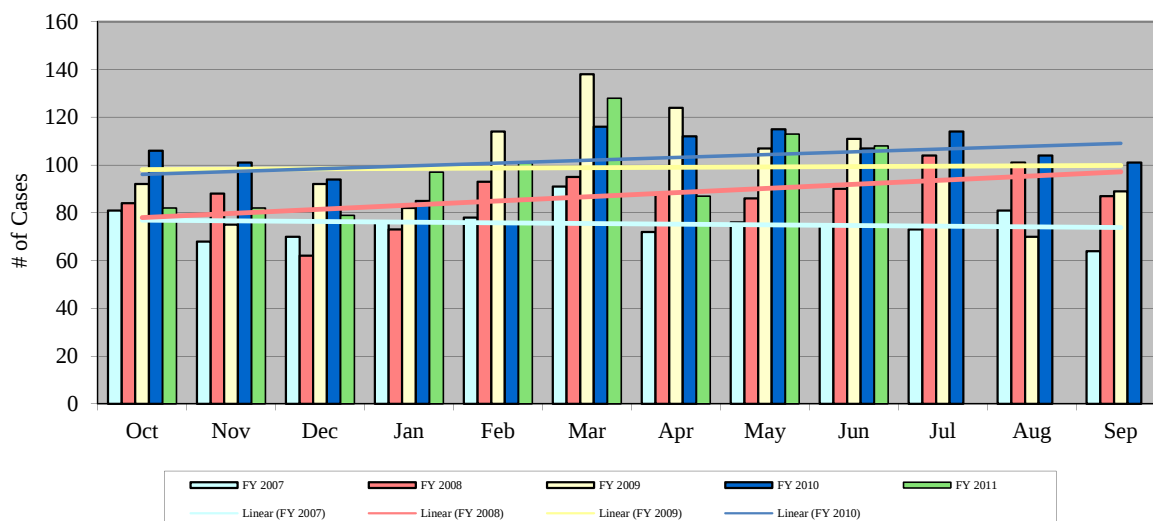
