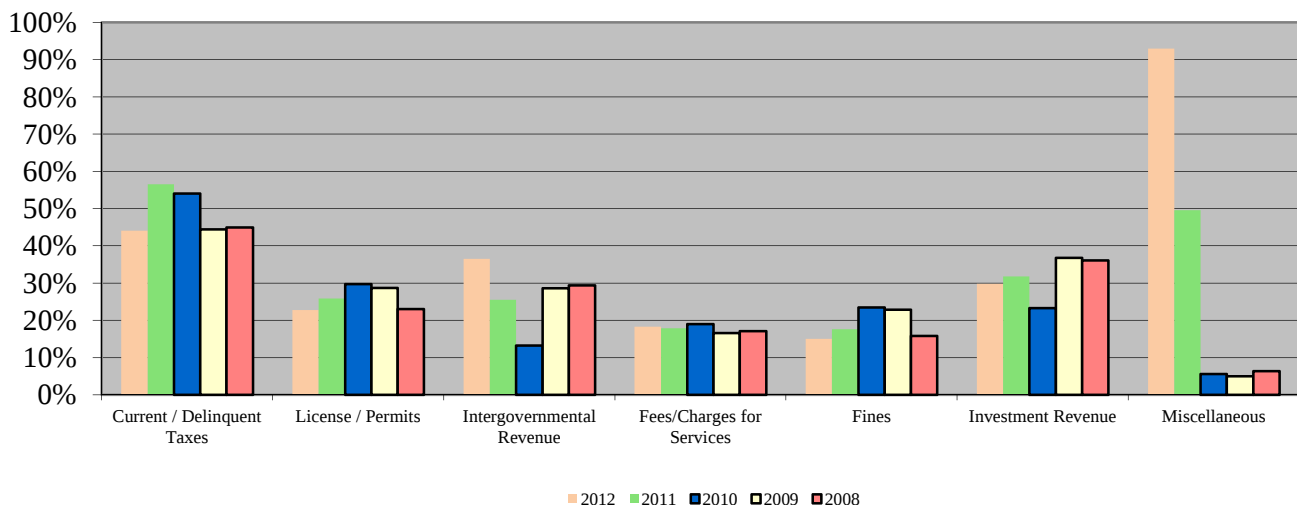

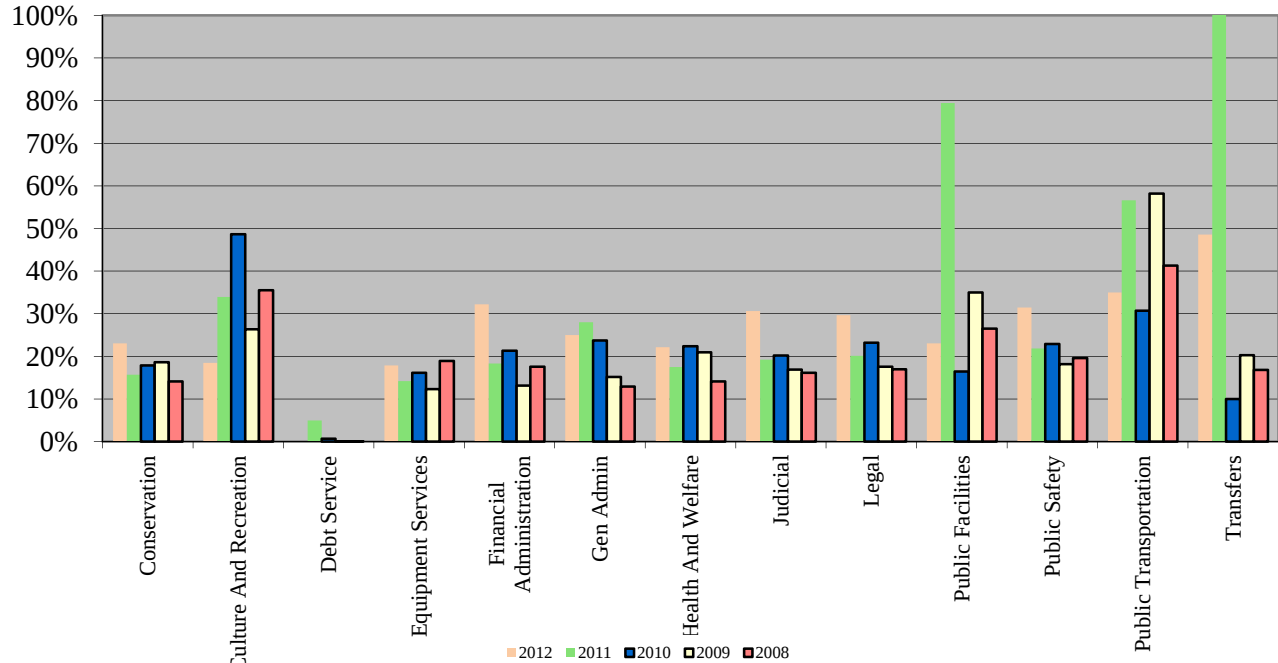
% of Combined Funds Revenue Collected 1st Quarter of Fiscal Year (Excluding Bond Funds)



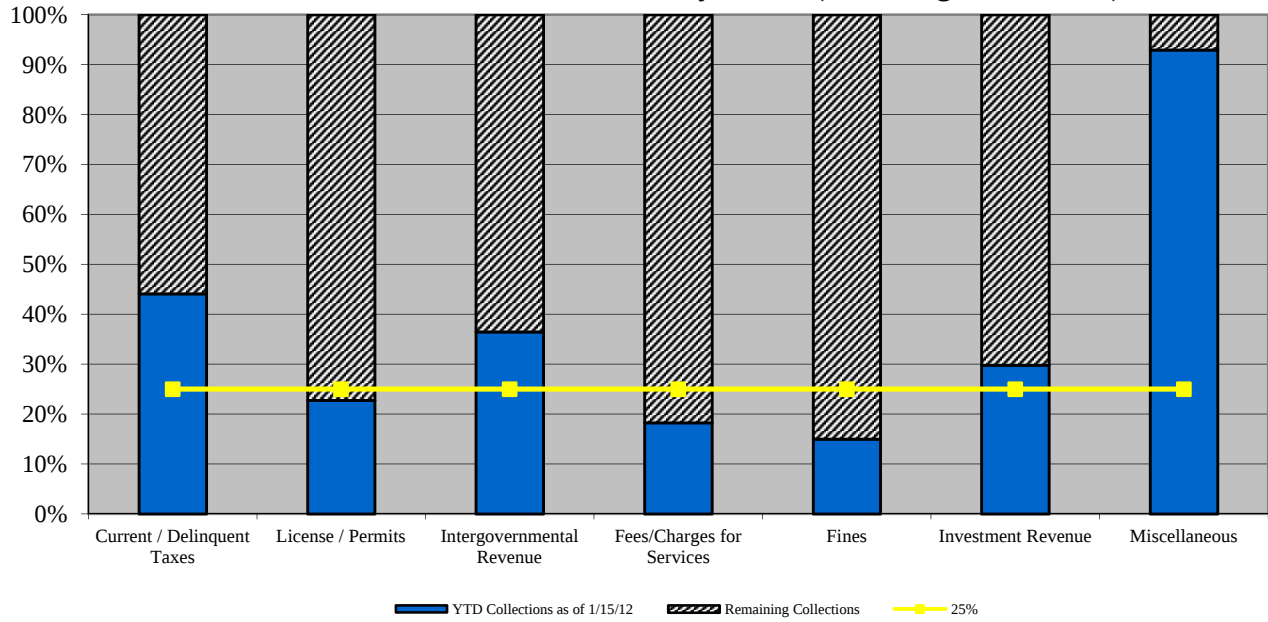
