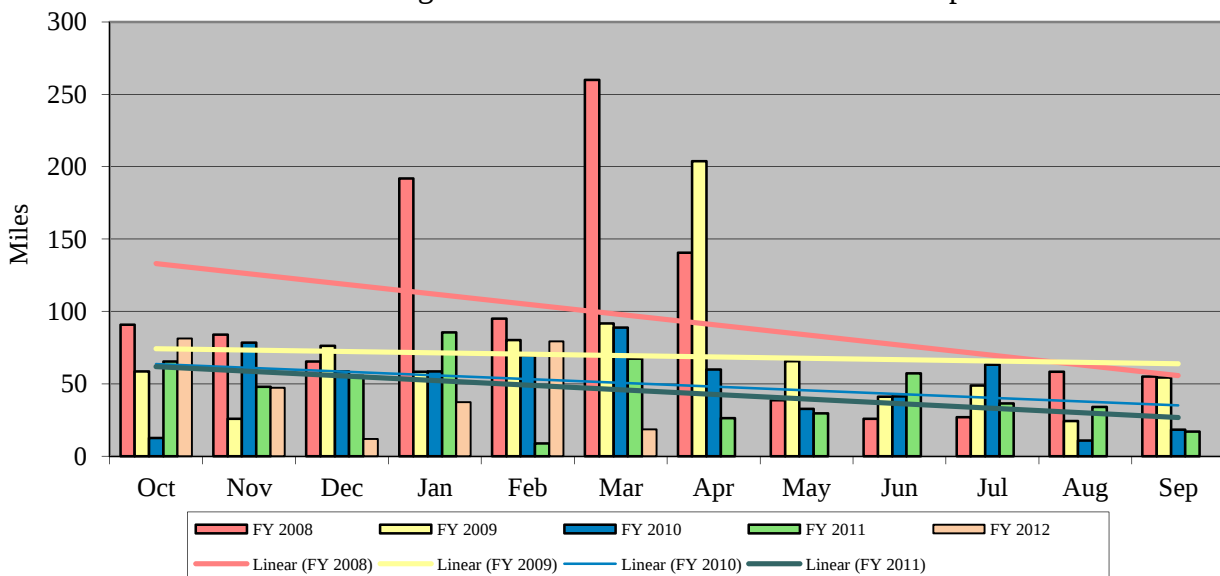

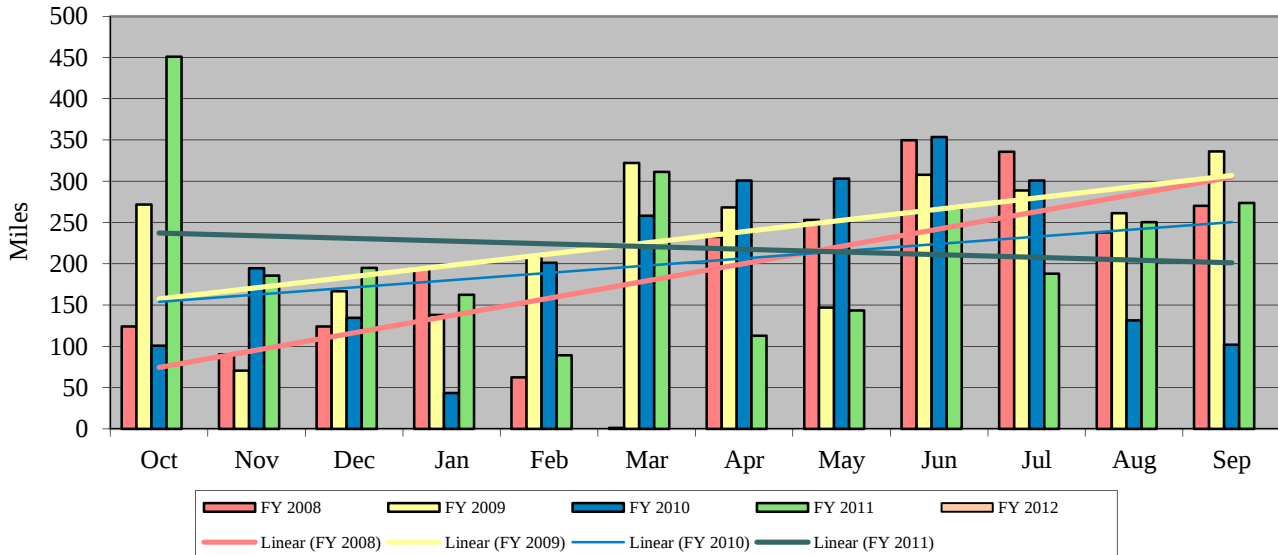

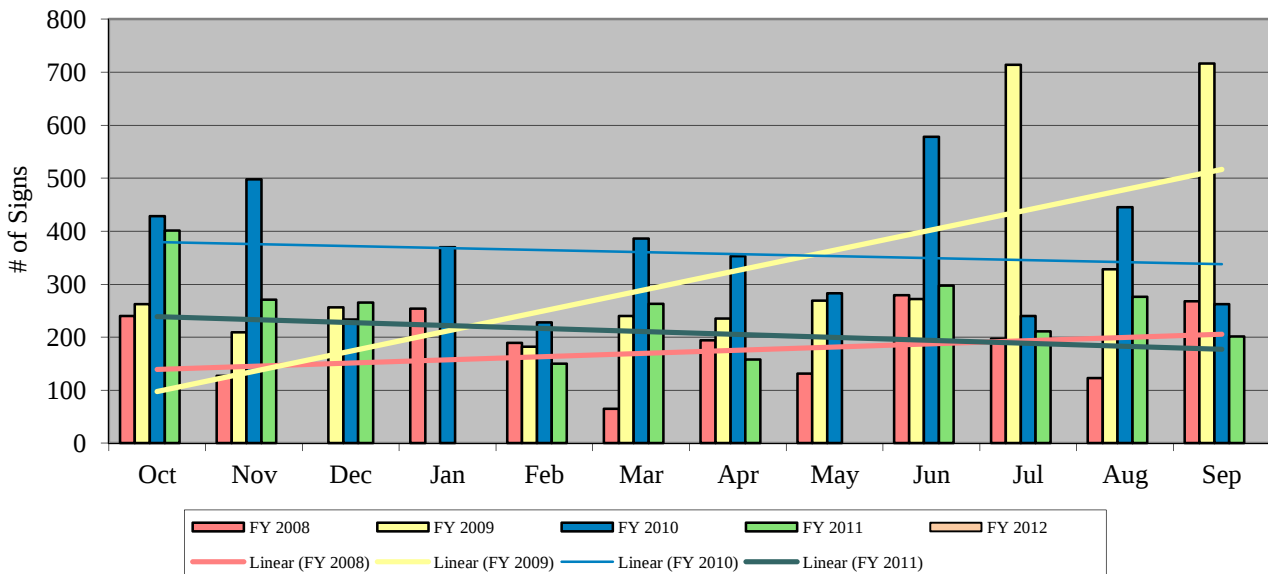

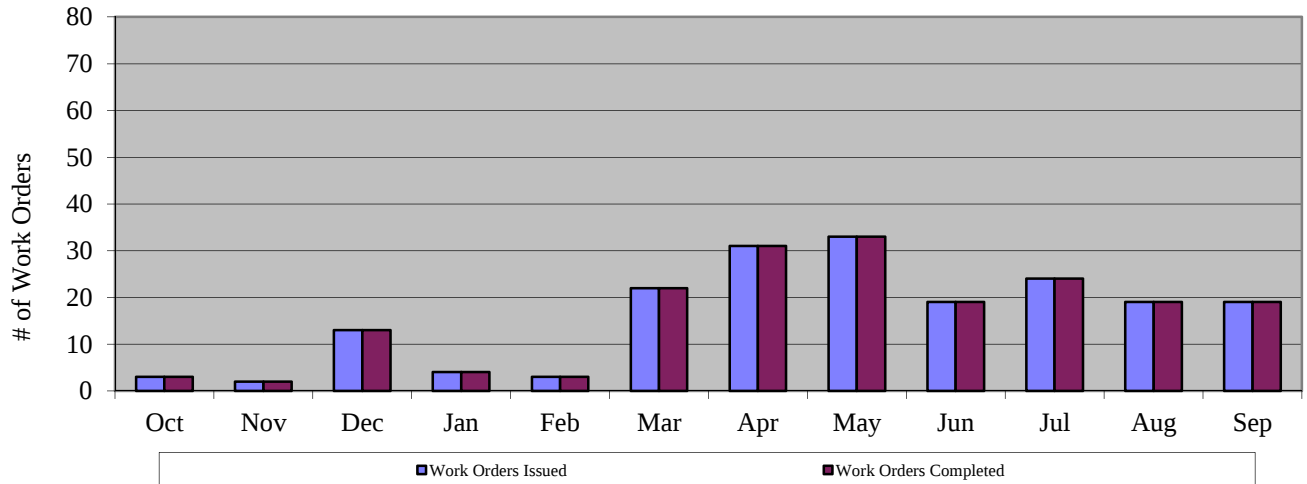
Road & Bridge - Culverts Repaired/Installed



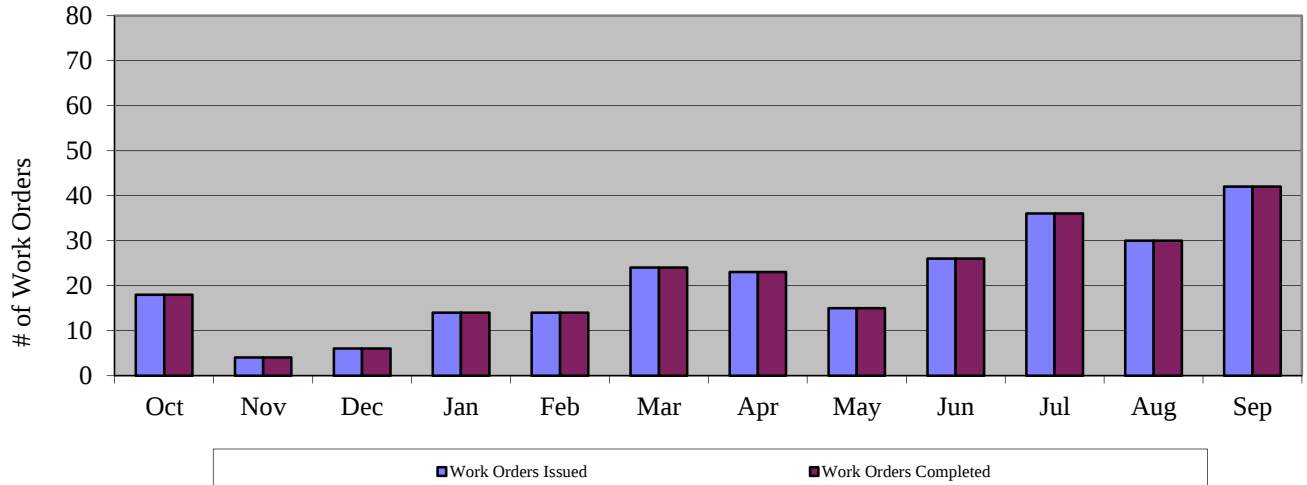

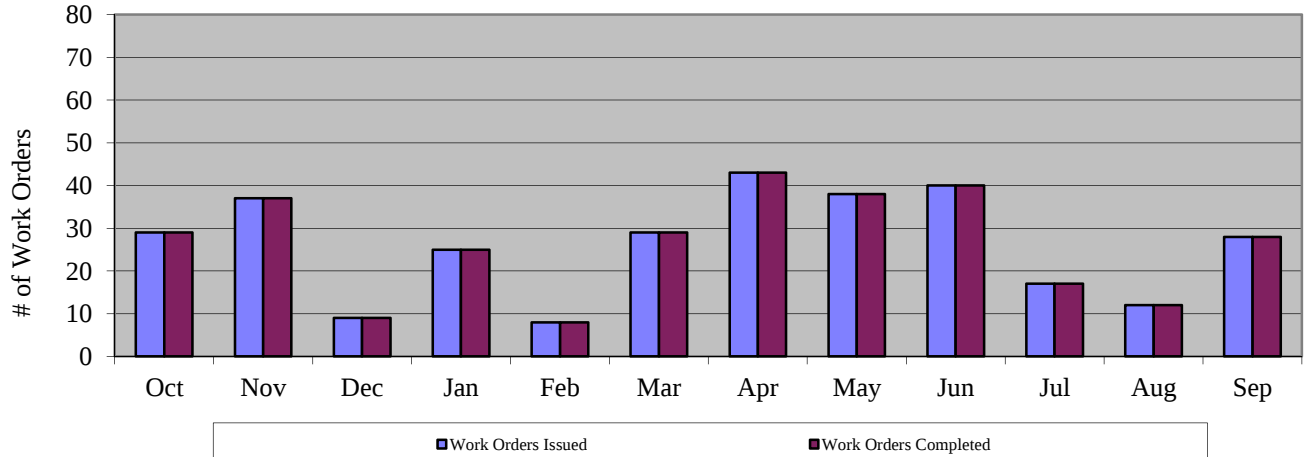
Road & Bridge - FY 2008 Work Orders



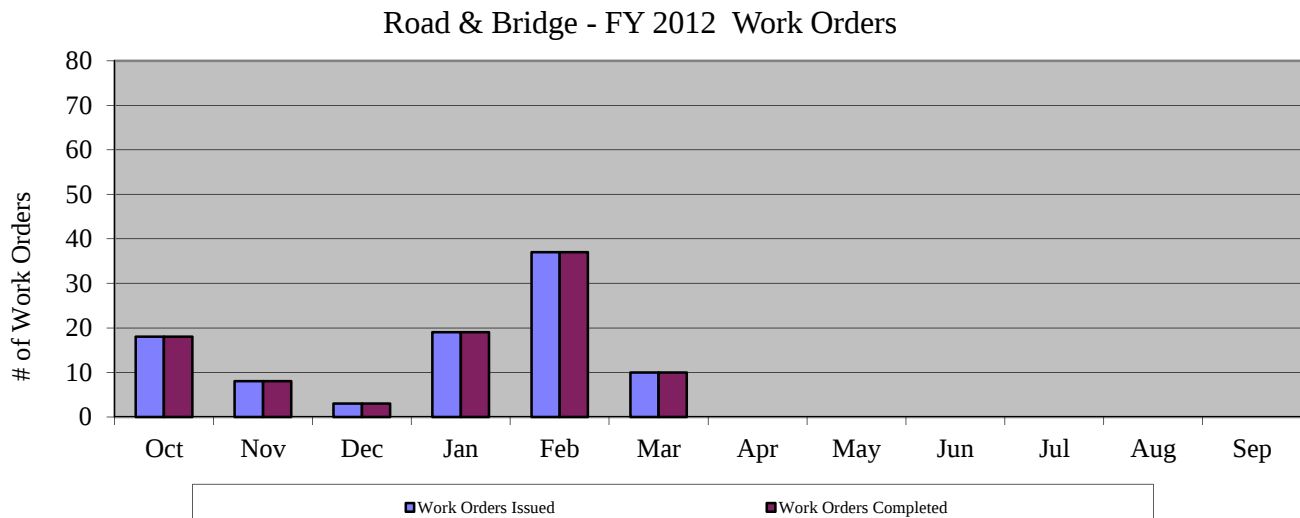
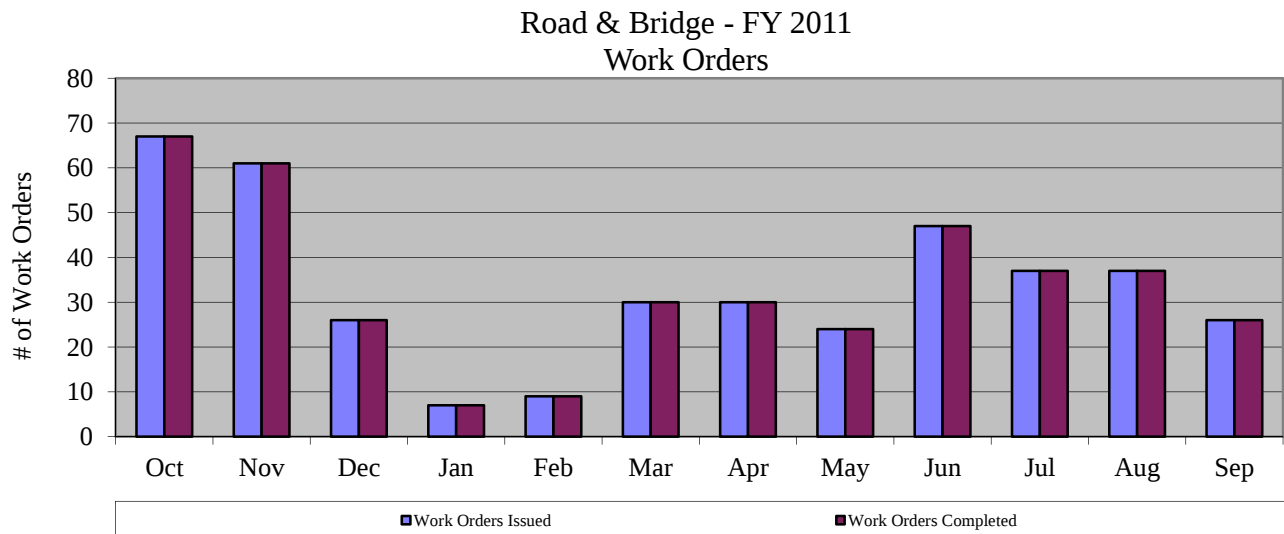

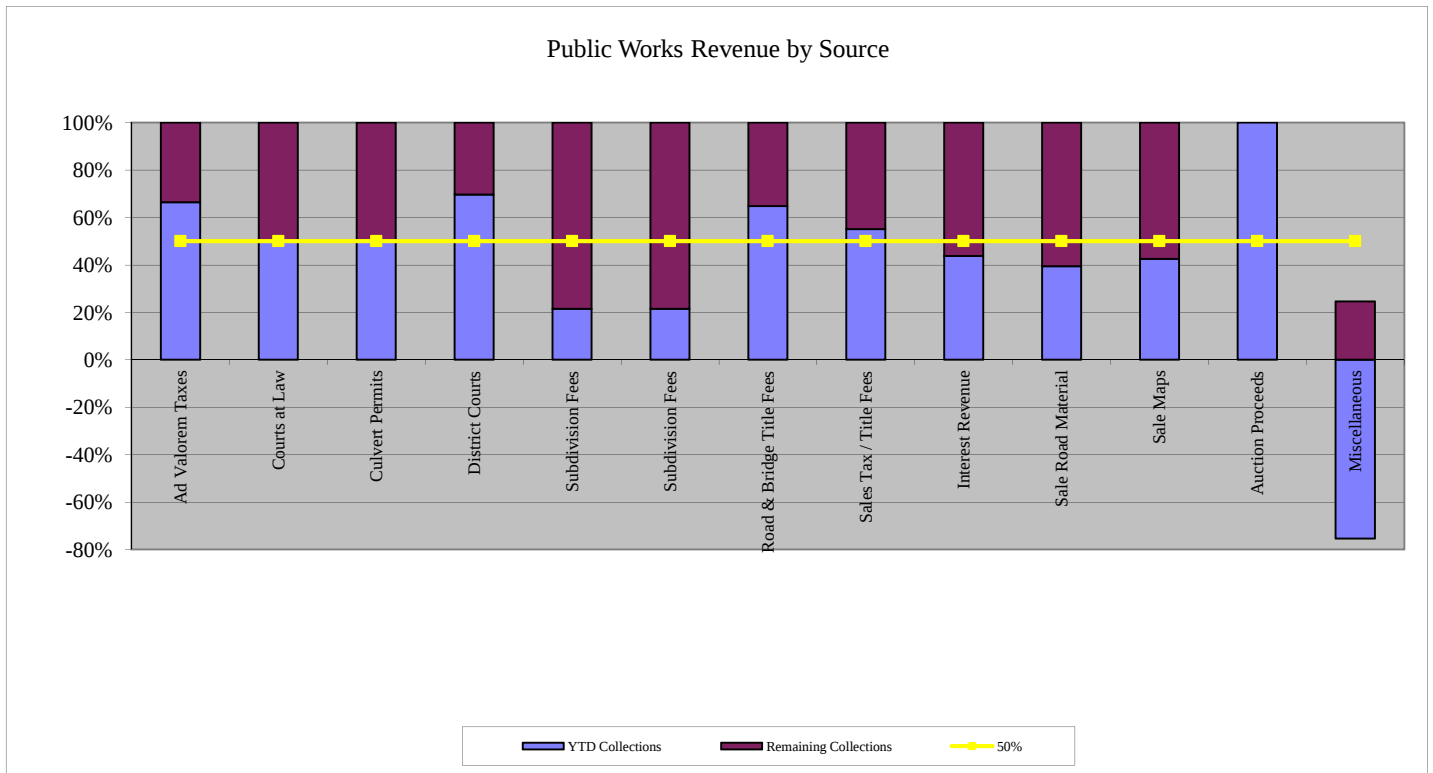
