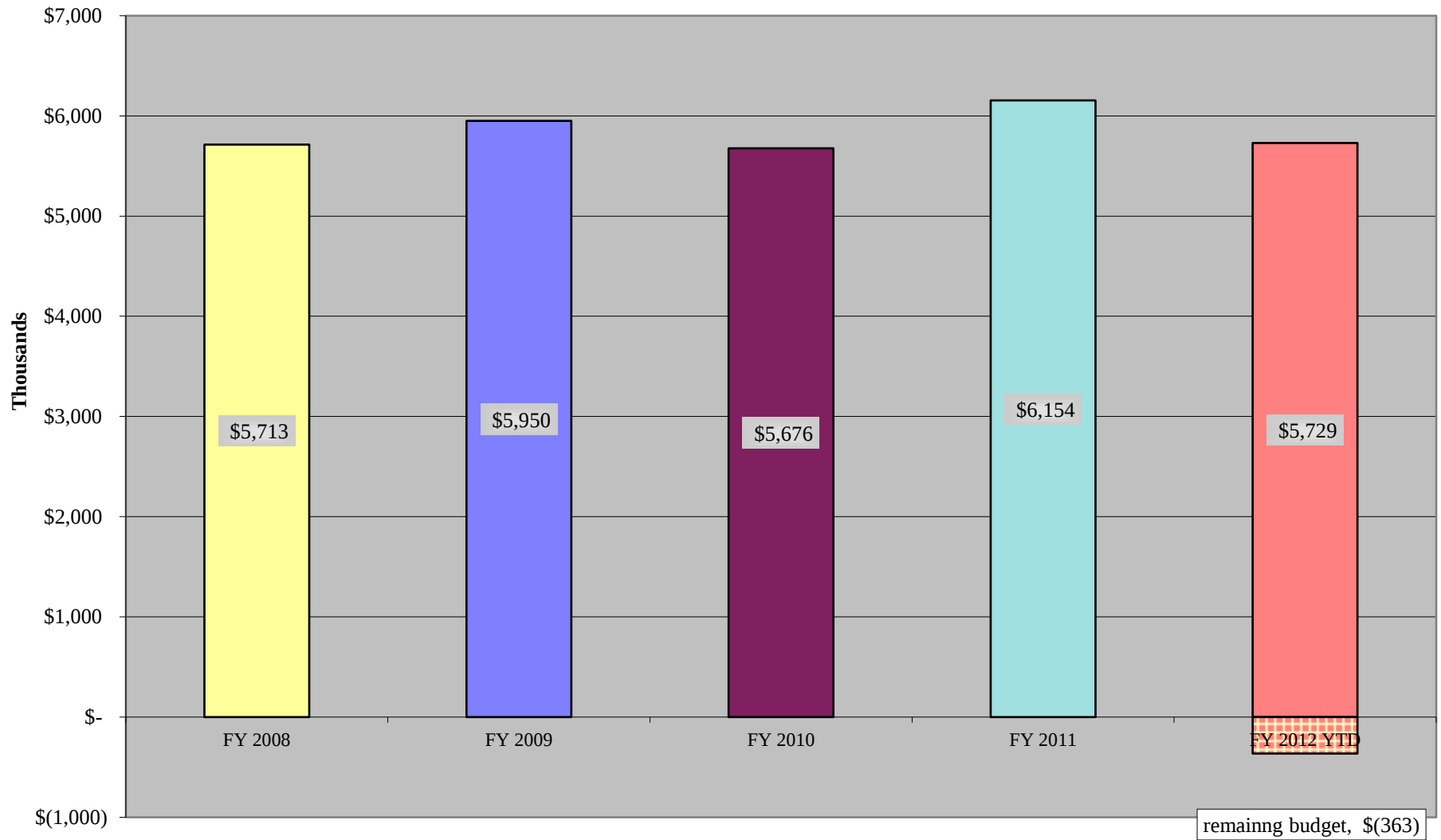


Indigent Defense Expenditures by Fiscal Year

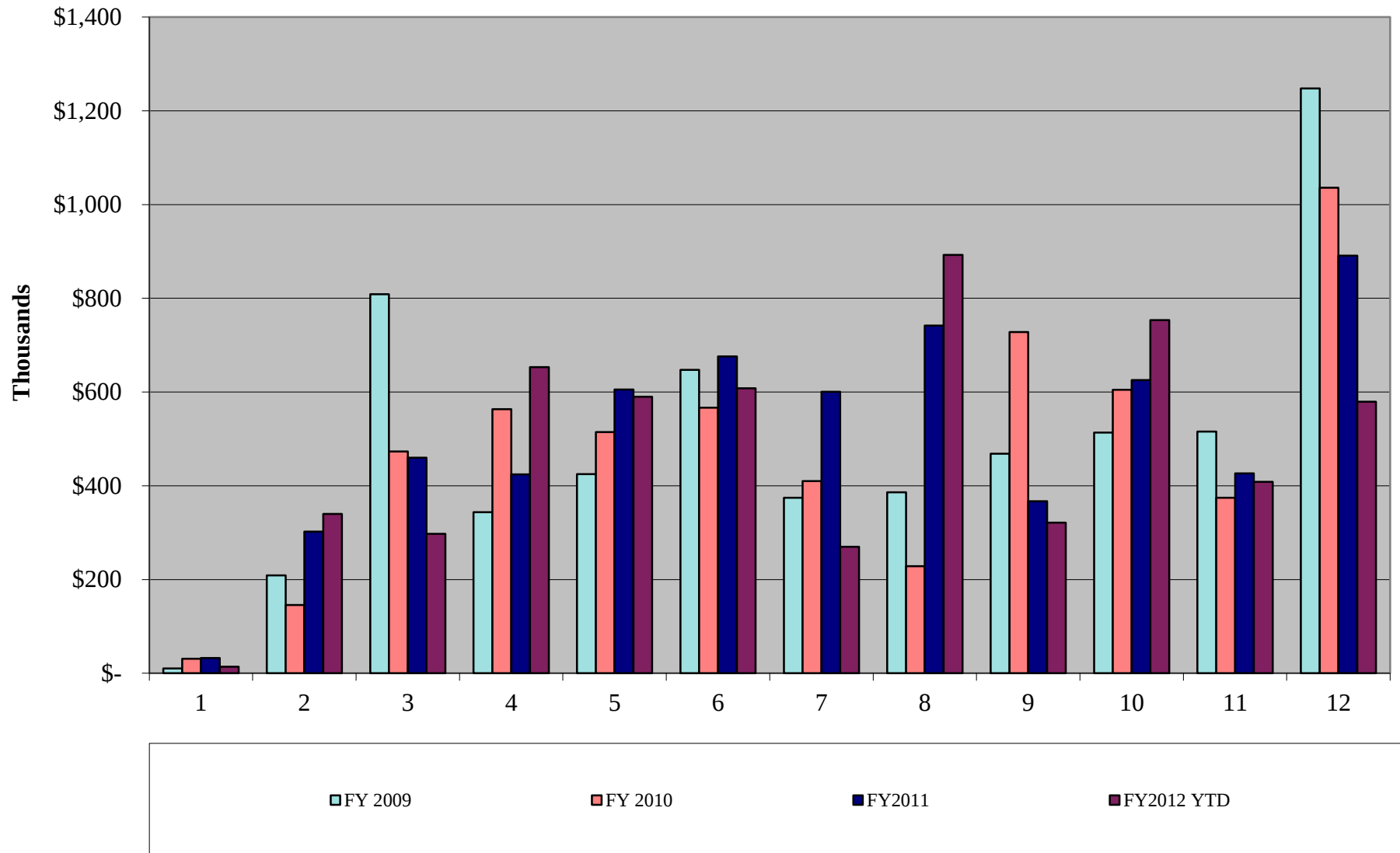

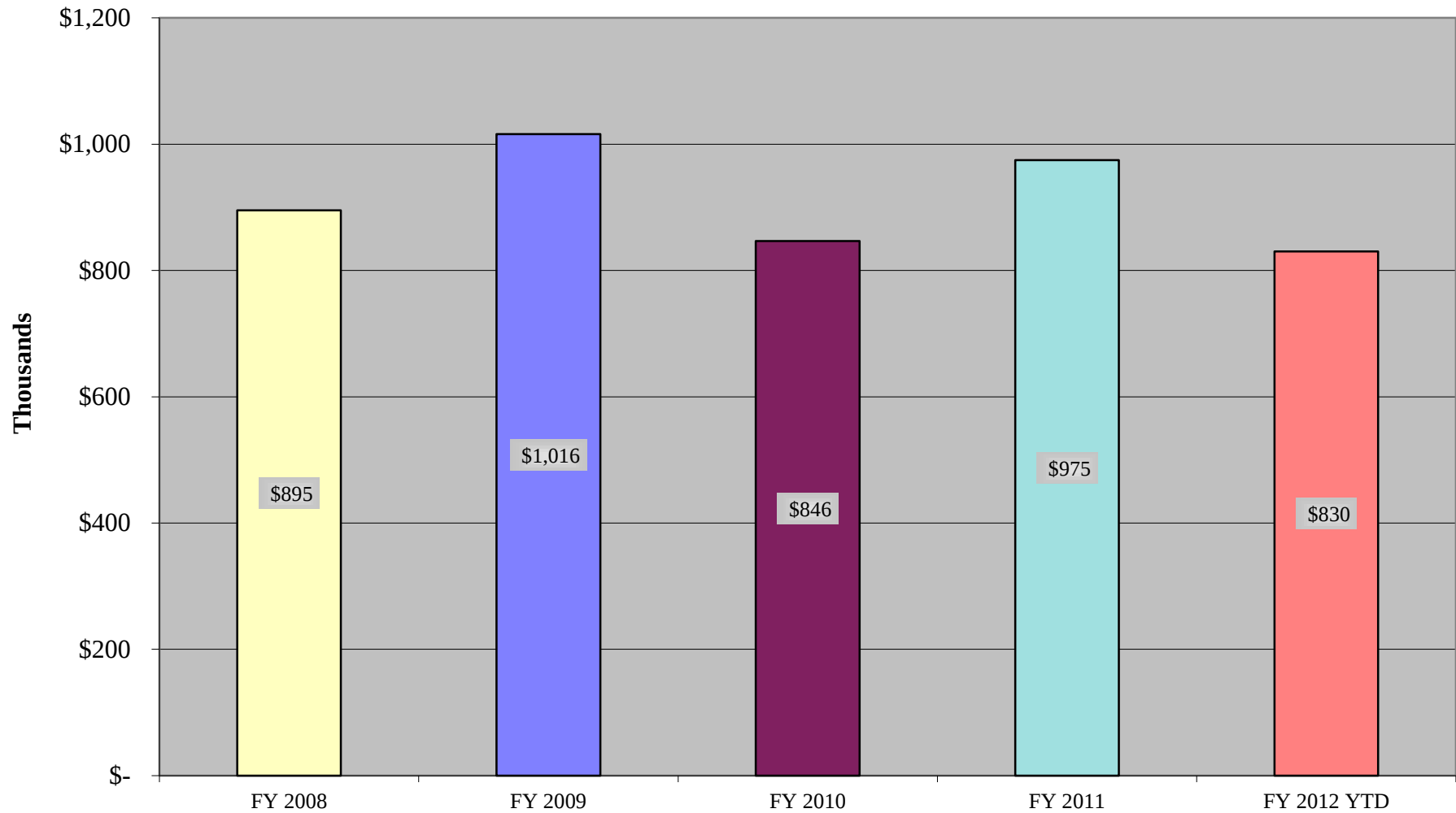
Indigent Defense Expenditures by Month (All Courts)

Ad Litem Expenditures by Fiscal Year

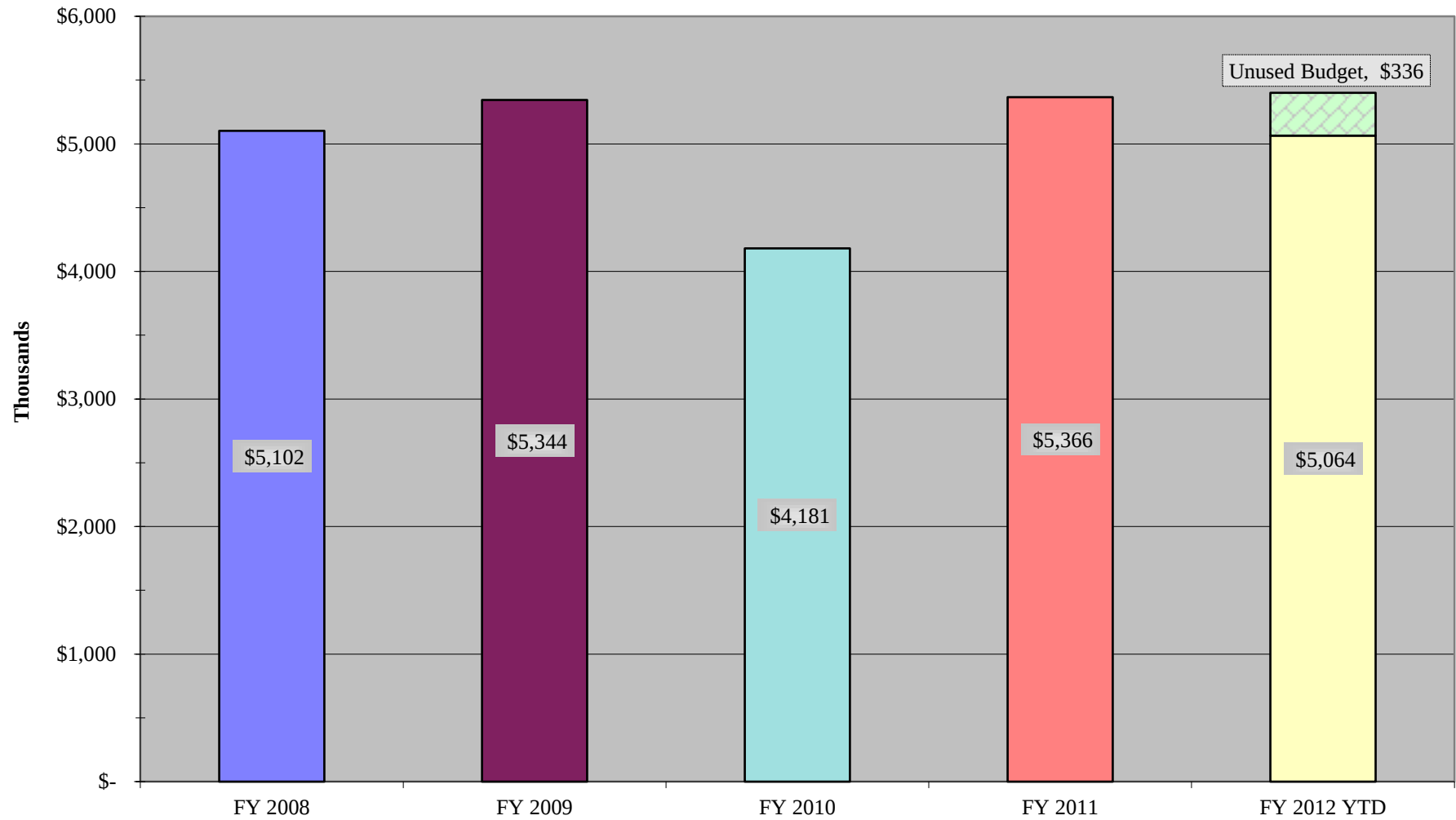
