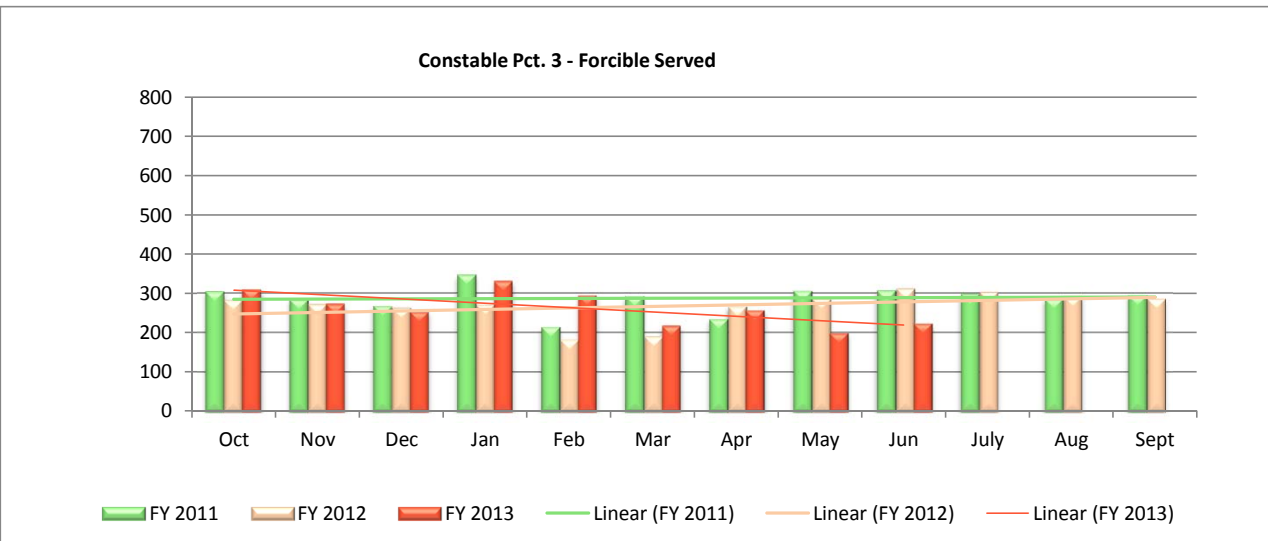
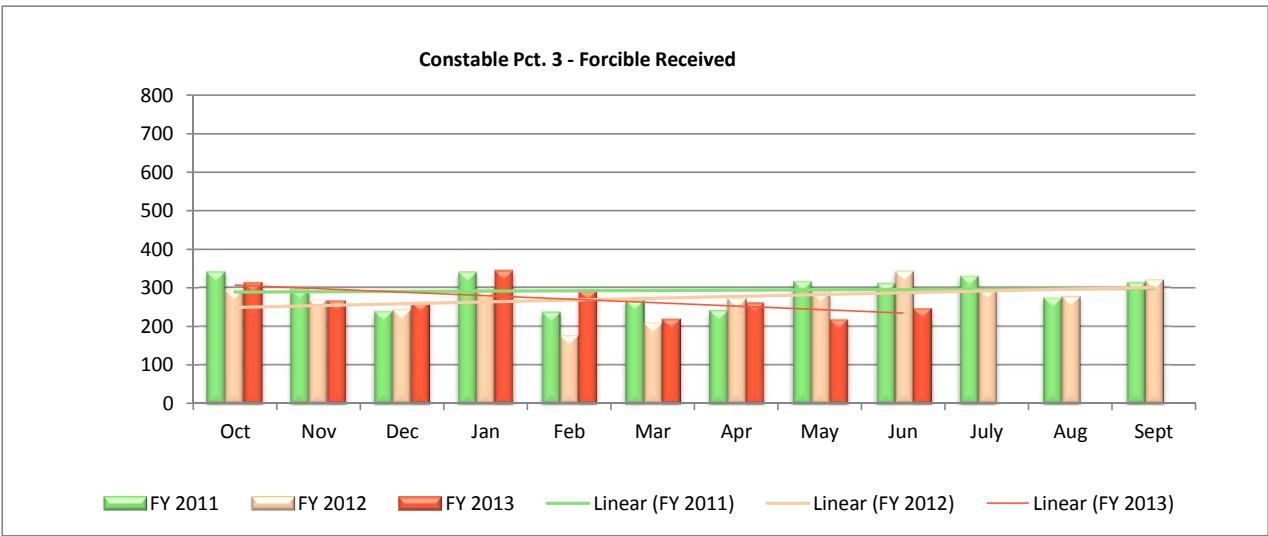
Constable Pct. 3 - Criminal Subpoenas Received



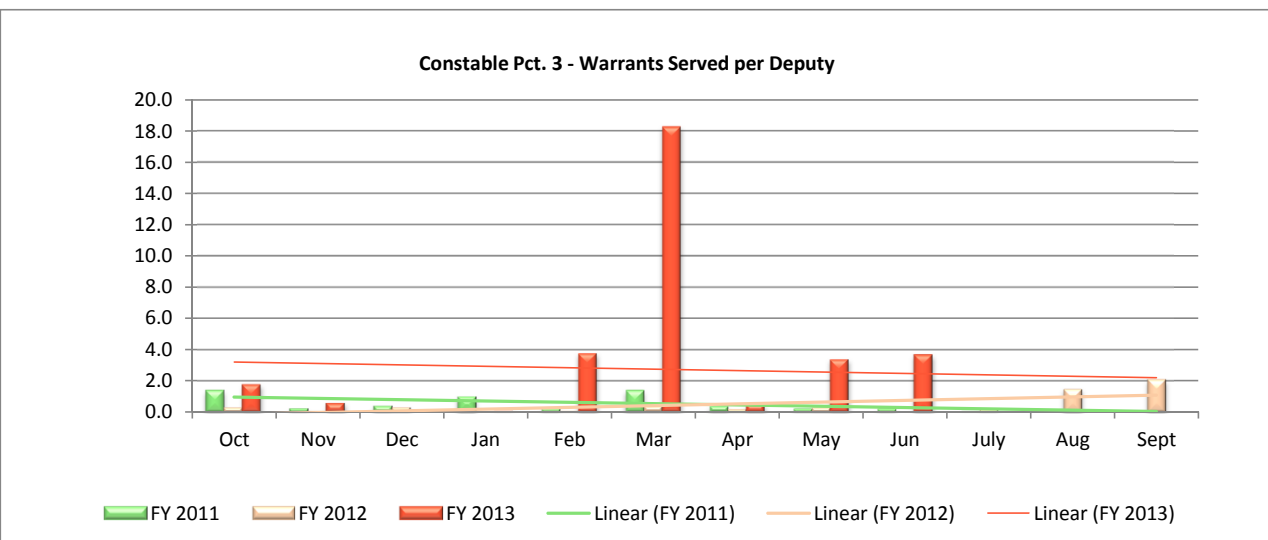
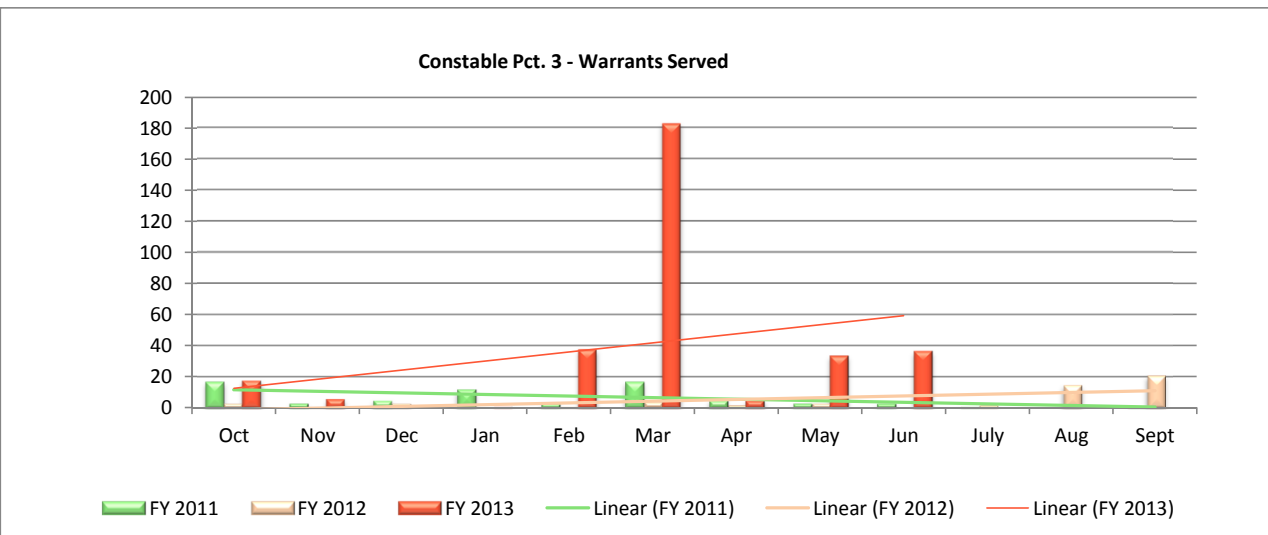
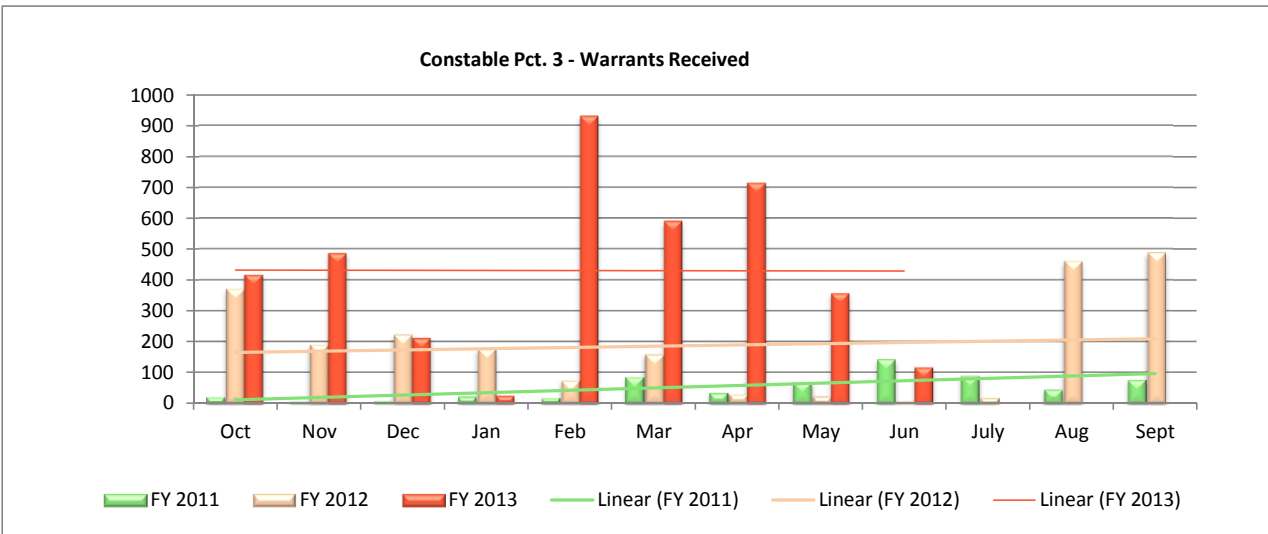
Constable Pct. 3 - Criminal Subpoenas Served

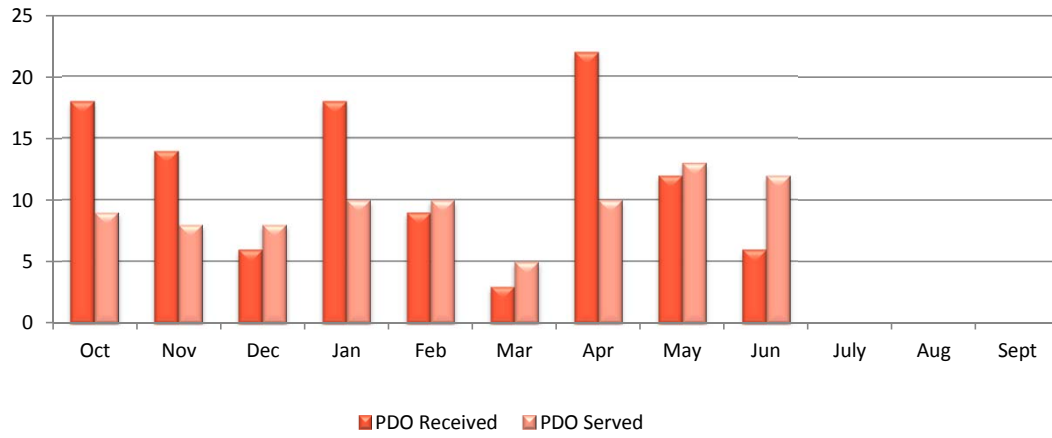
