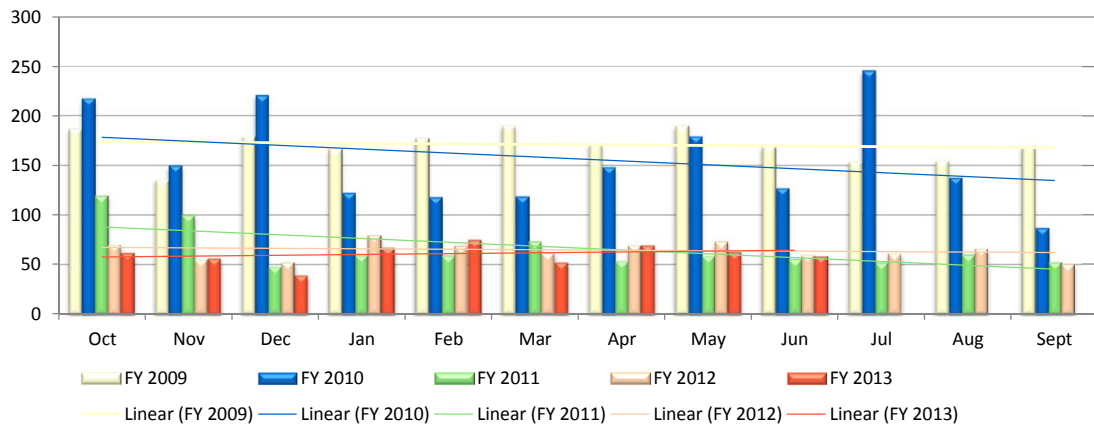

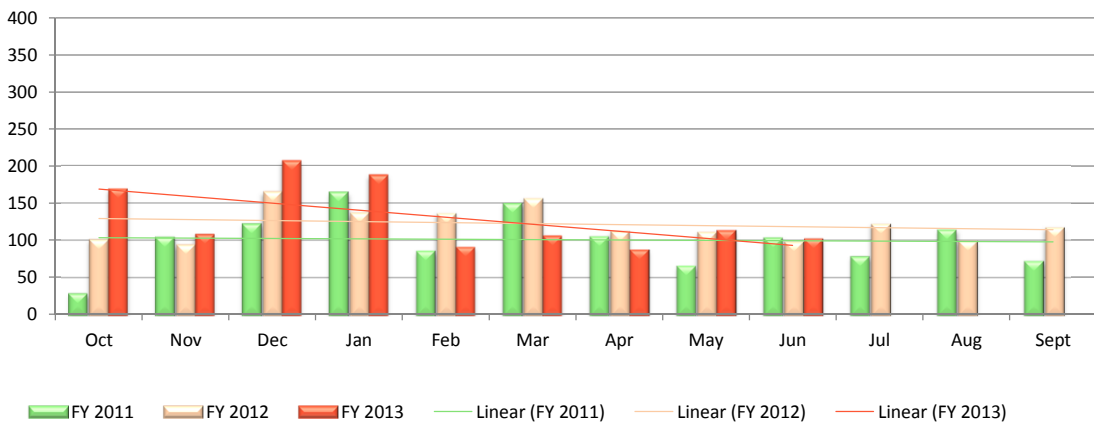

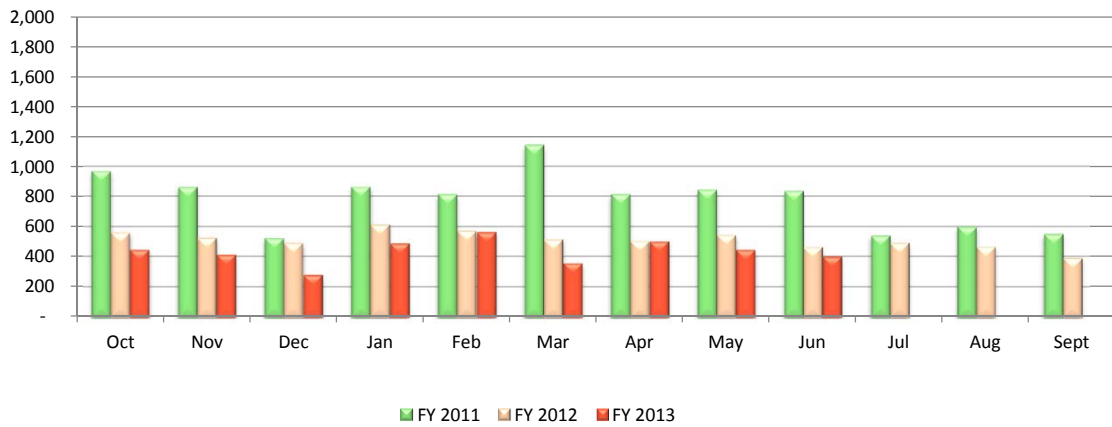

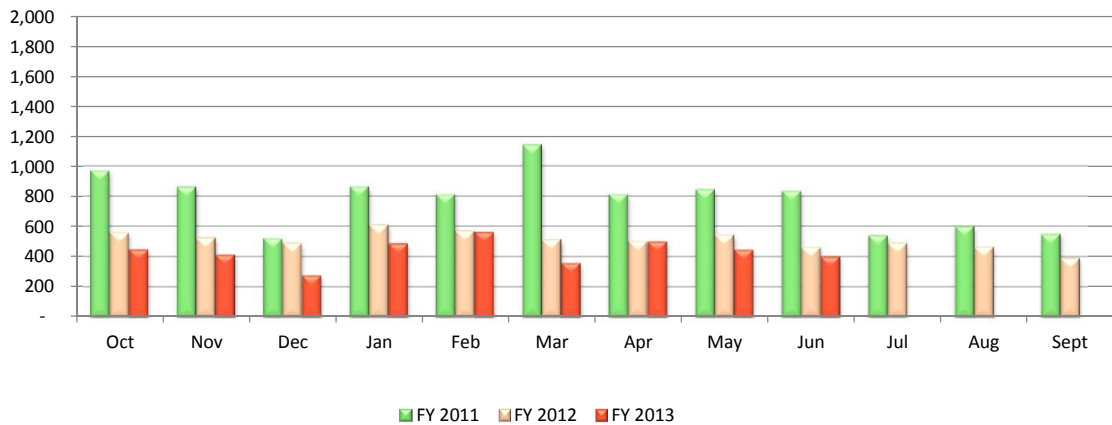

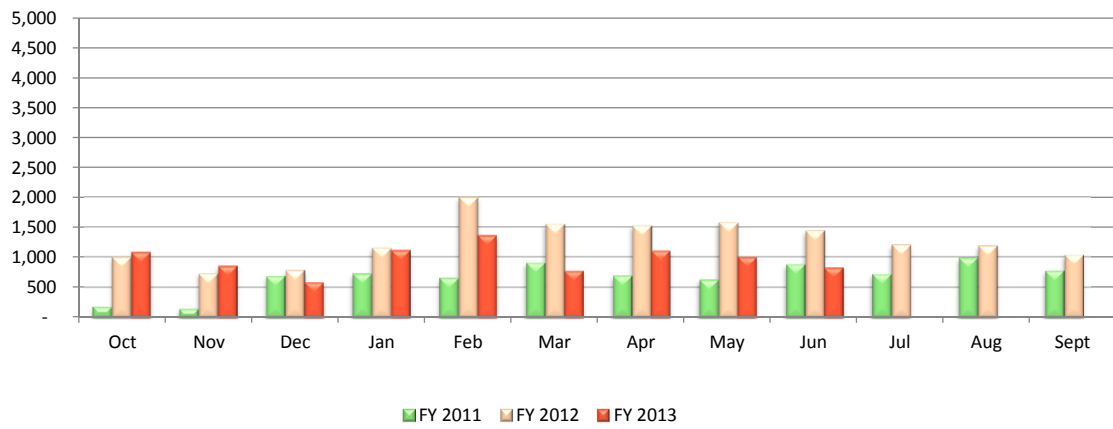
Constable Pct. 4 - Total Papers Cleared per Deputy



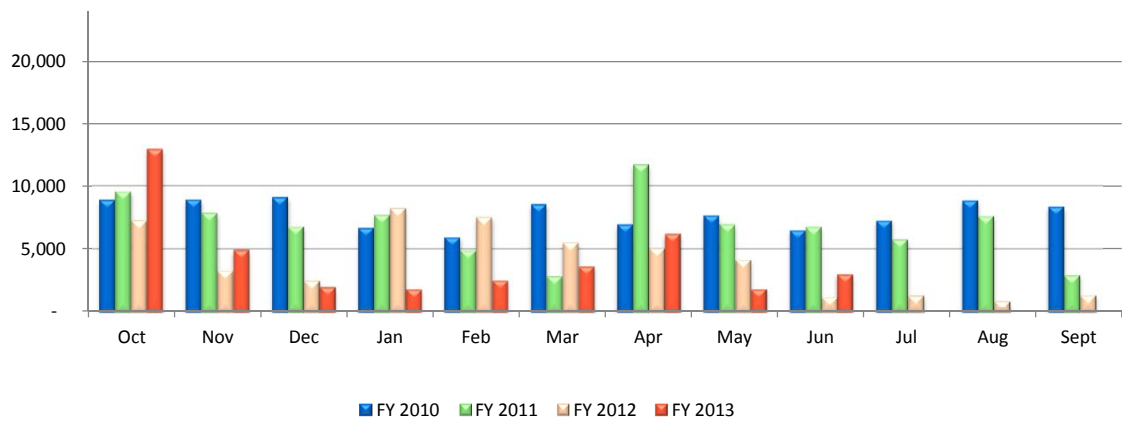

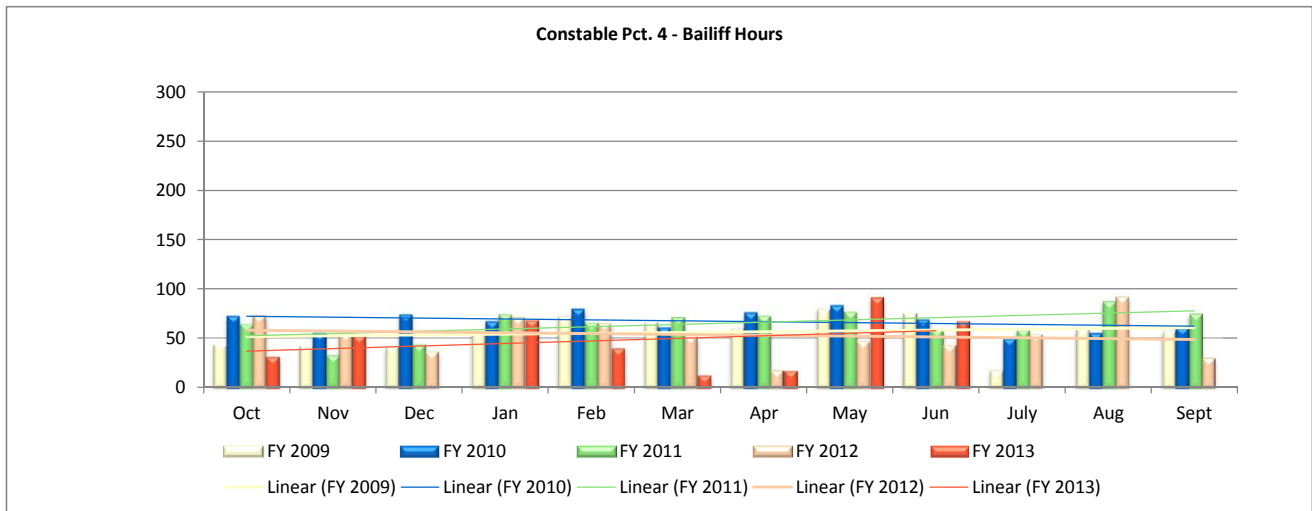
Constable Pct. 4 - Total Attempts

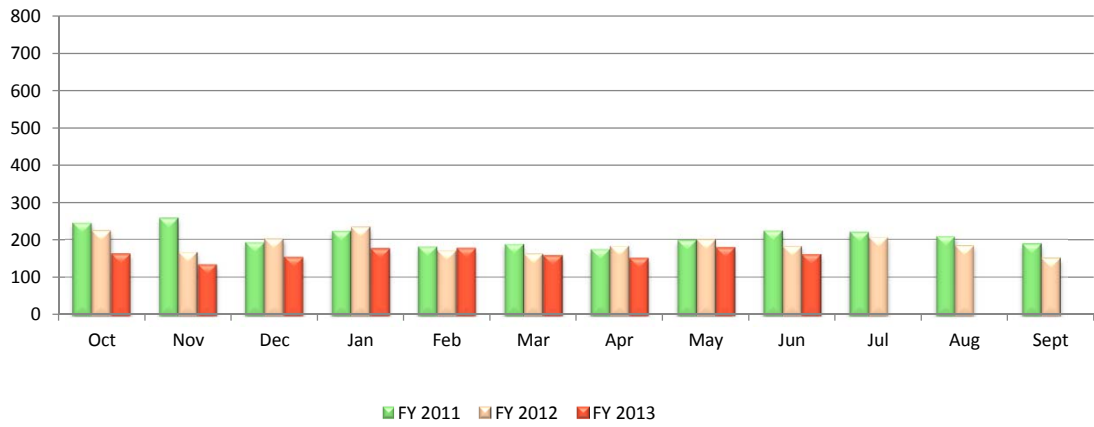

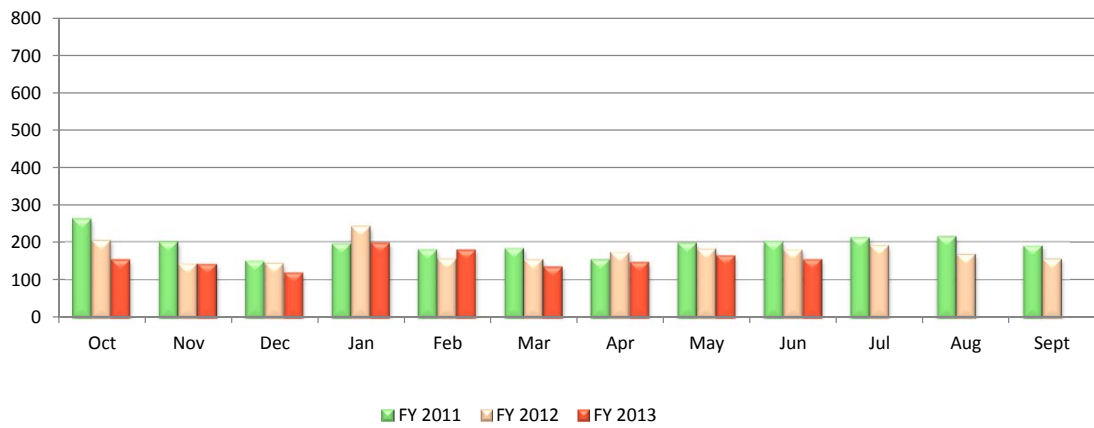

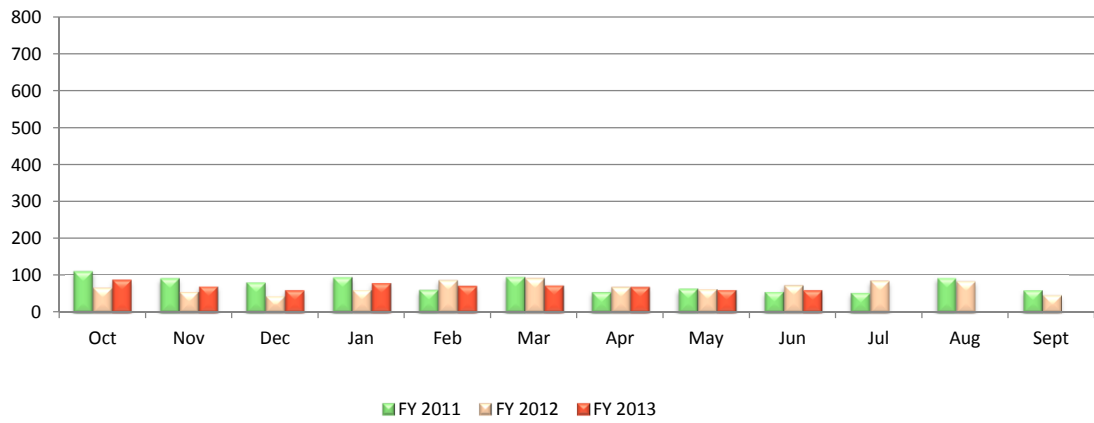


Constable Pct. 4 - Forcible Served

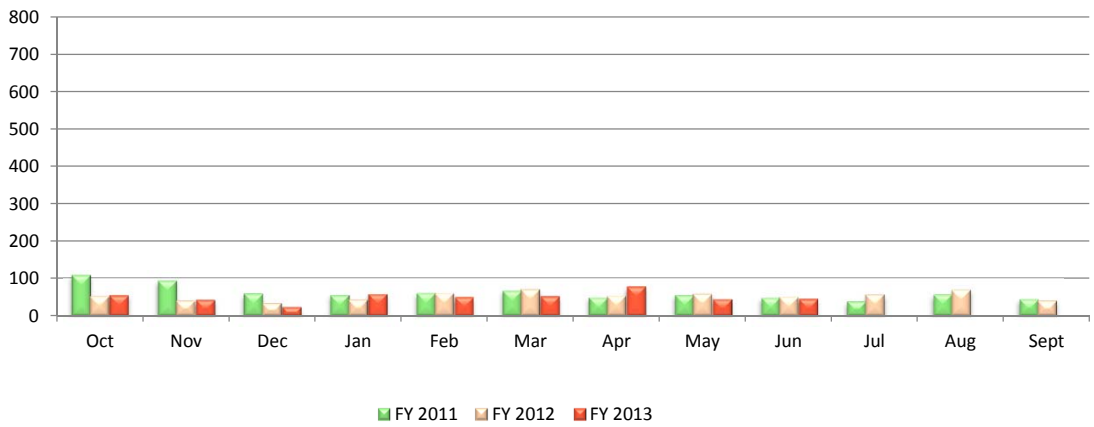

Constable Pct. 4 - Criminal Subpoenas Received

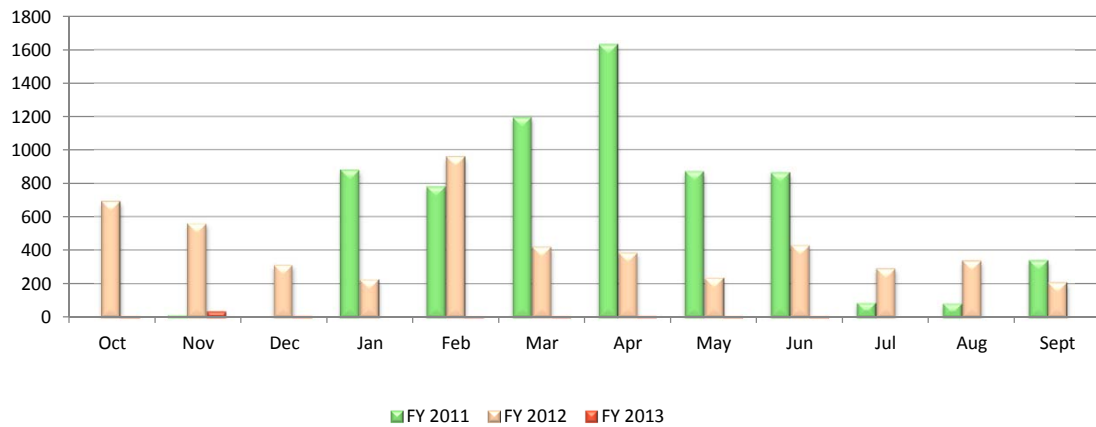

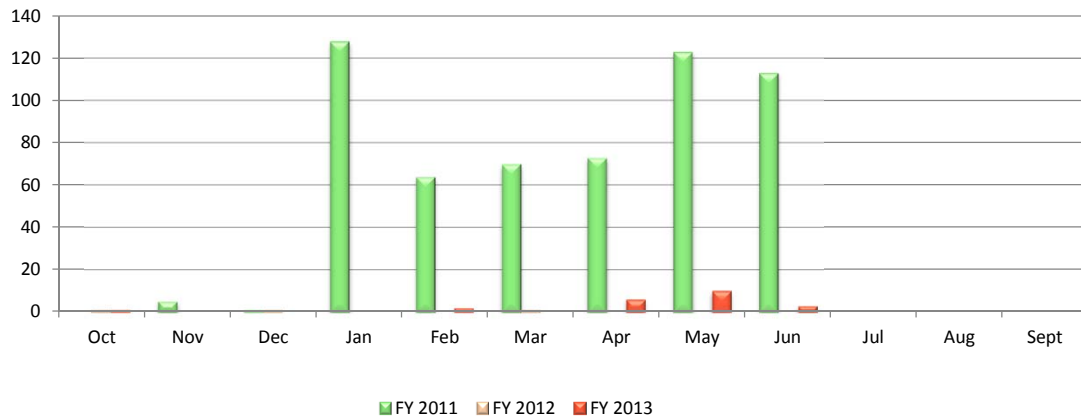
