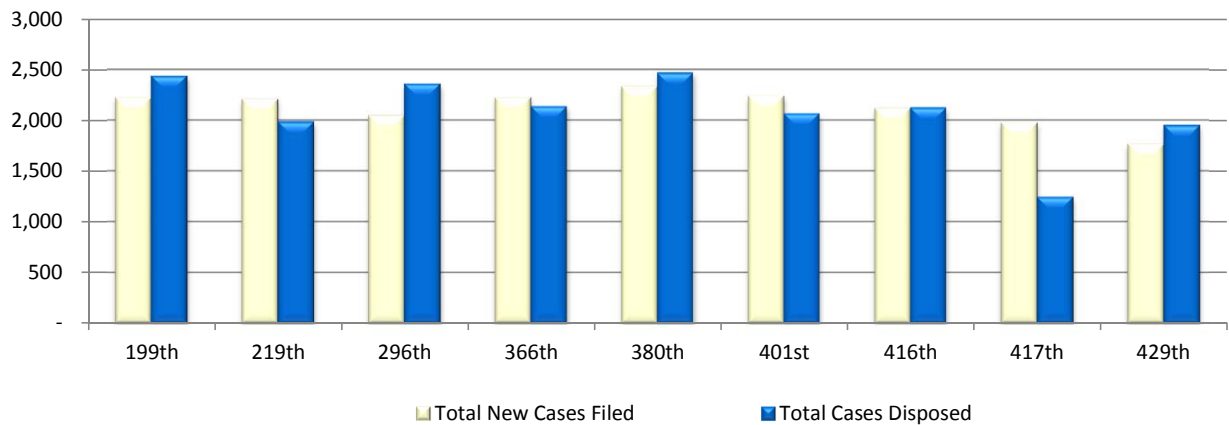
District Courts FY 2010



District Courts FY 2011

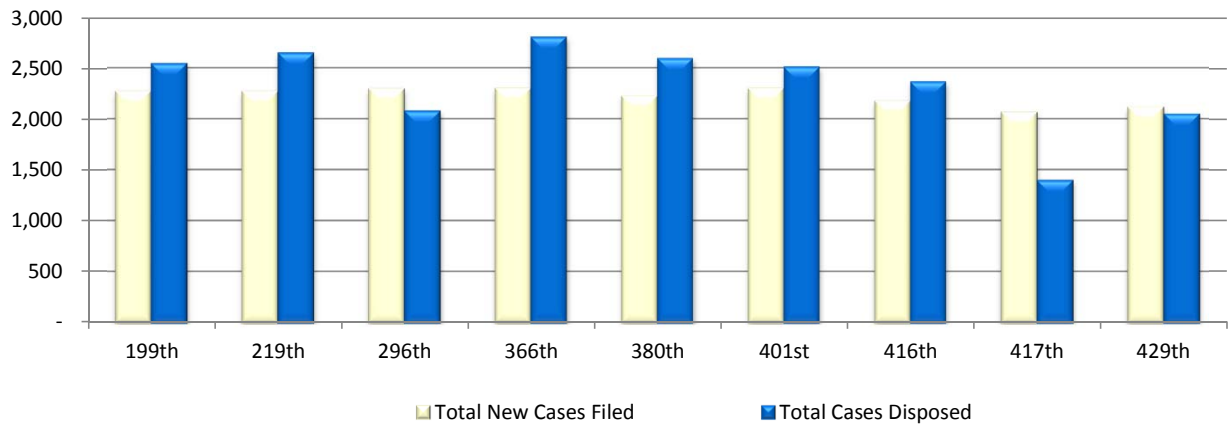

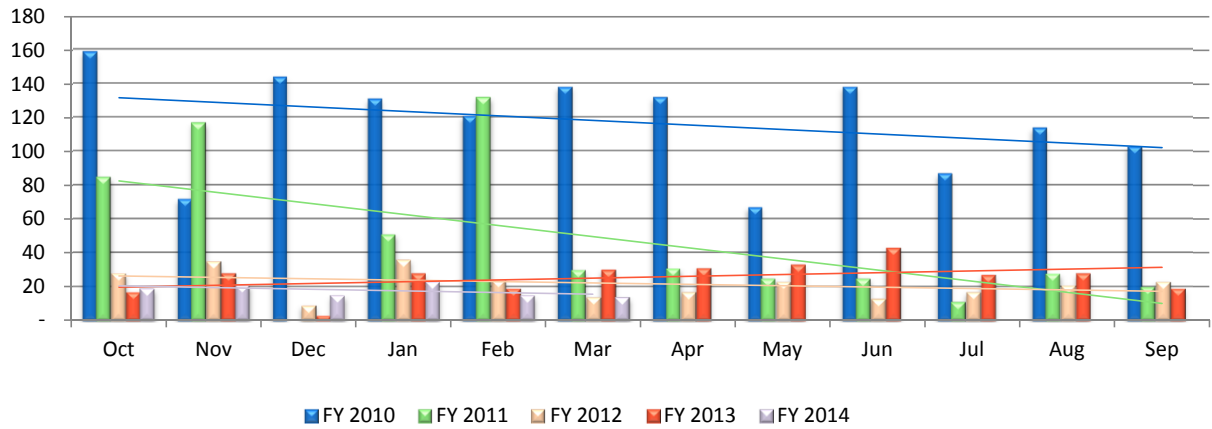
