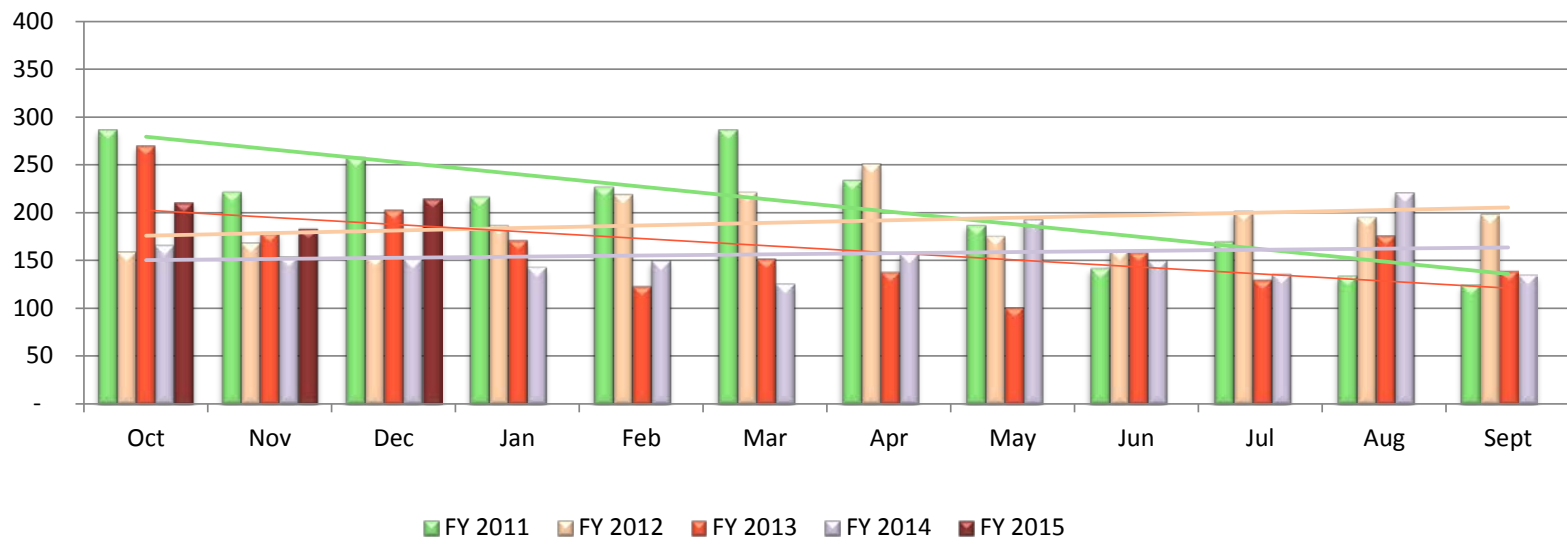

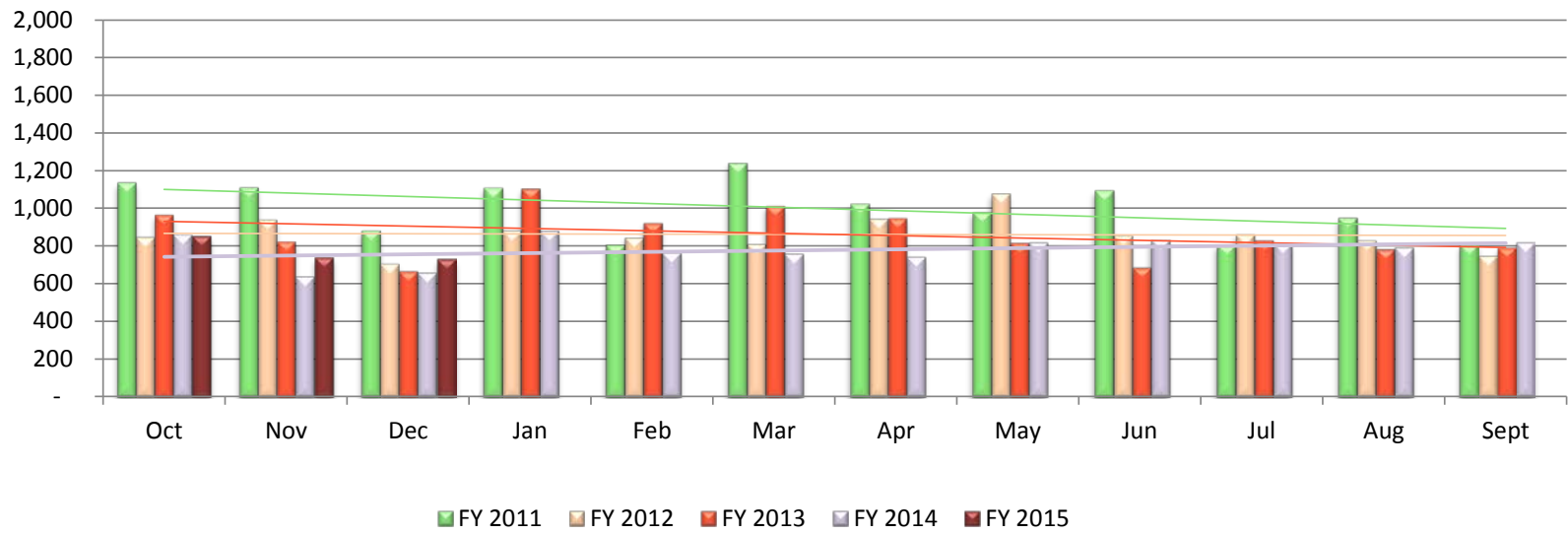

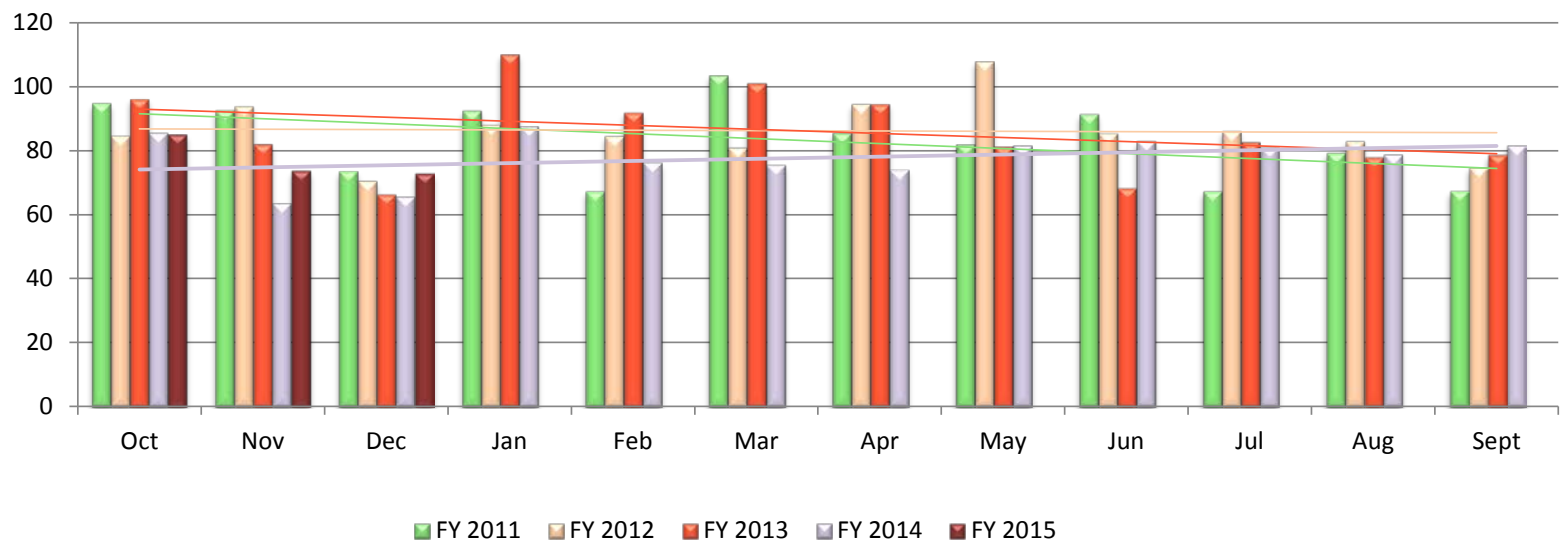

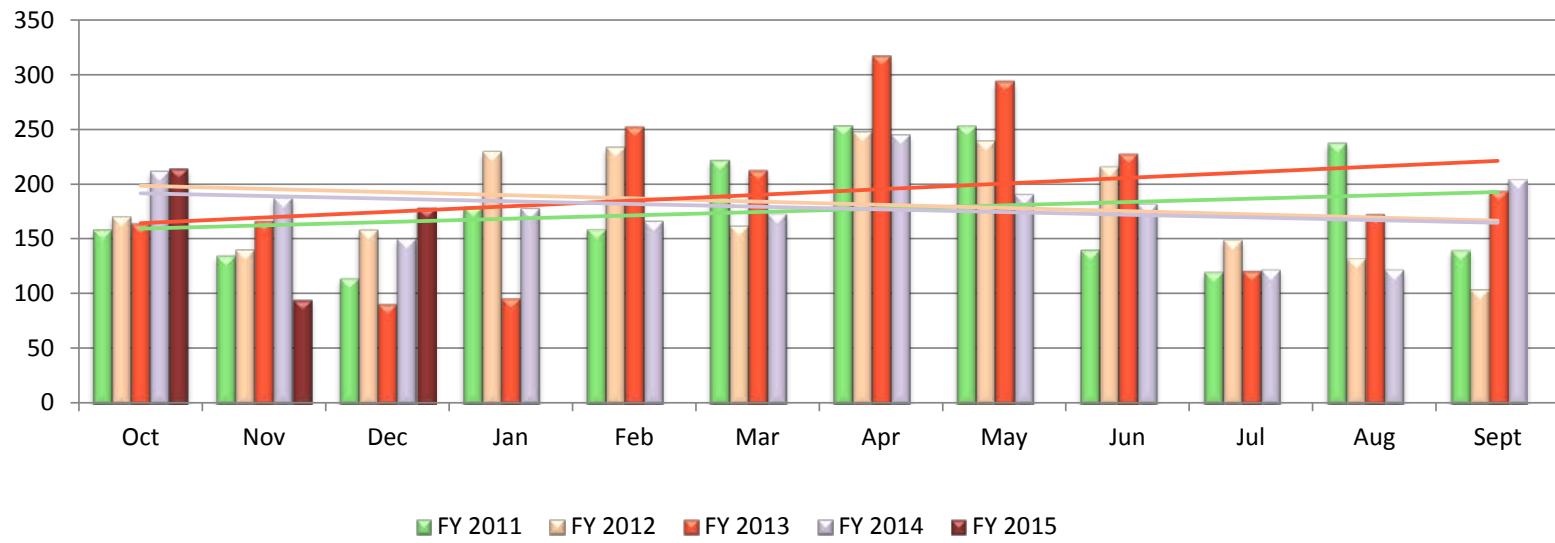

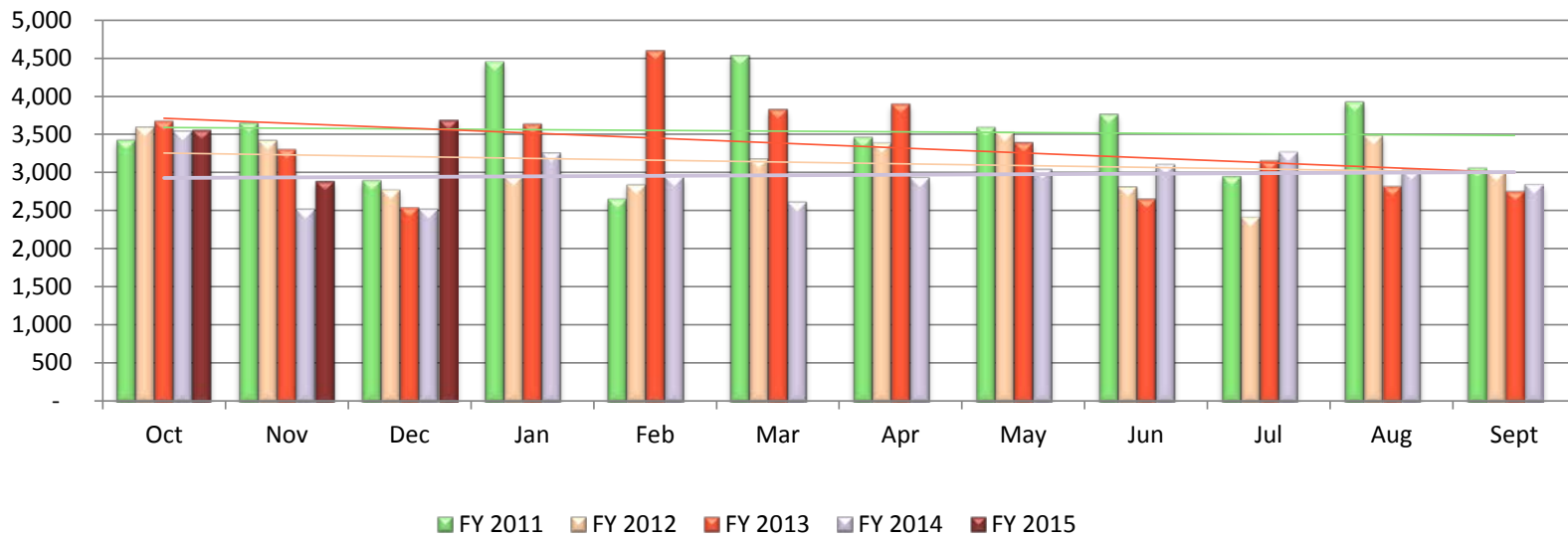

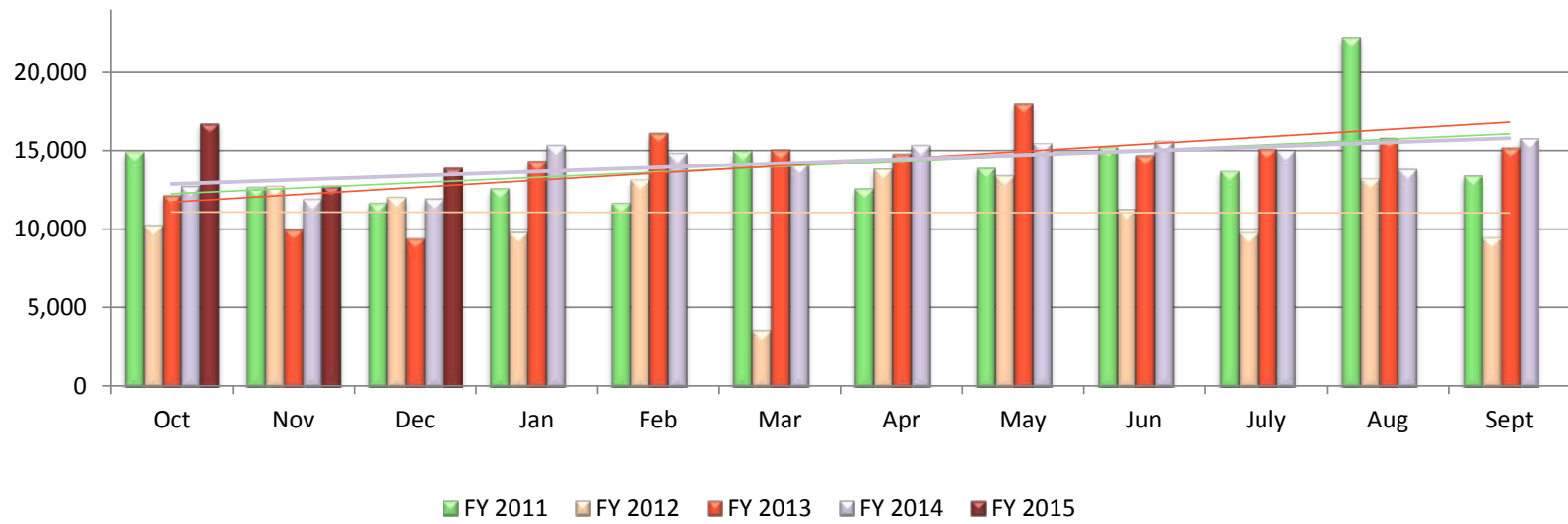

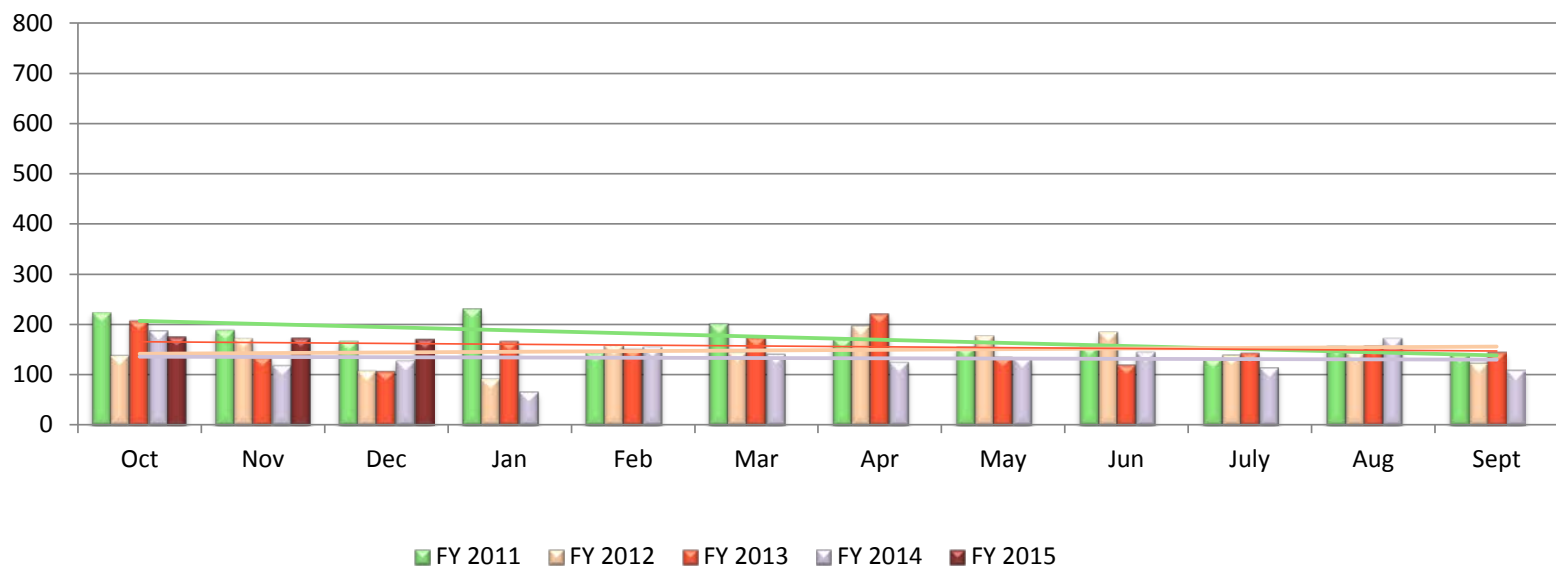

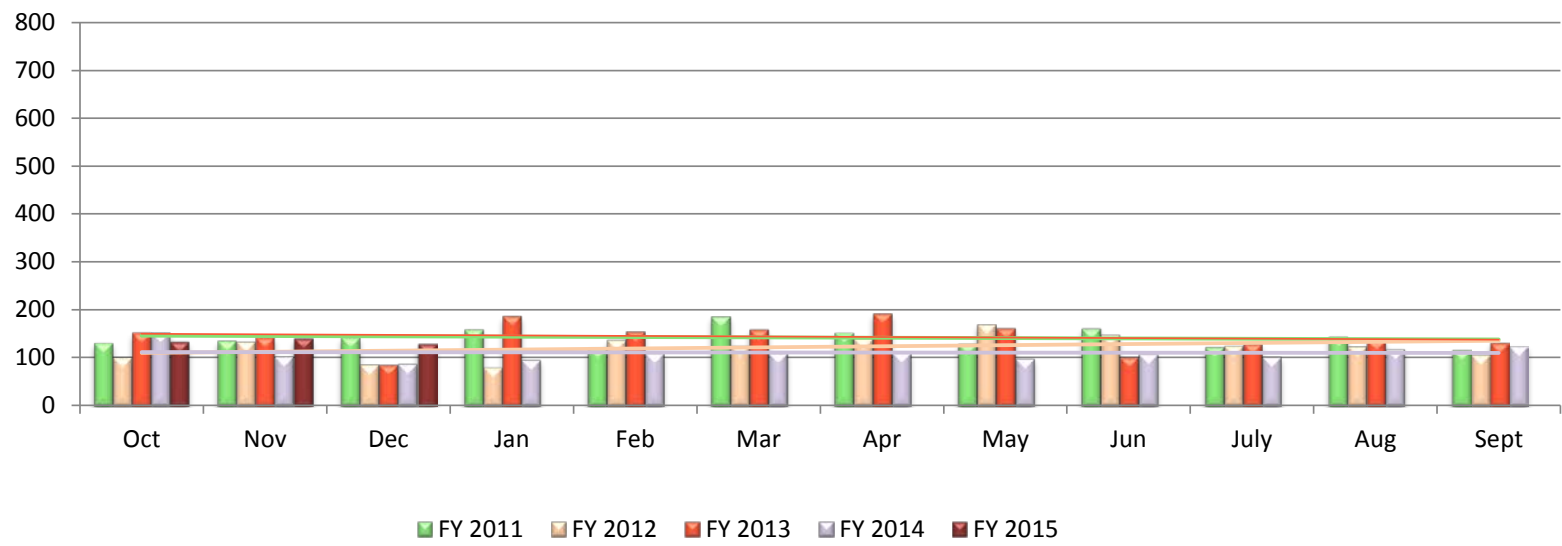

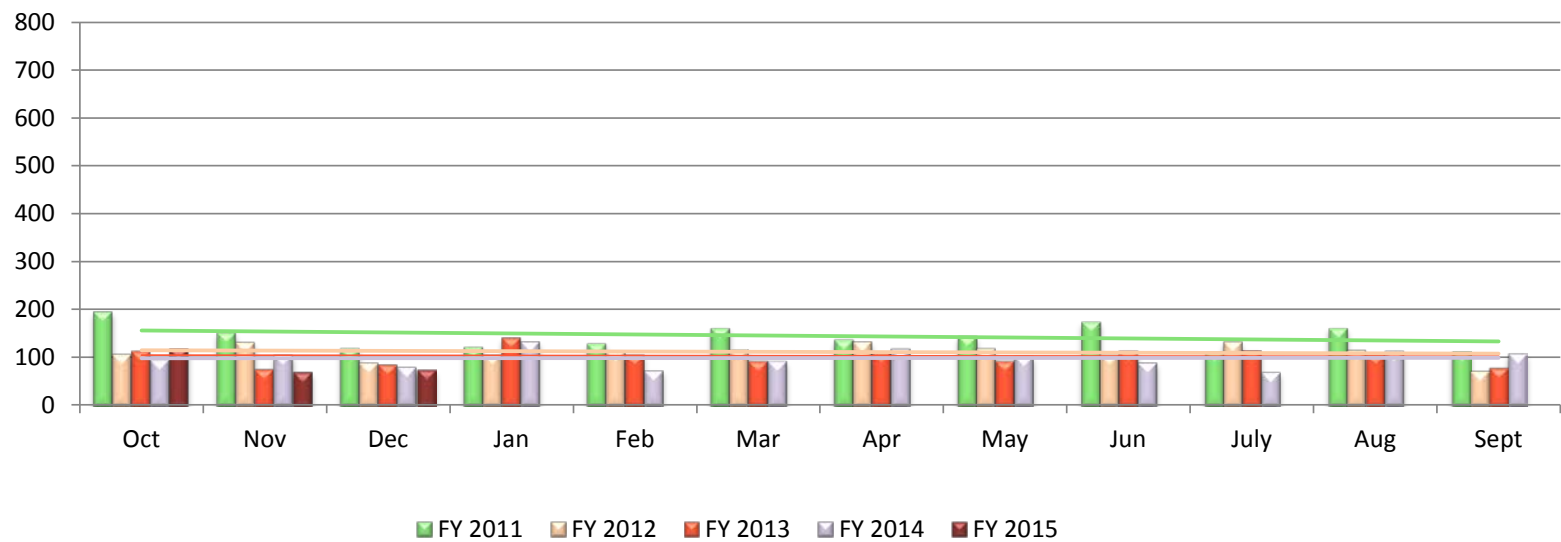

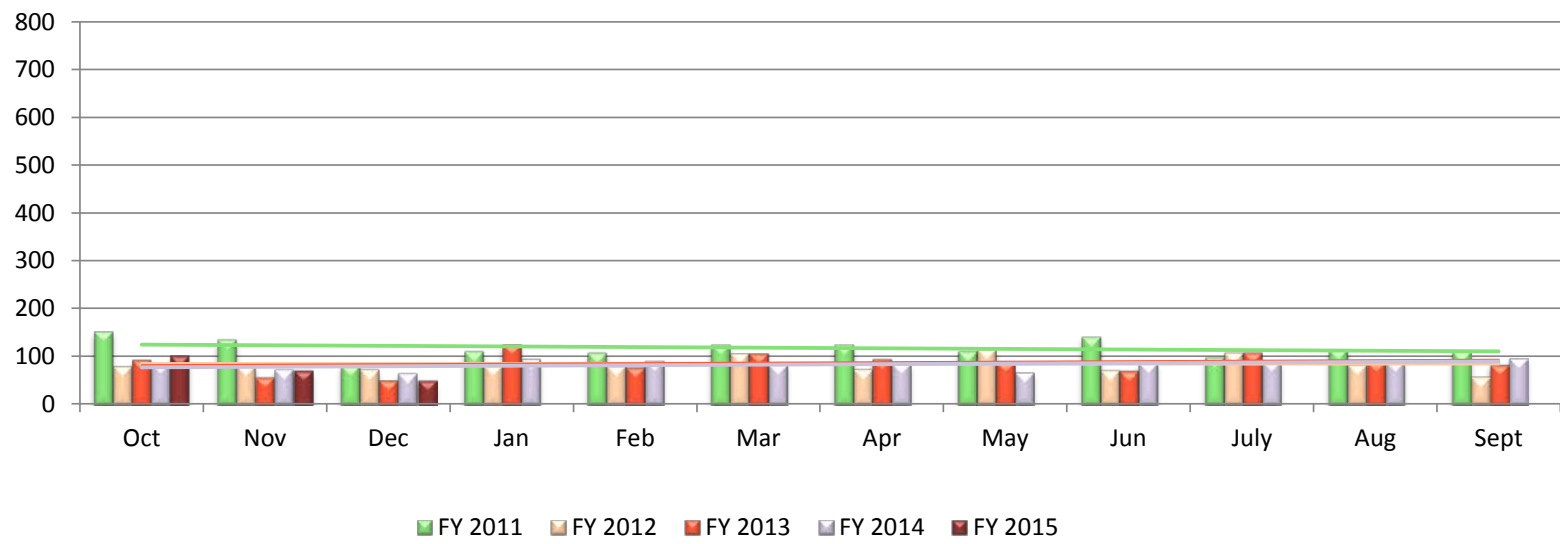

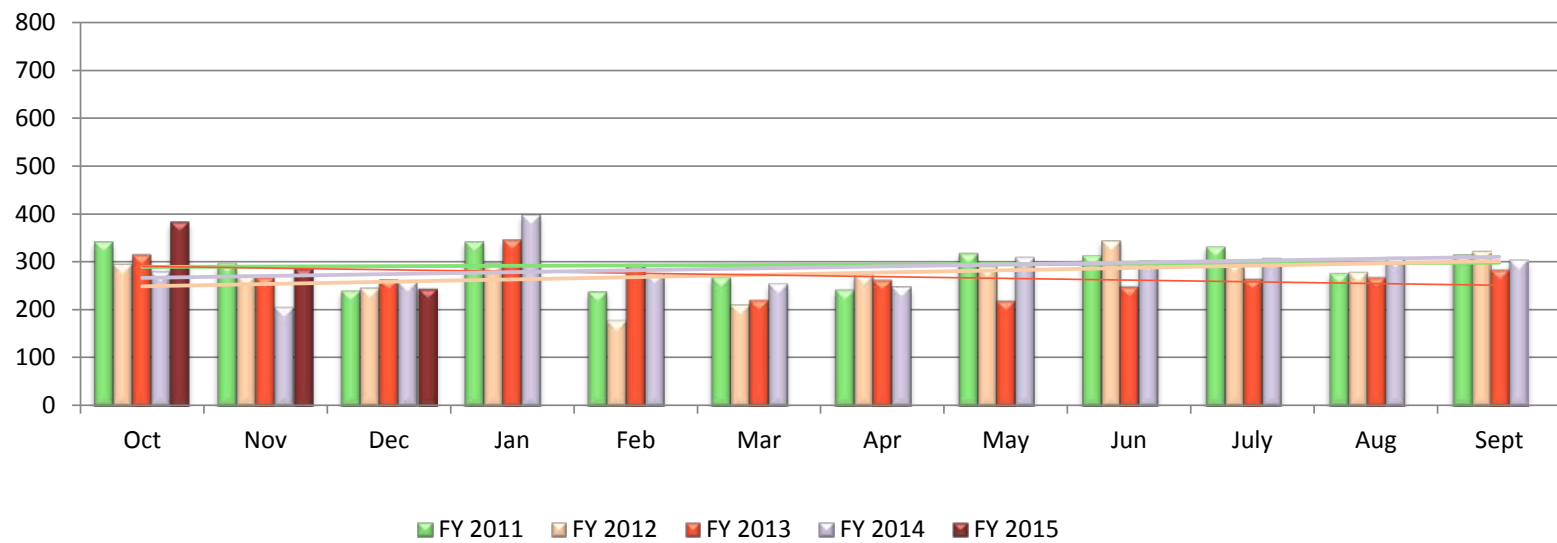

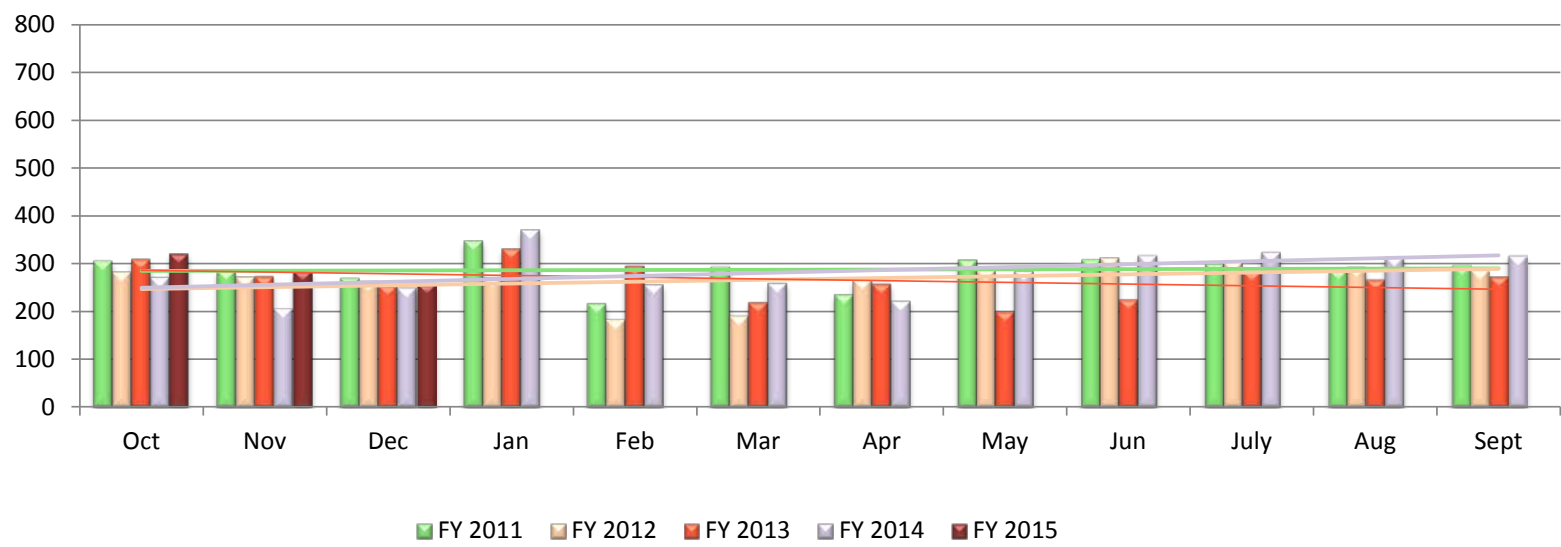

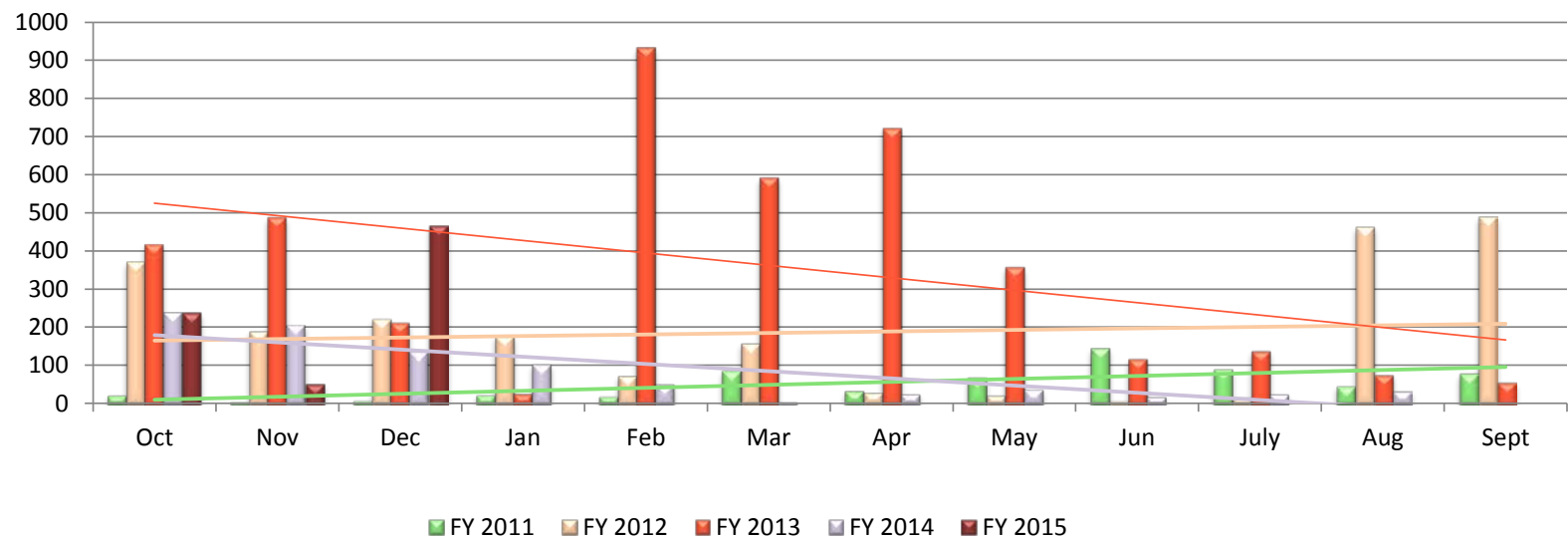

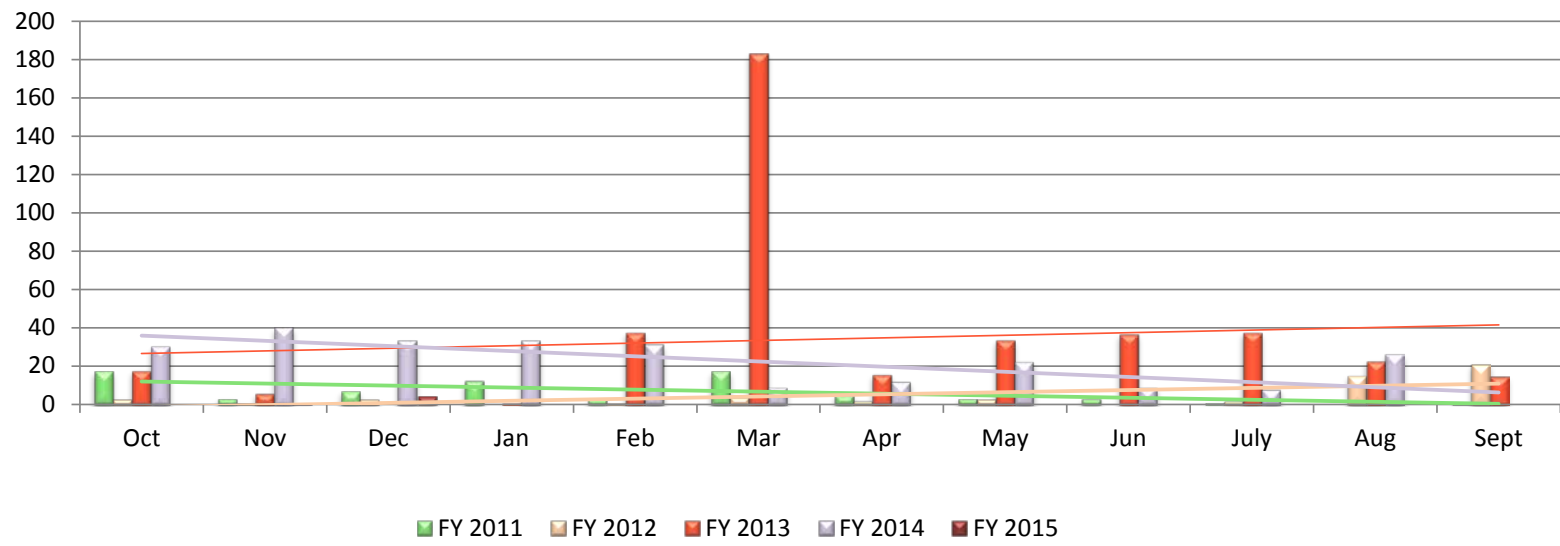

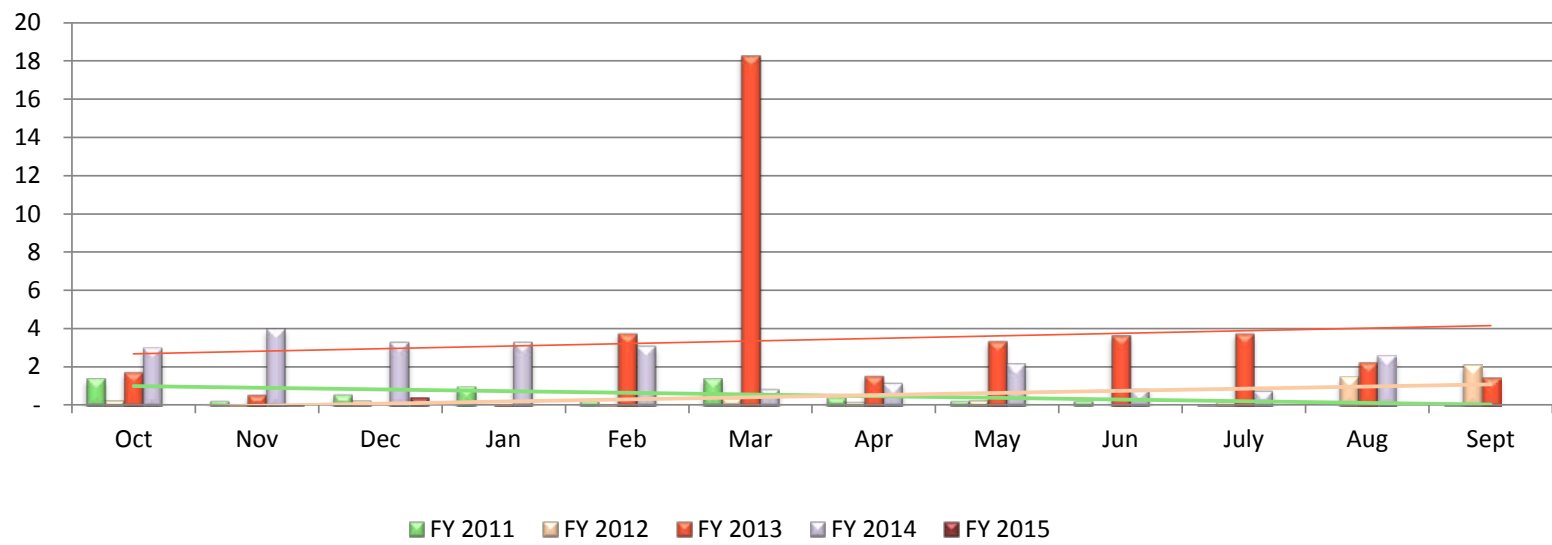

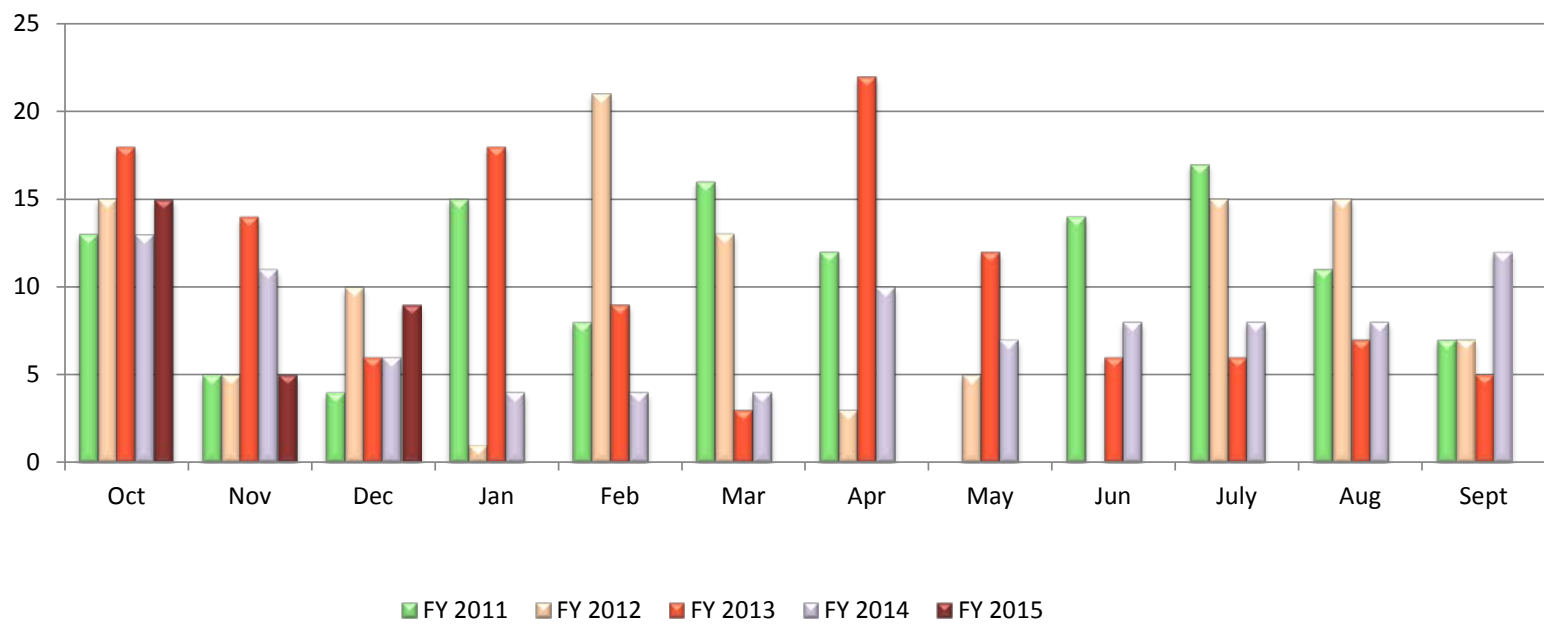
Constable Pct. 3 - Warrants Served per Deputy

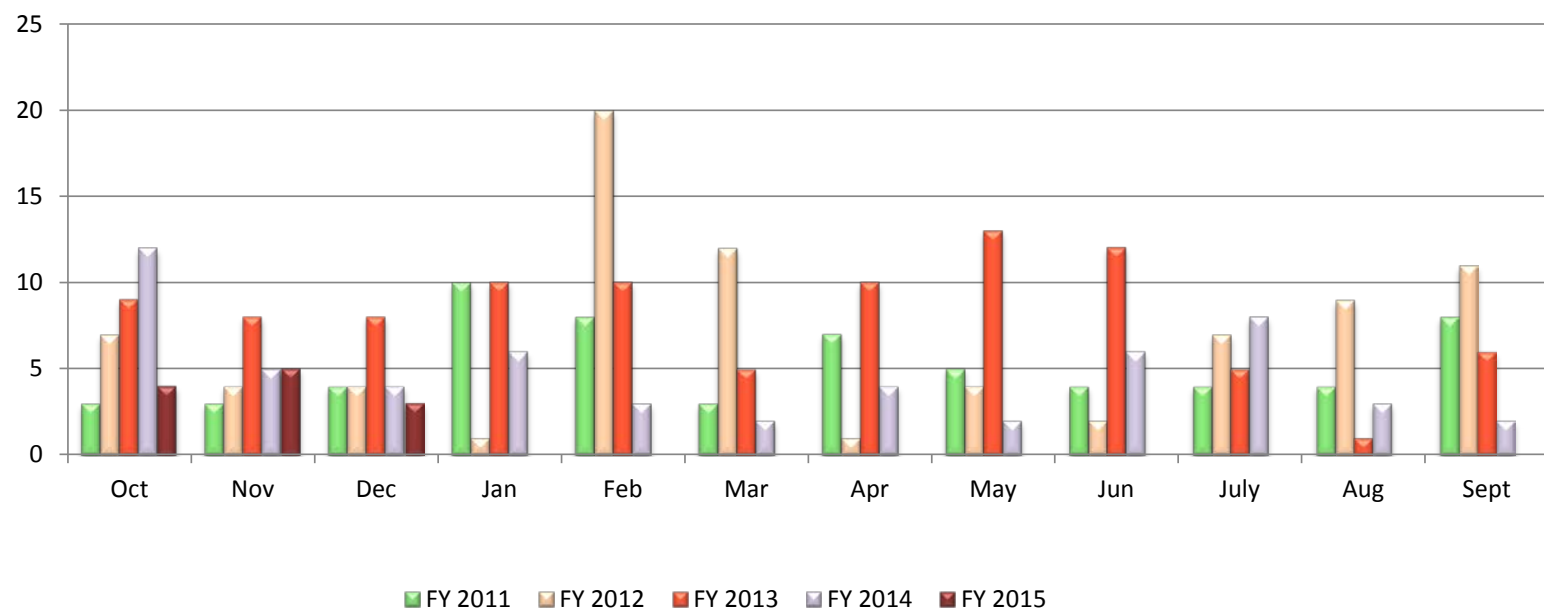

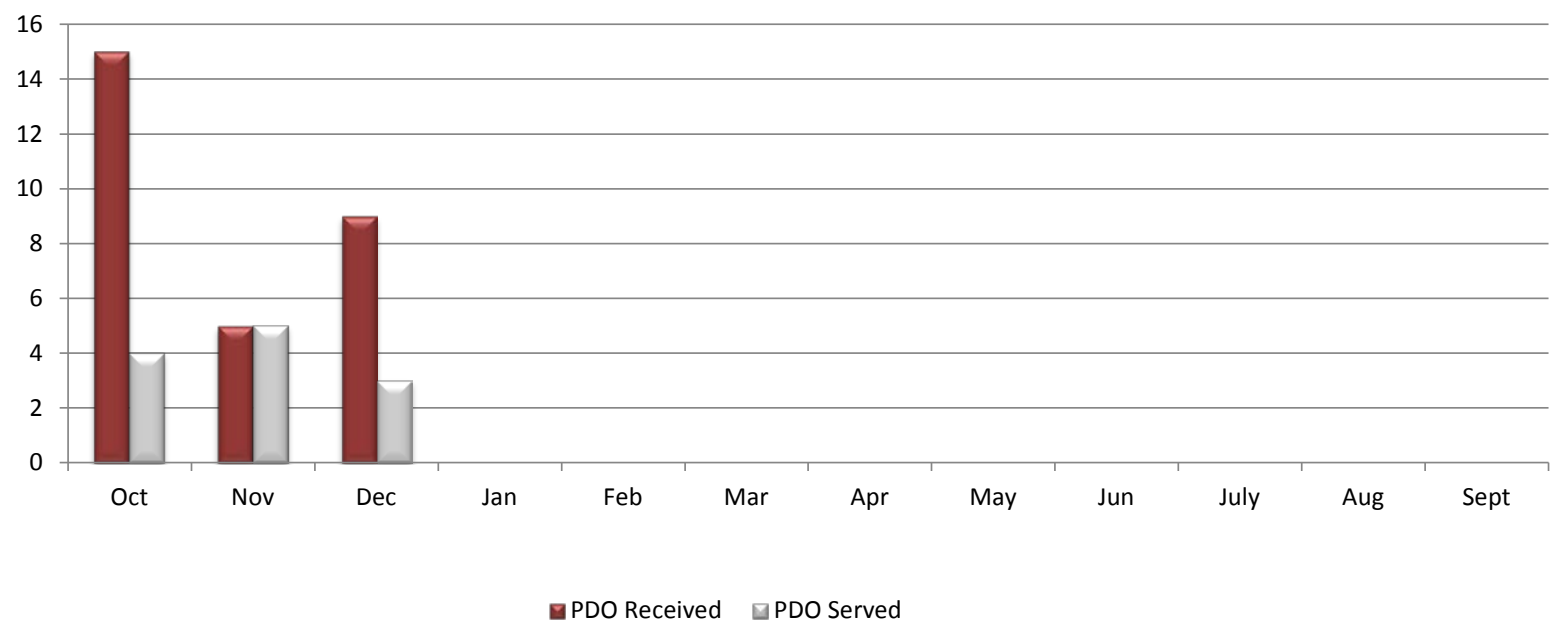

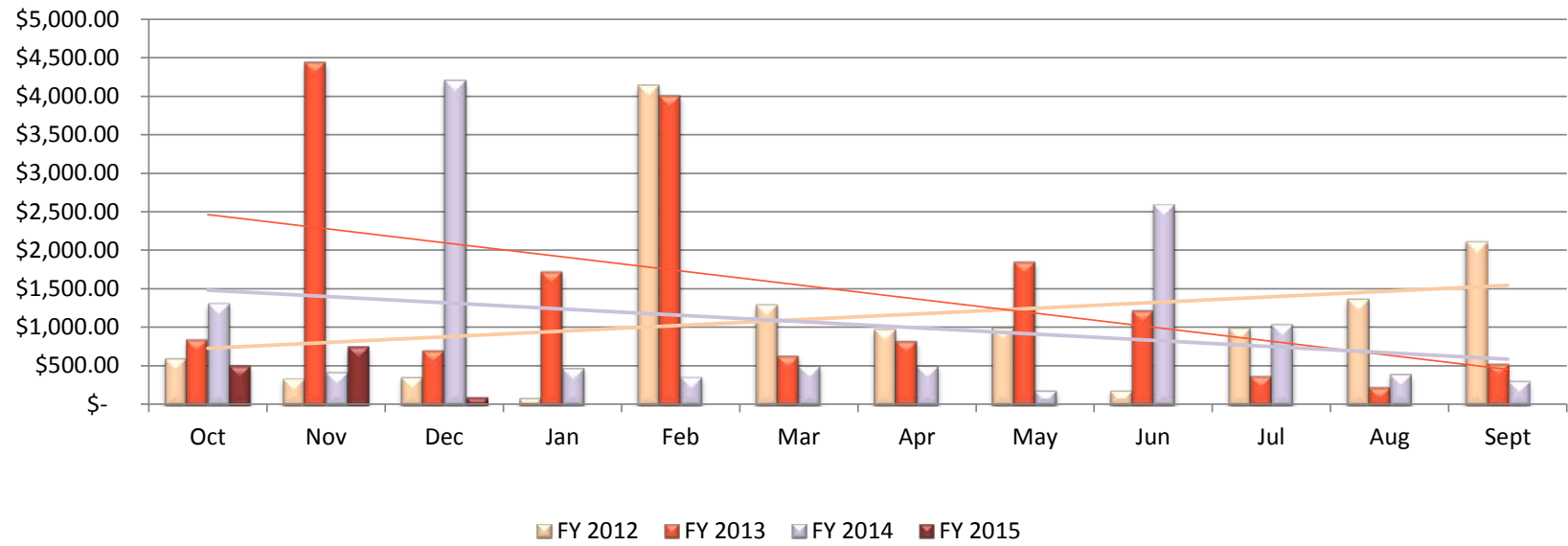

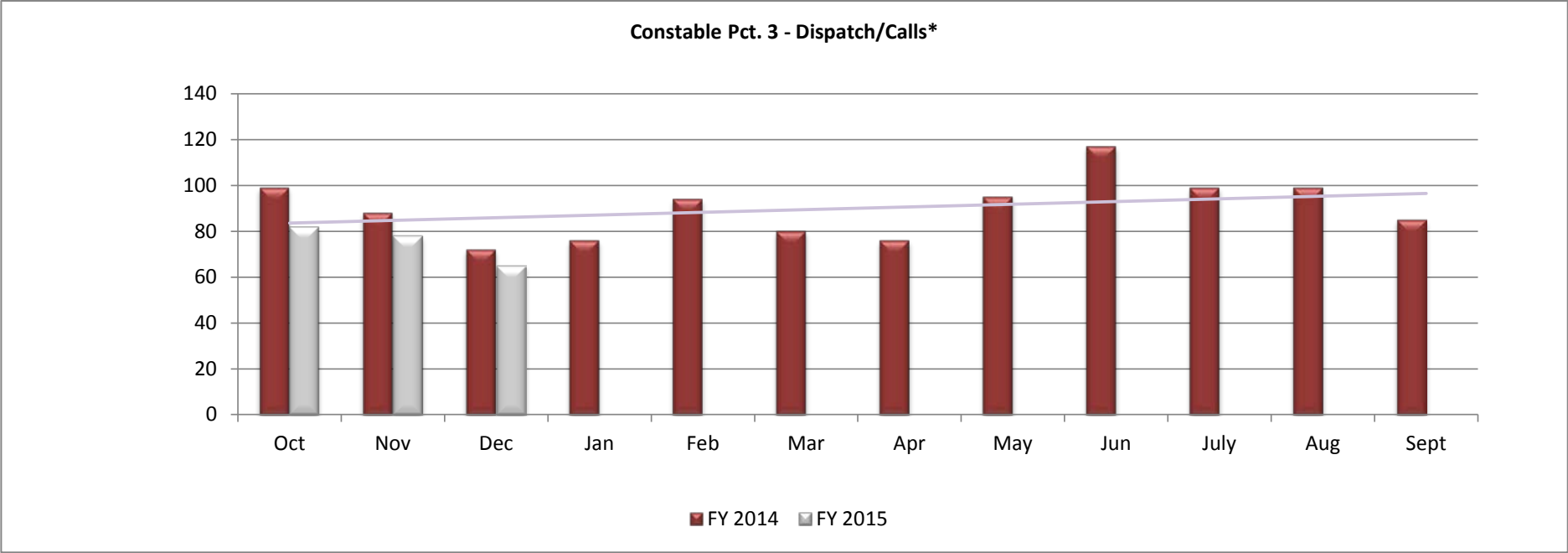
