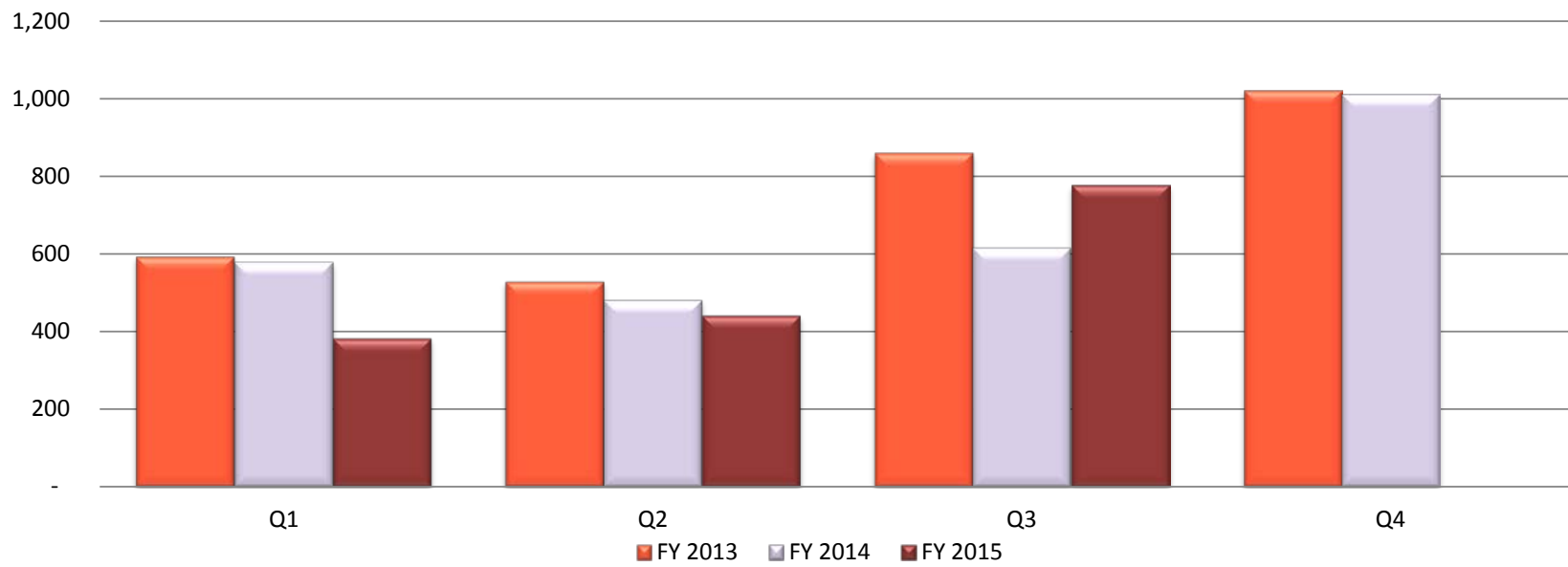

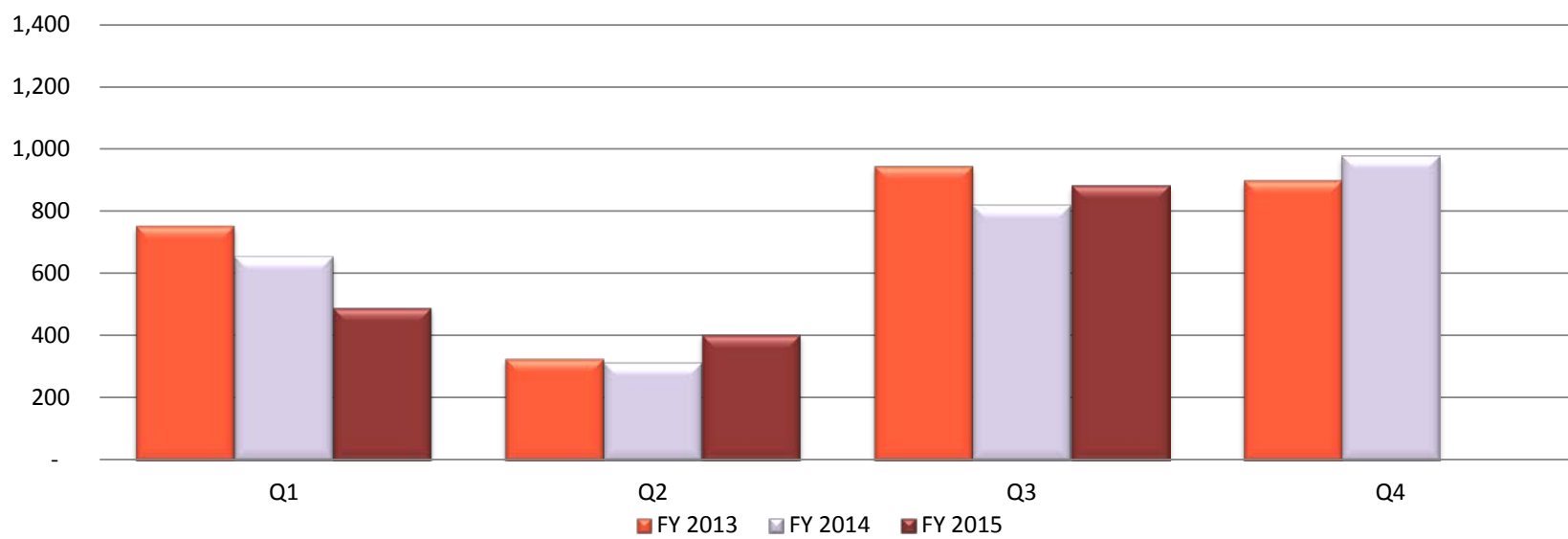

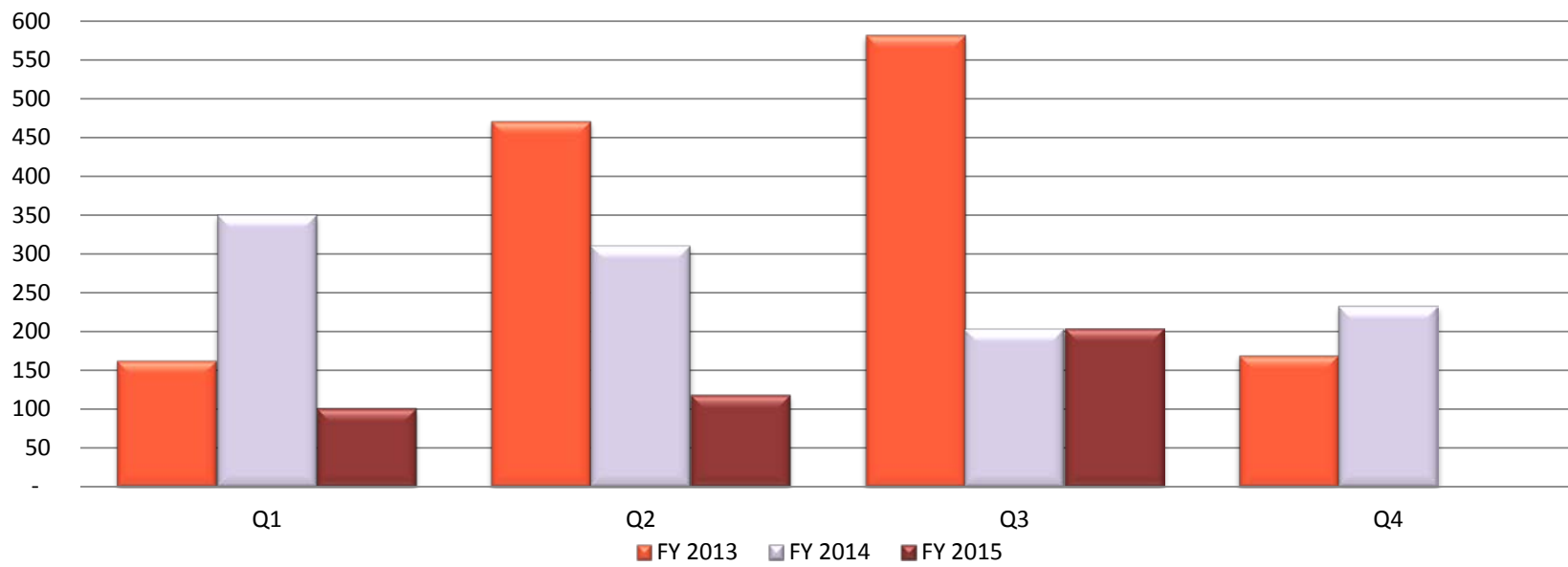

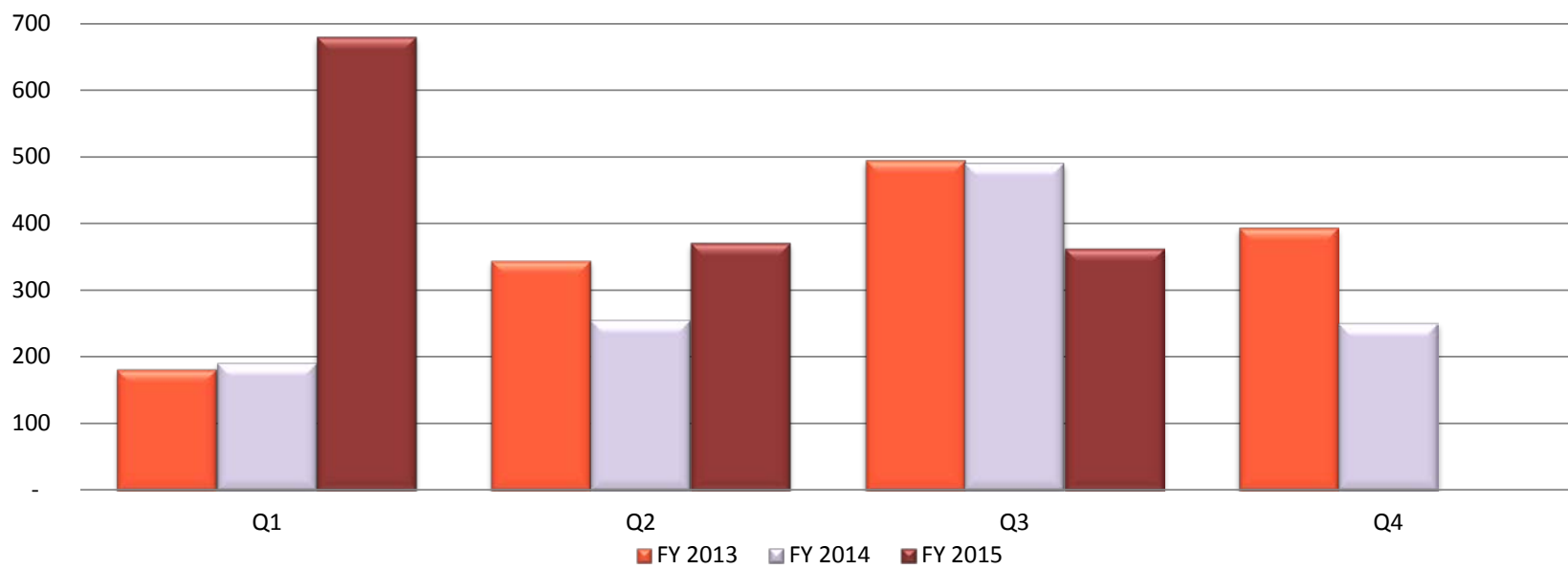

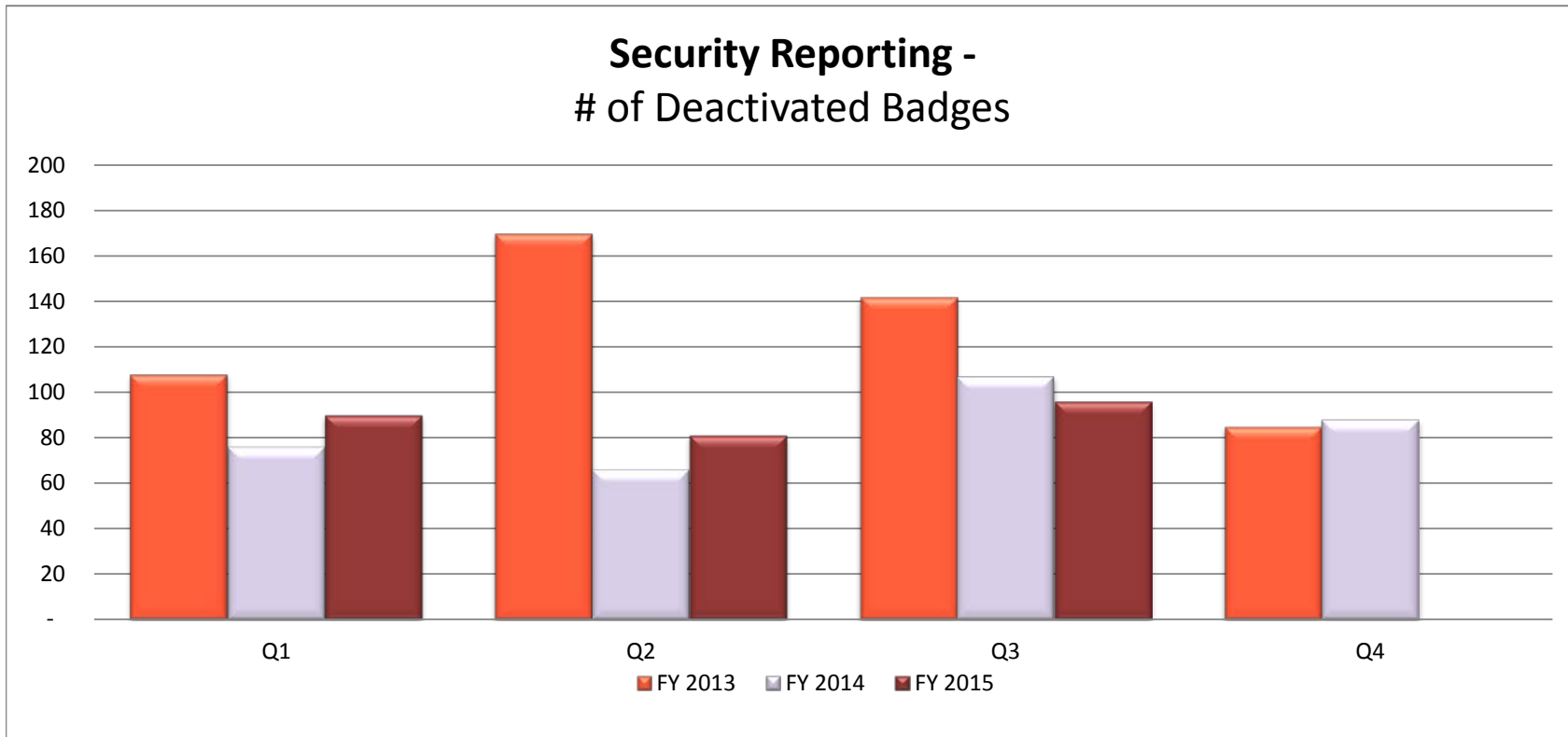
Security Reporting - # of Activated Badges
