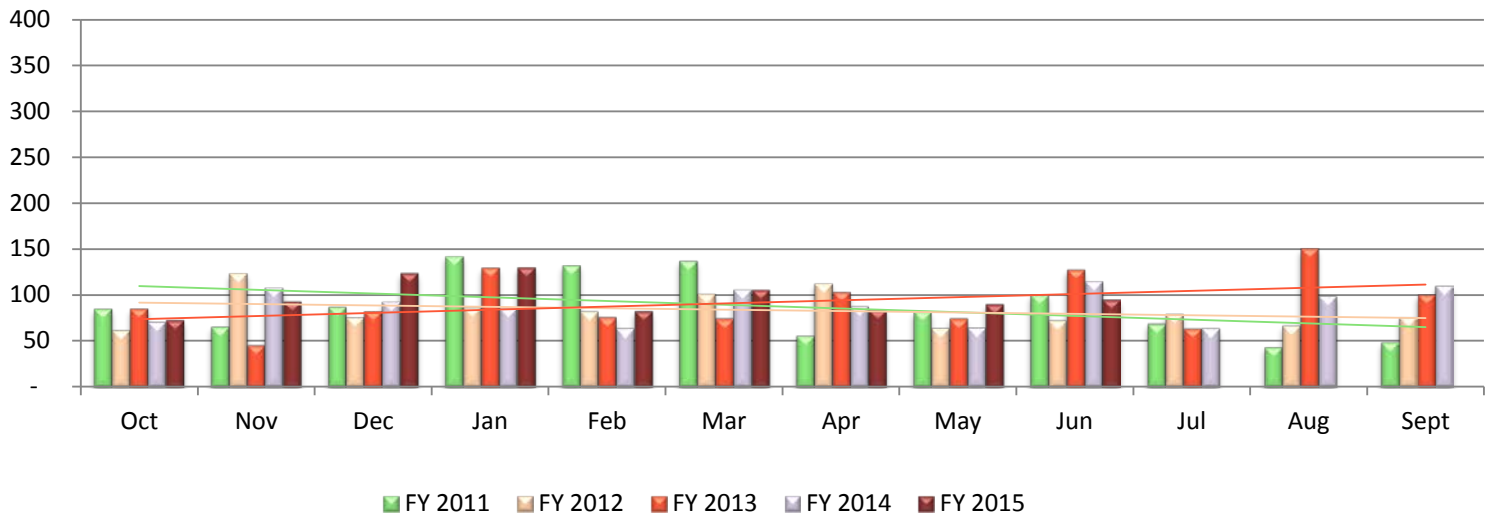

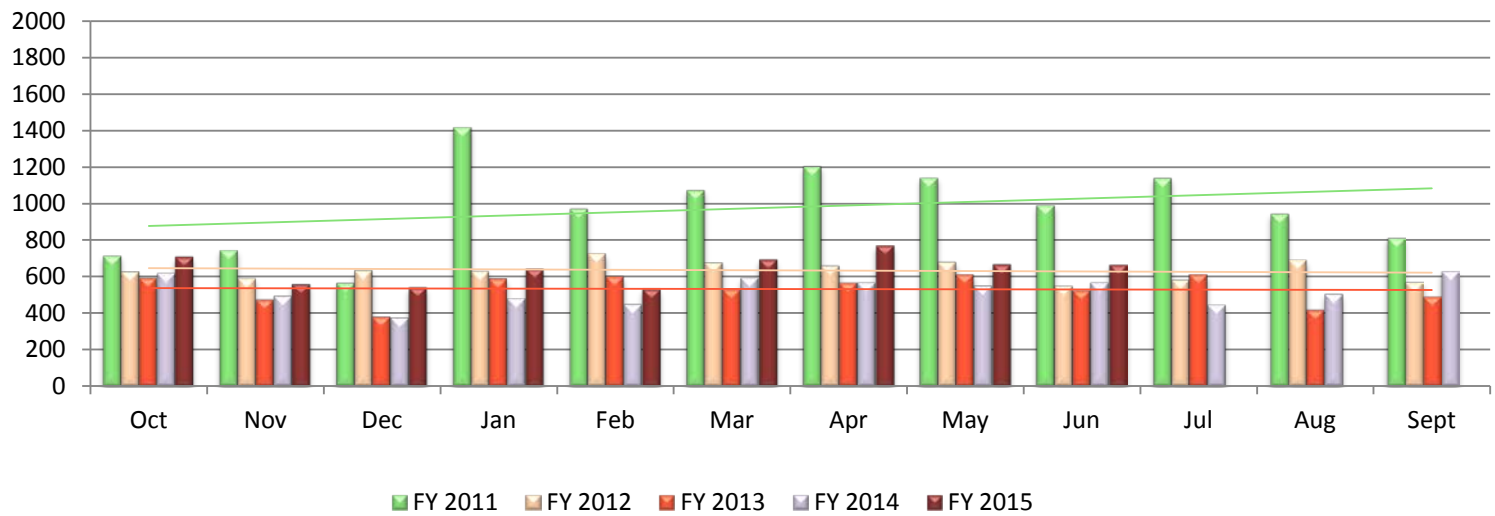

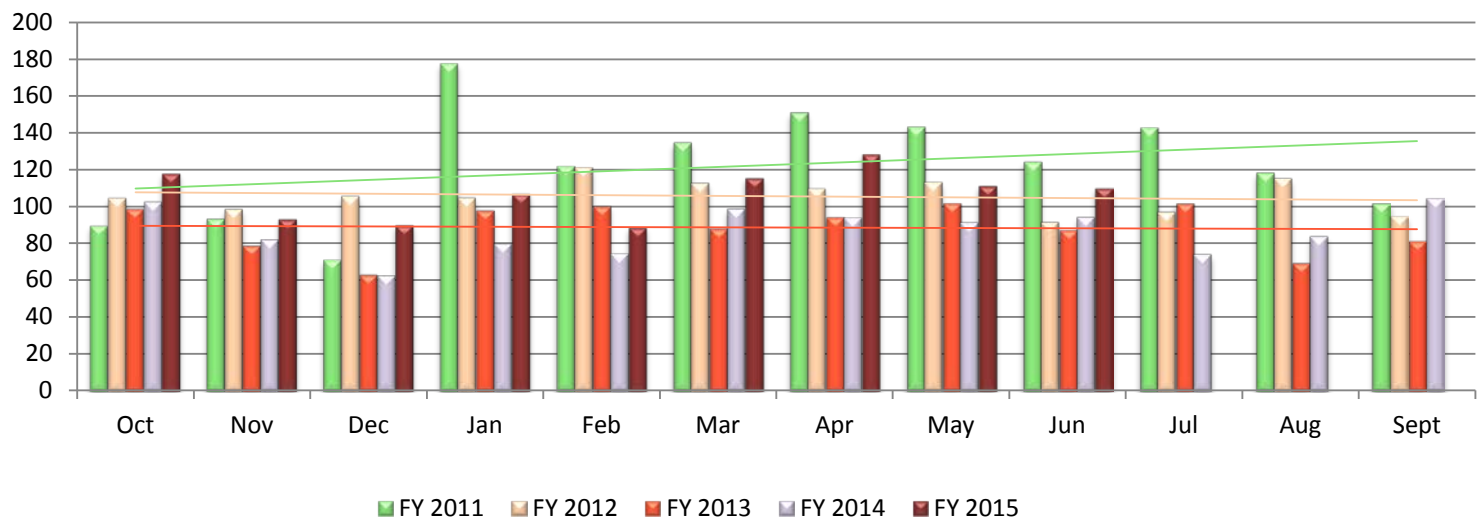

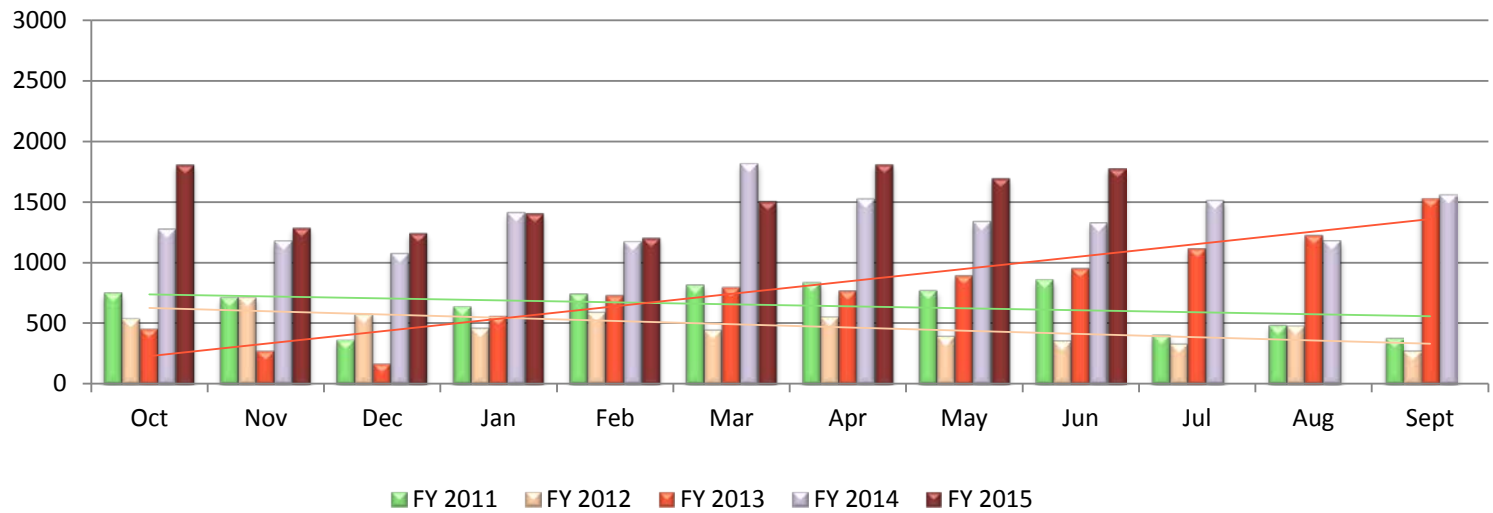

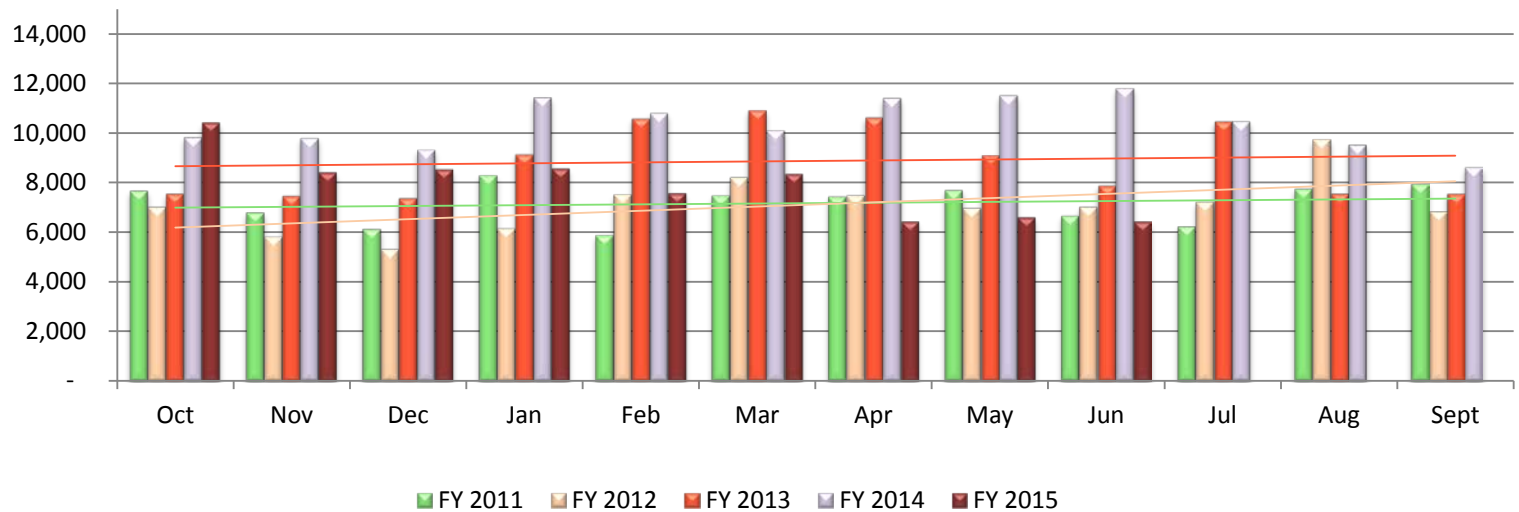

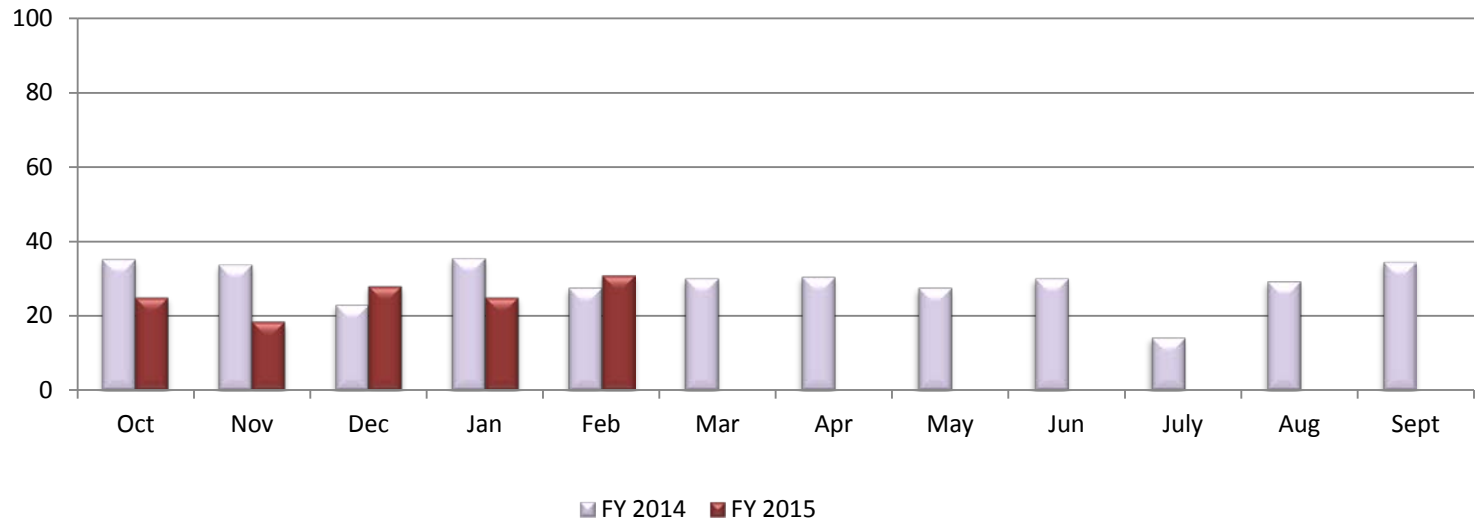

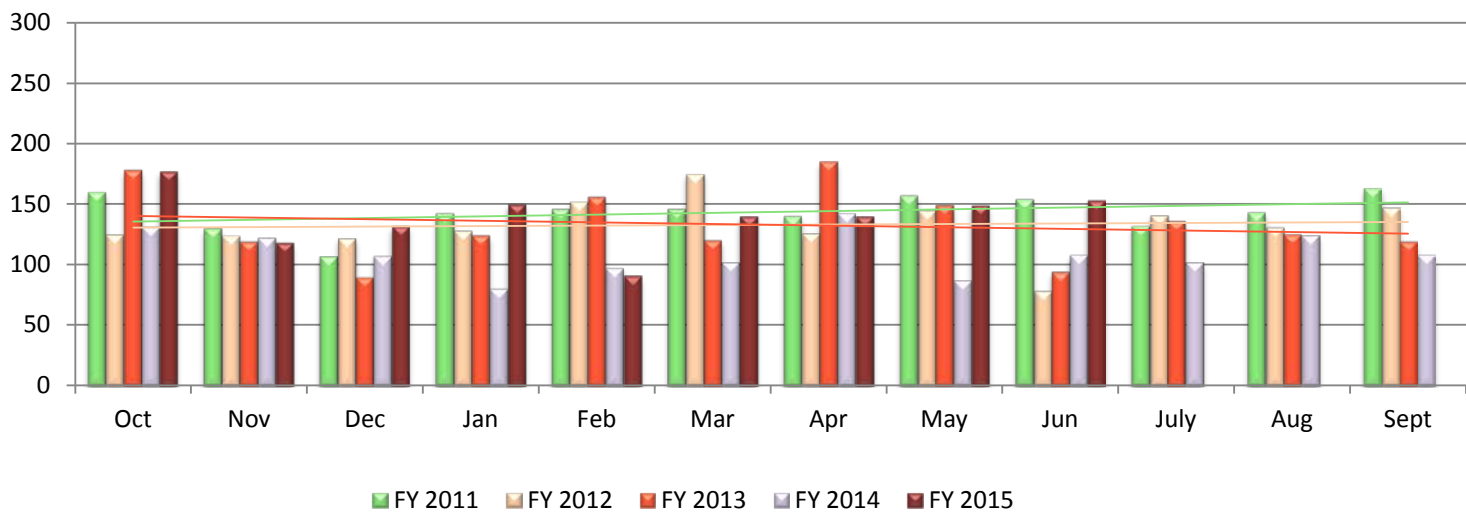
Constable Pct. 1 - Bailiff Hours

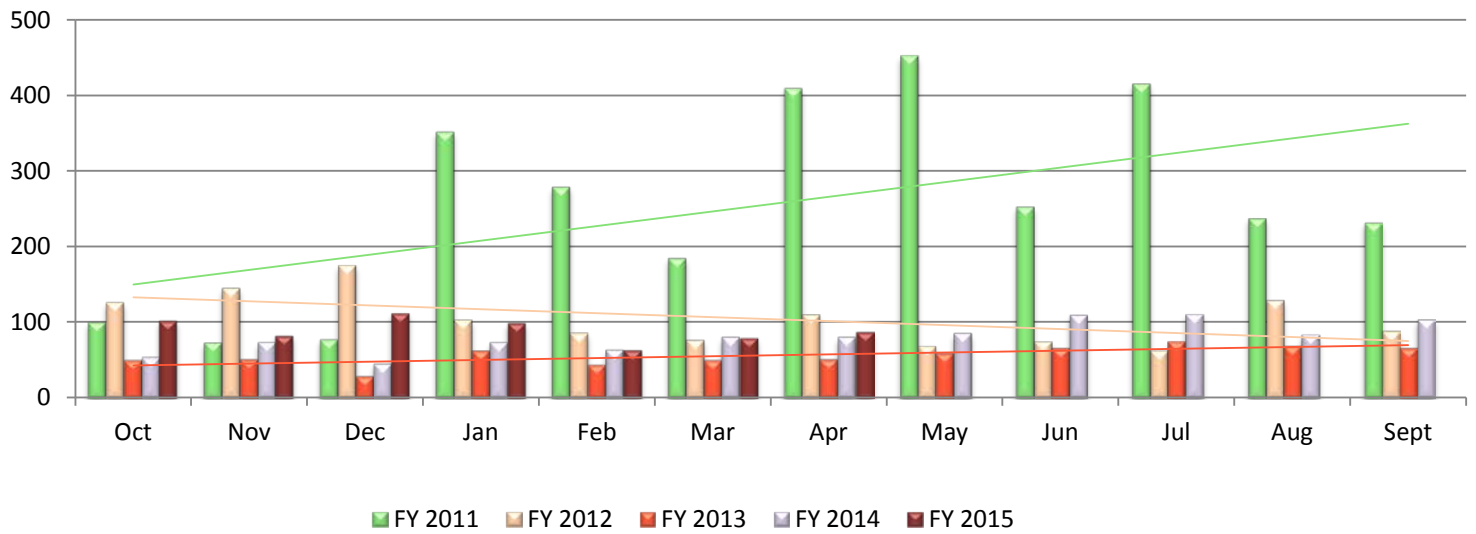

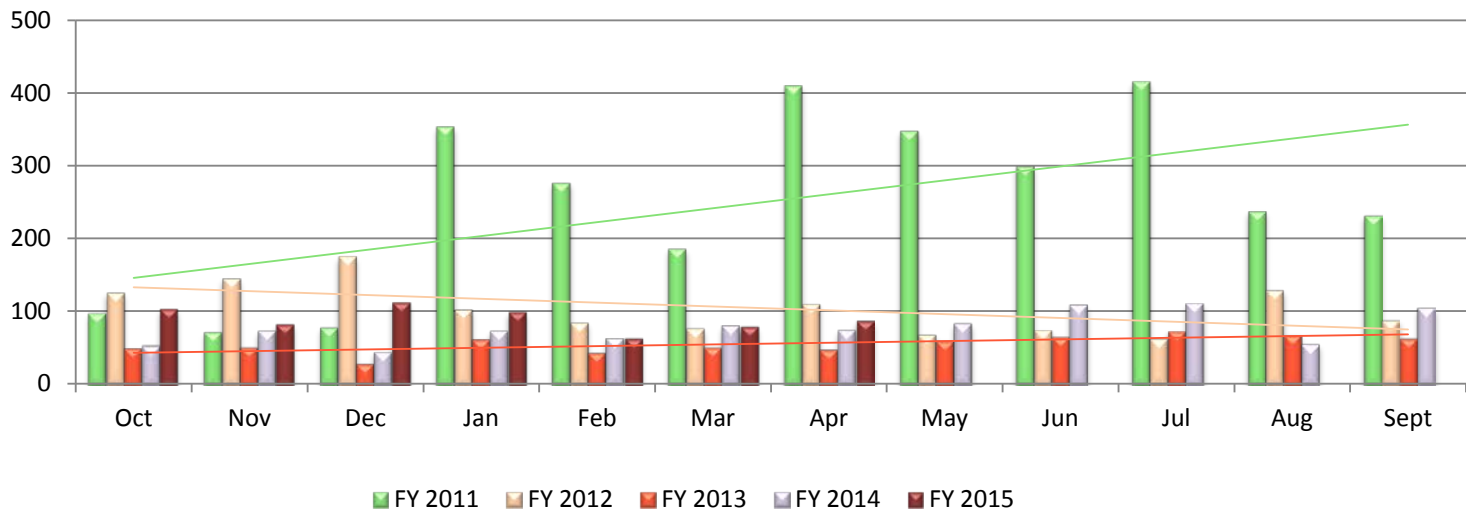

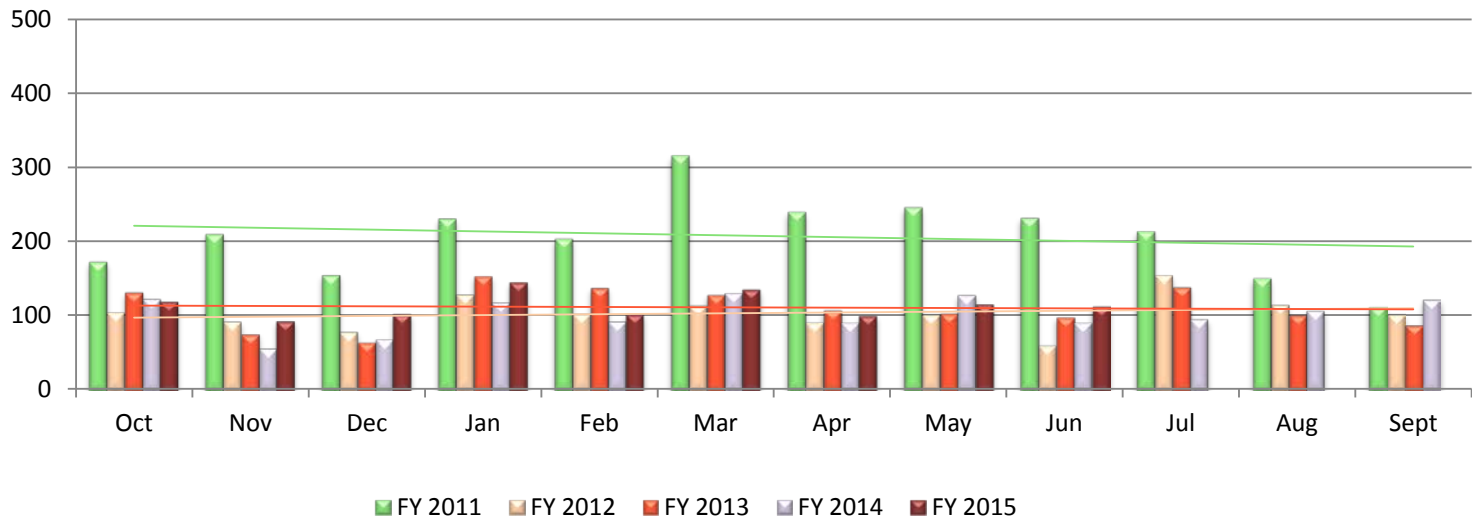

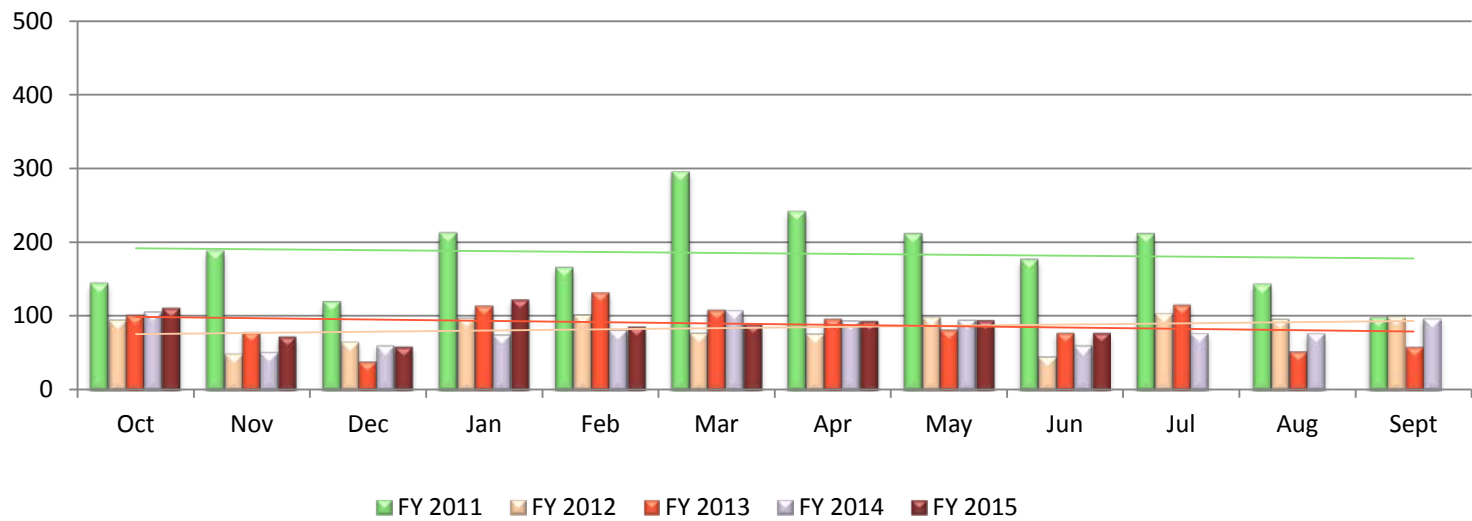

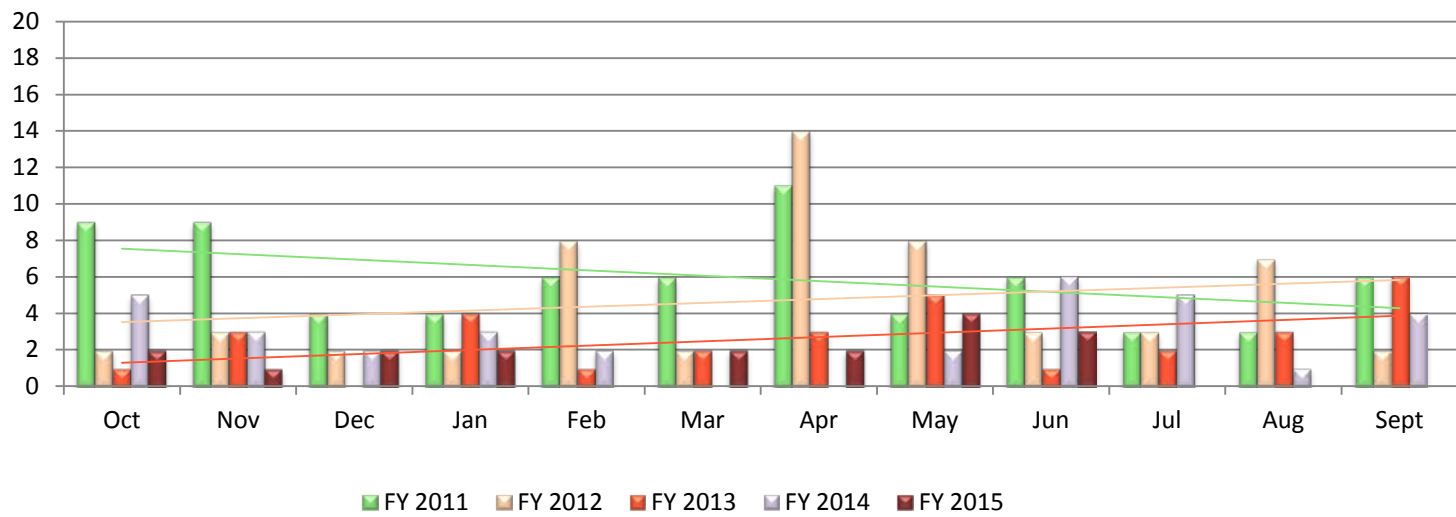

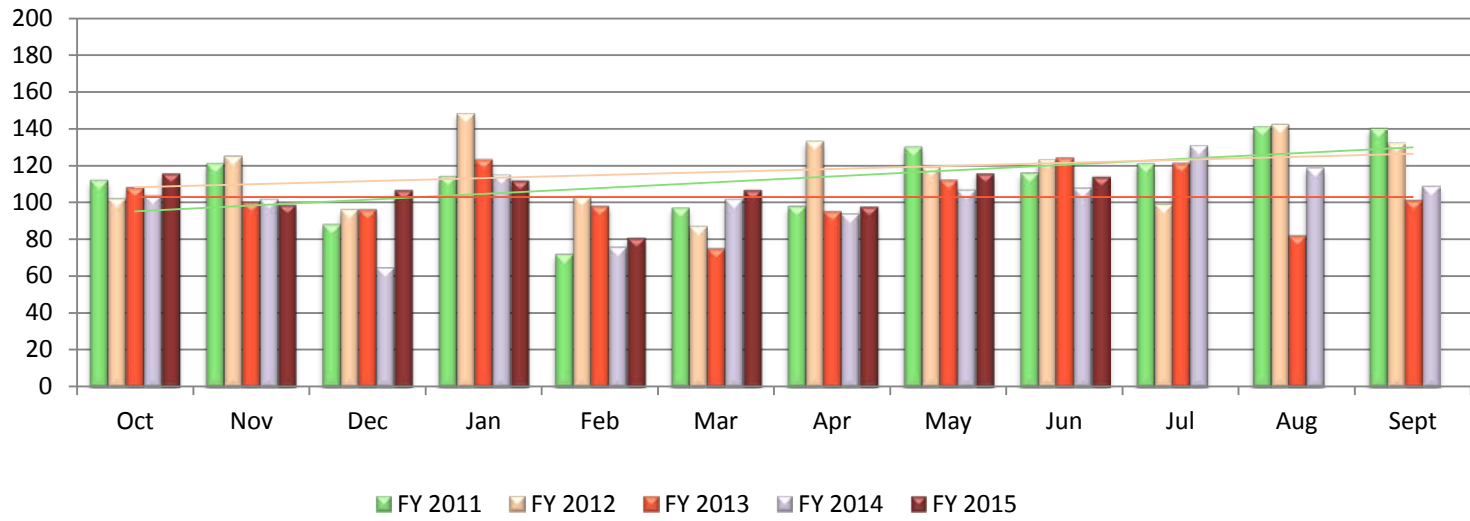

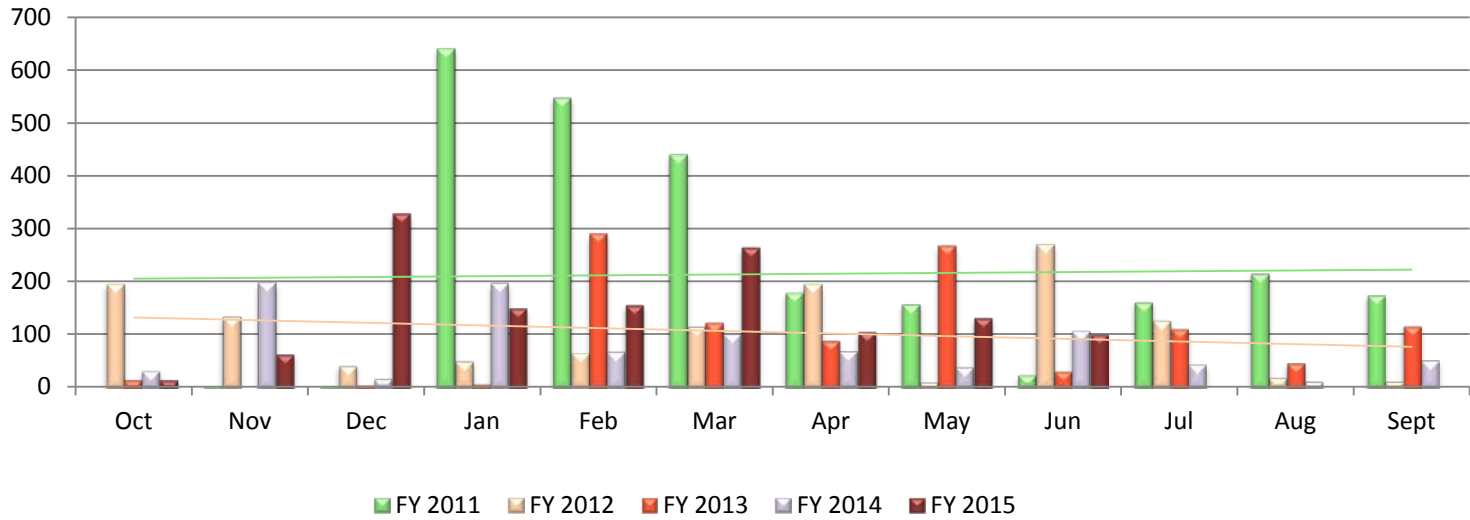

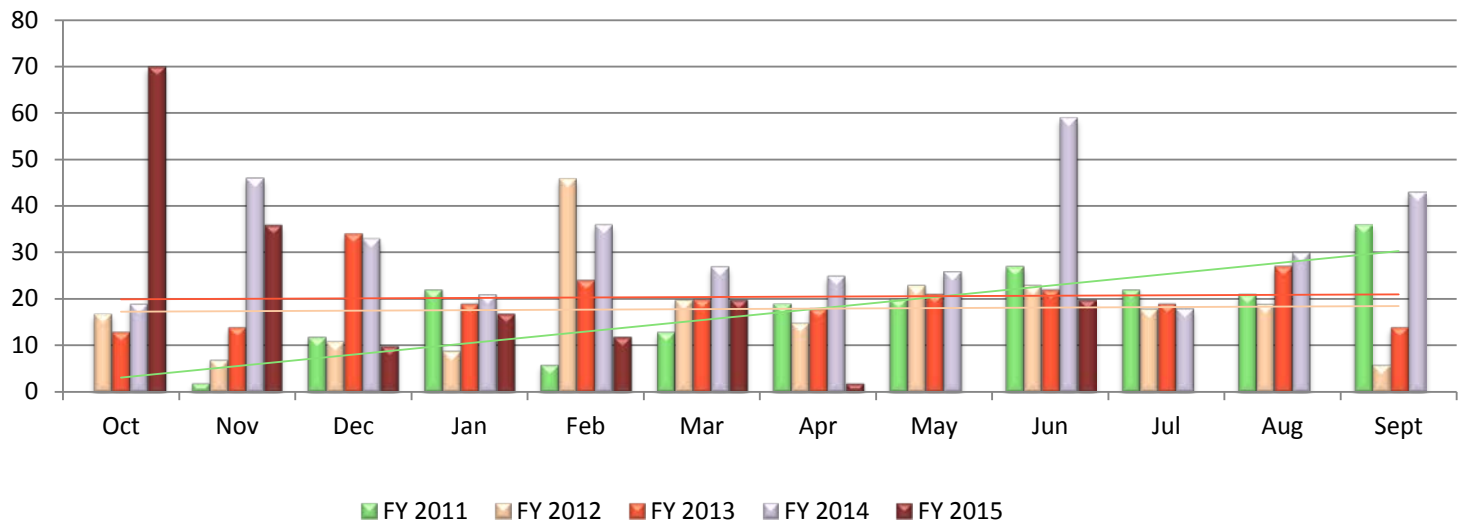

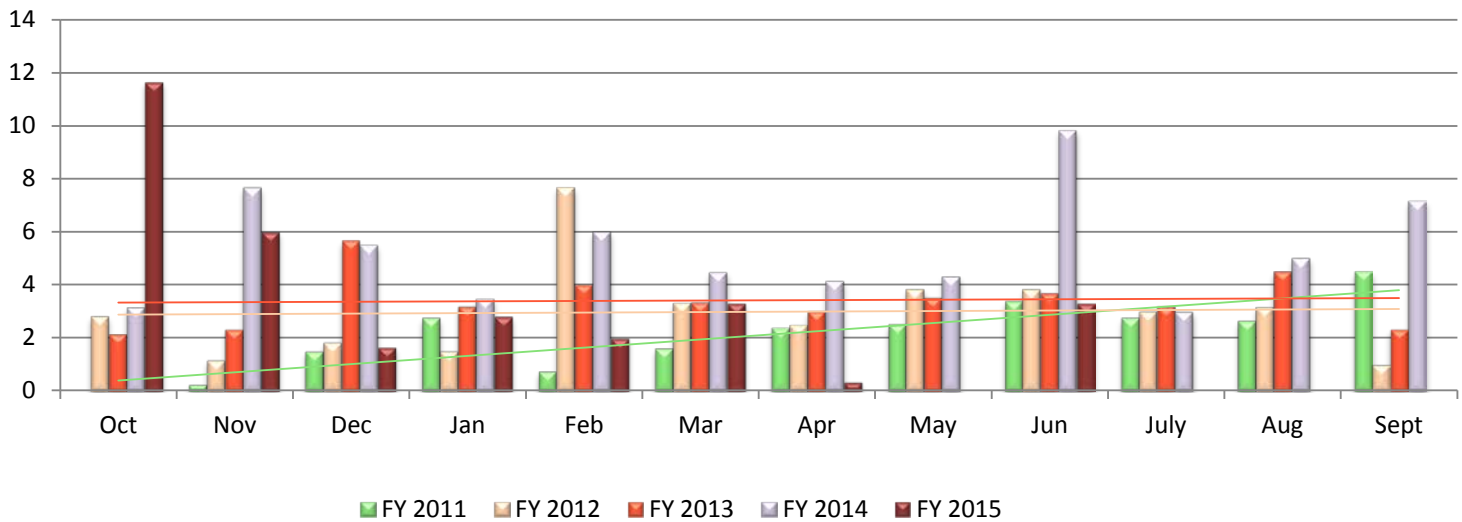

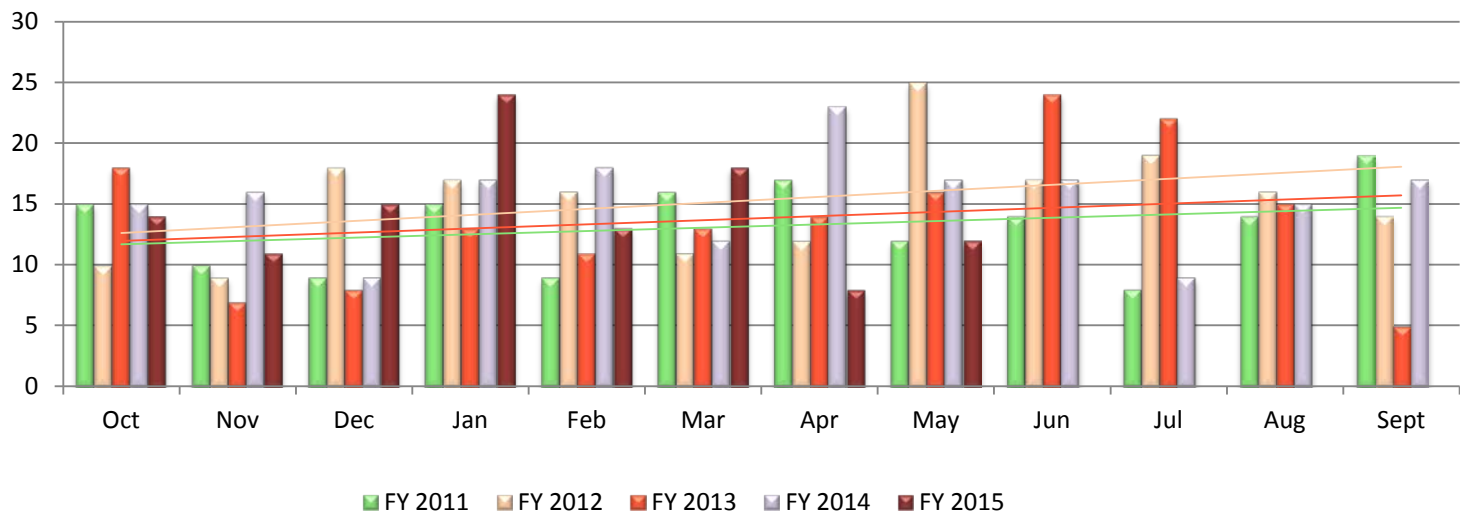
Constable Pct. 1 - Warrants Served per Deputy

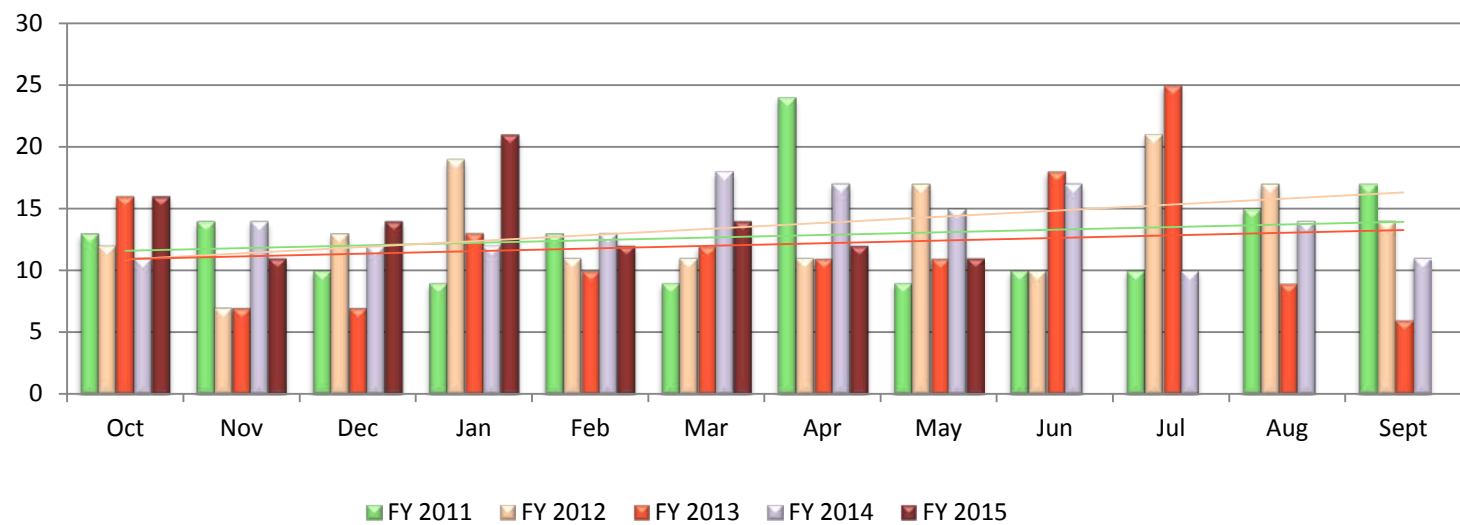

Constable Pct. 1 - Writ of Possession Received



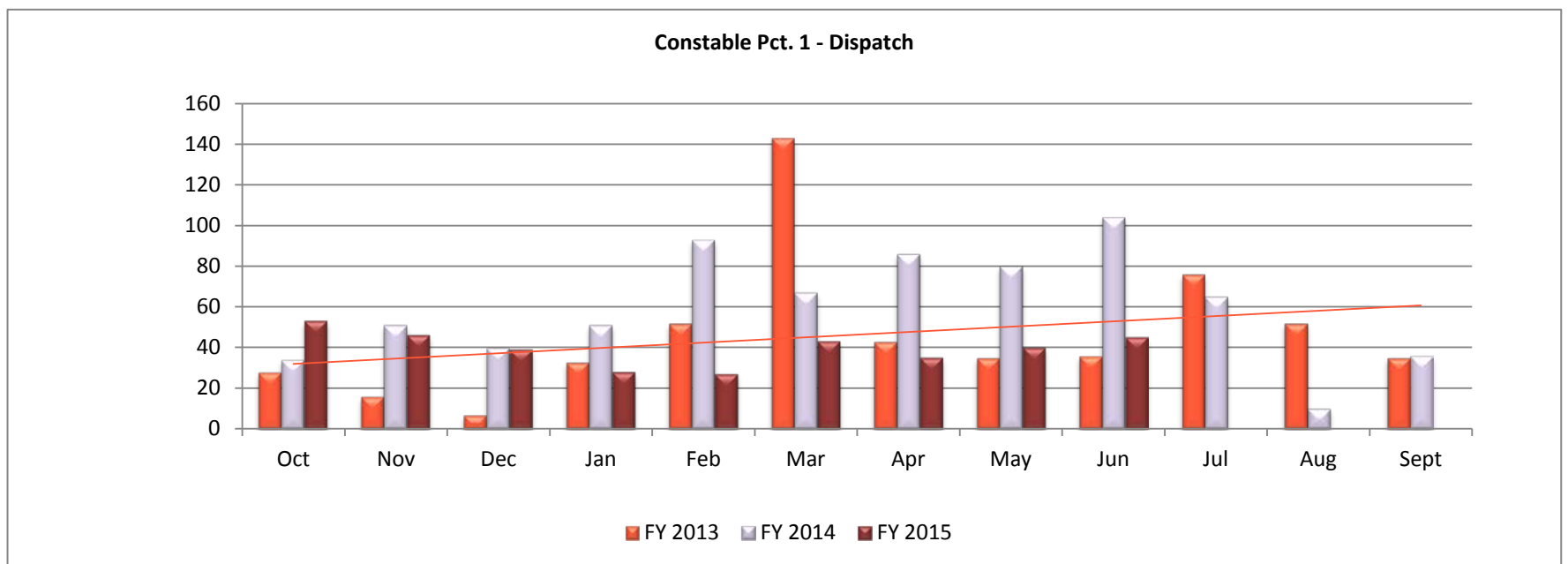
