Felony Cases Received from Agency**



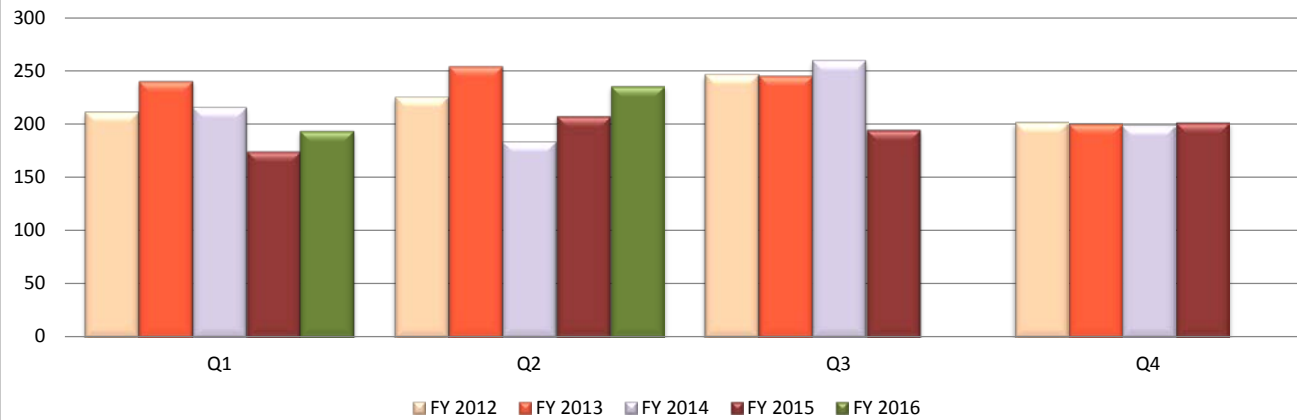
