Constable Pct. 4 - Papers Served per Deputy



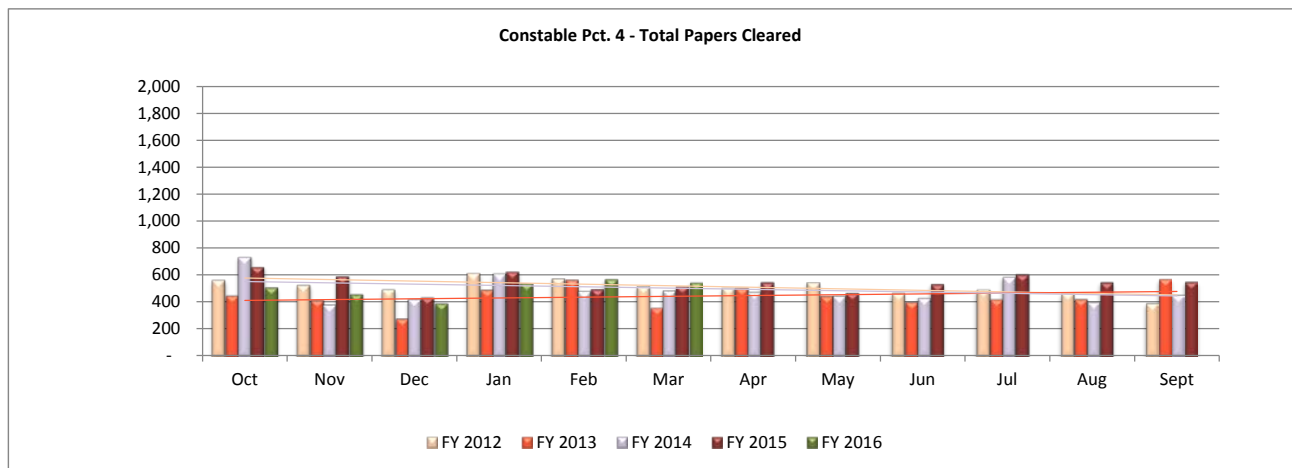

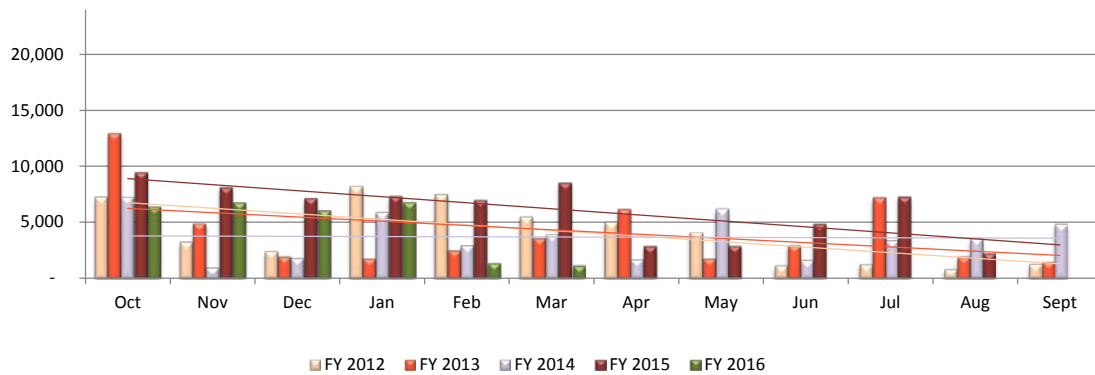

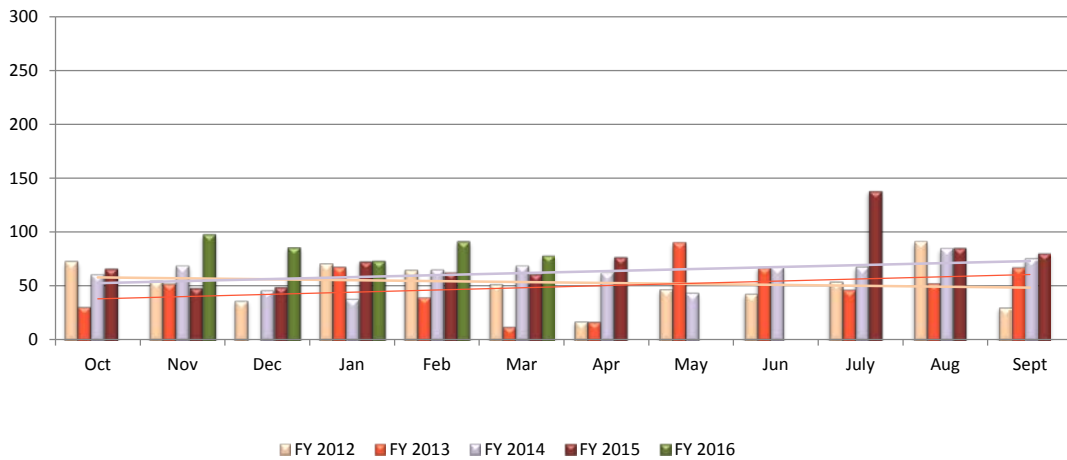
Constable Pct. 4 - Miles Driven

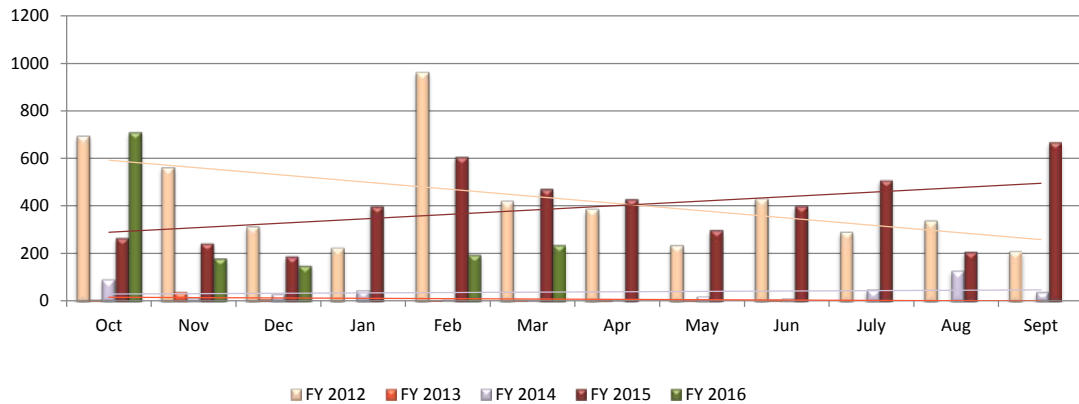

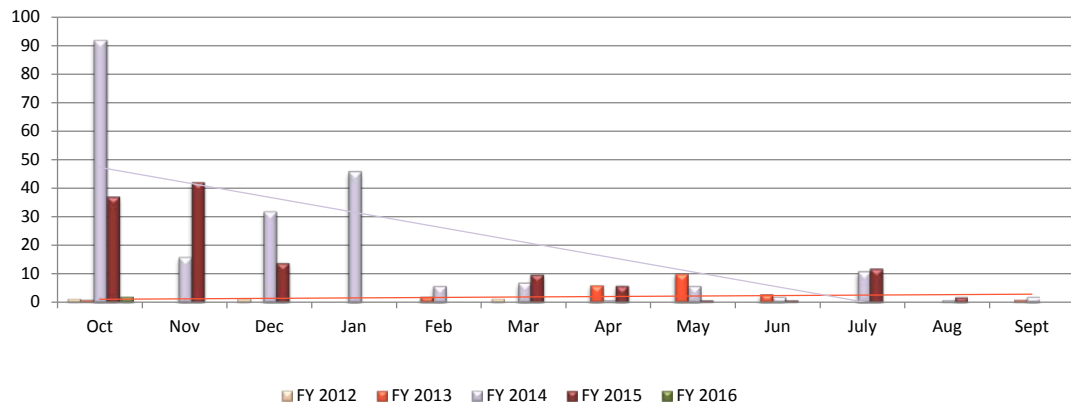

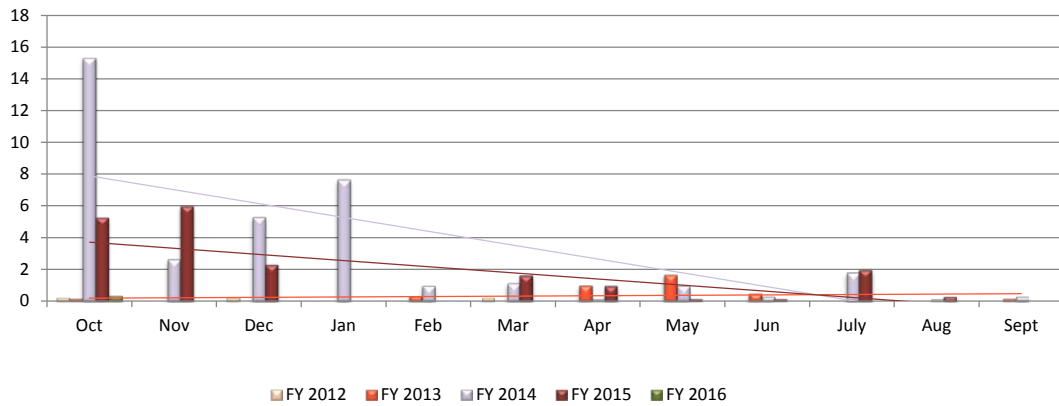

Constable Pct. 4 - Warrants Served



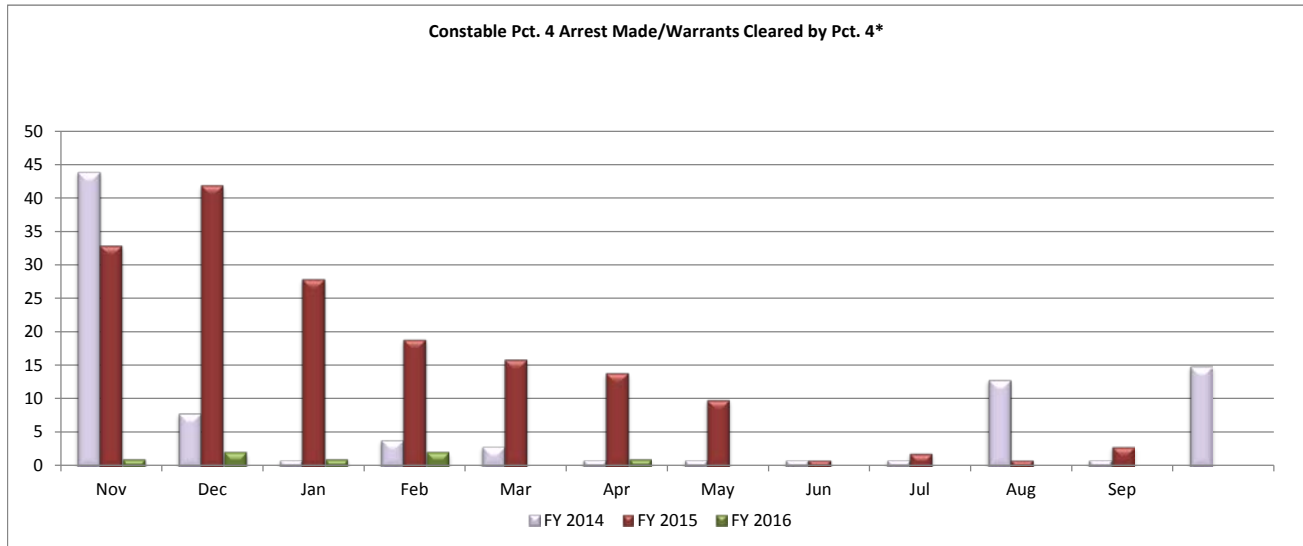
