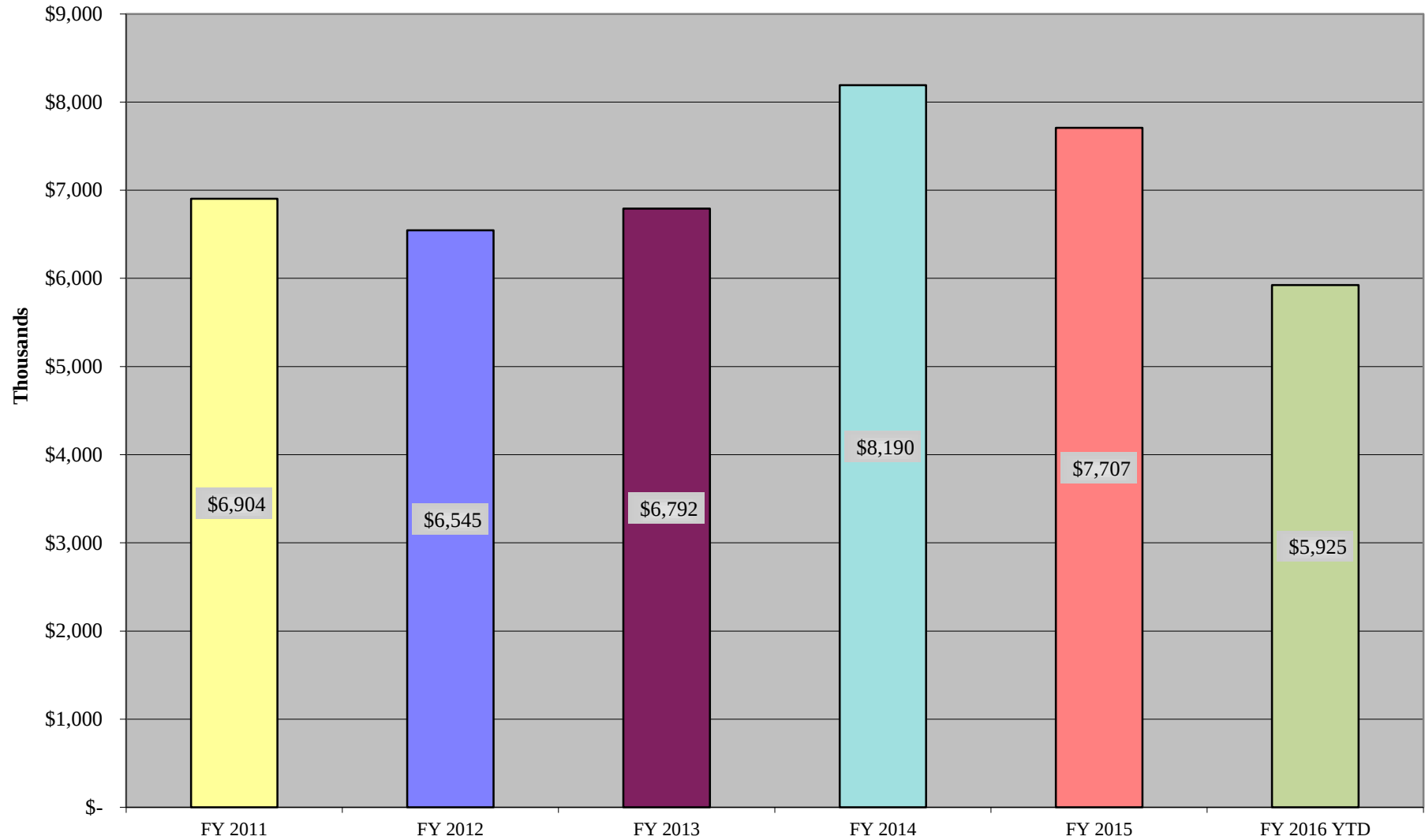

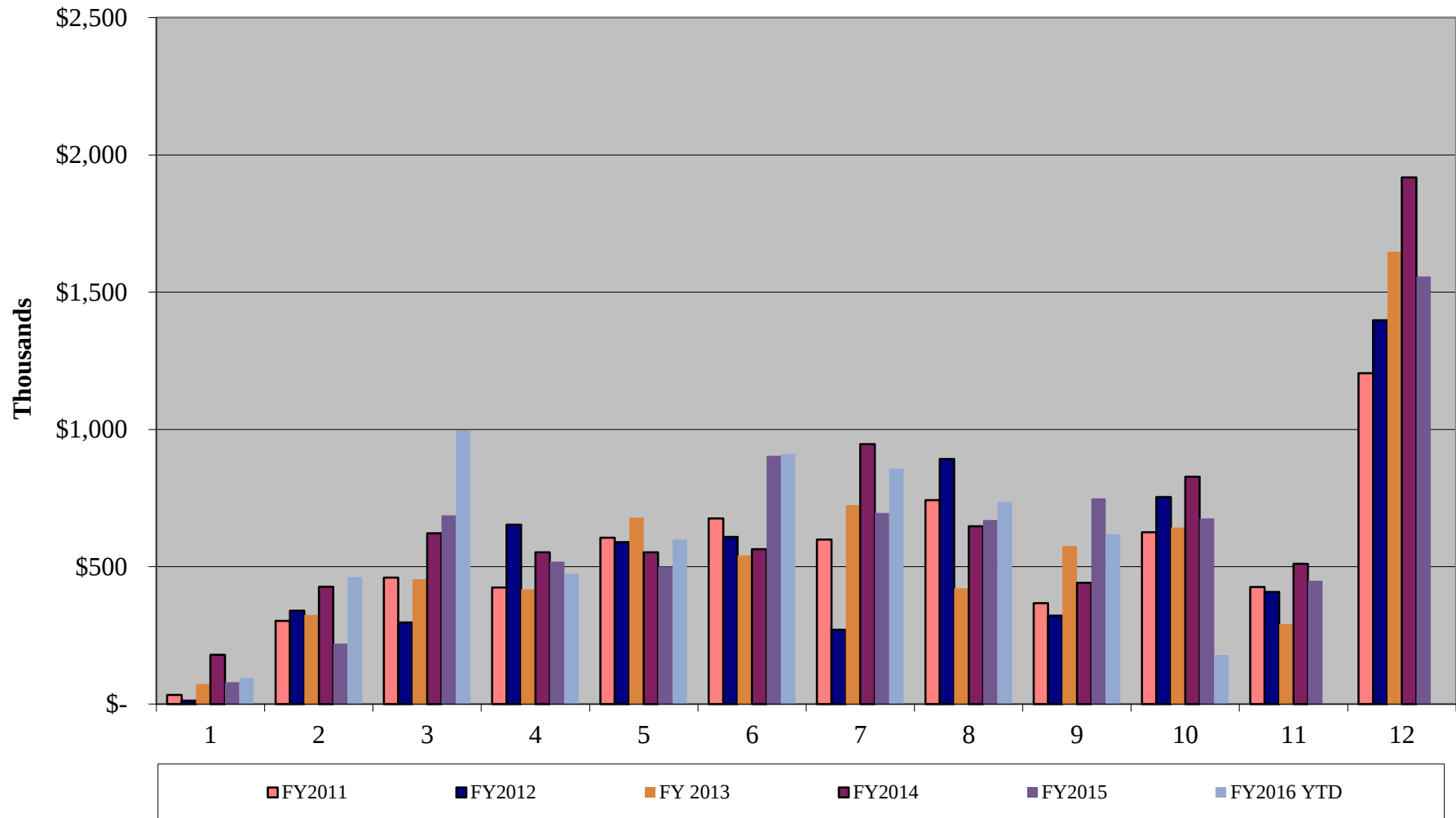

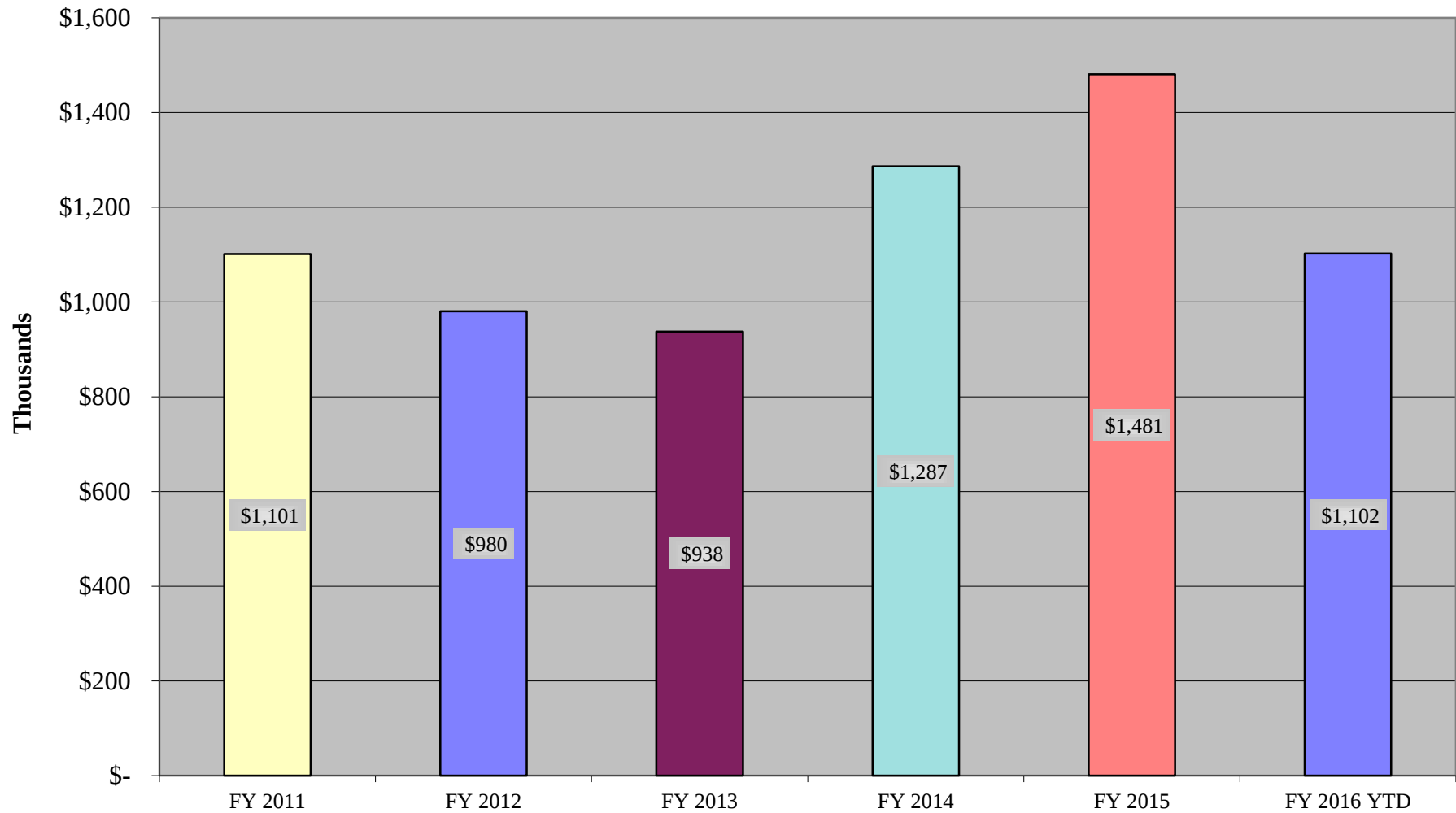
Indigent Defense Expenditures by Month (All Courts)

As of July 1, 2016

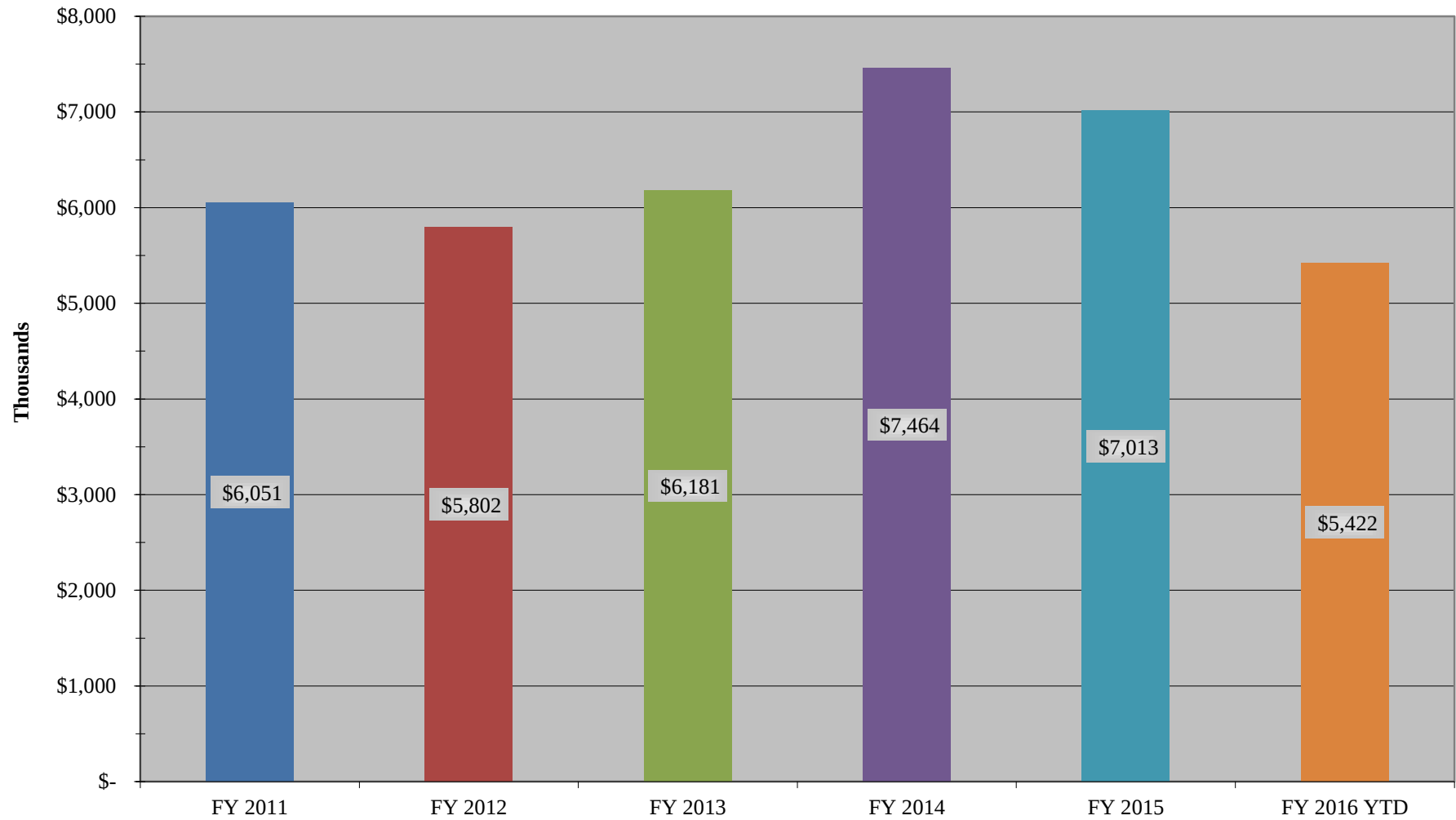

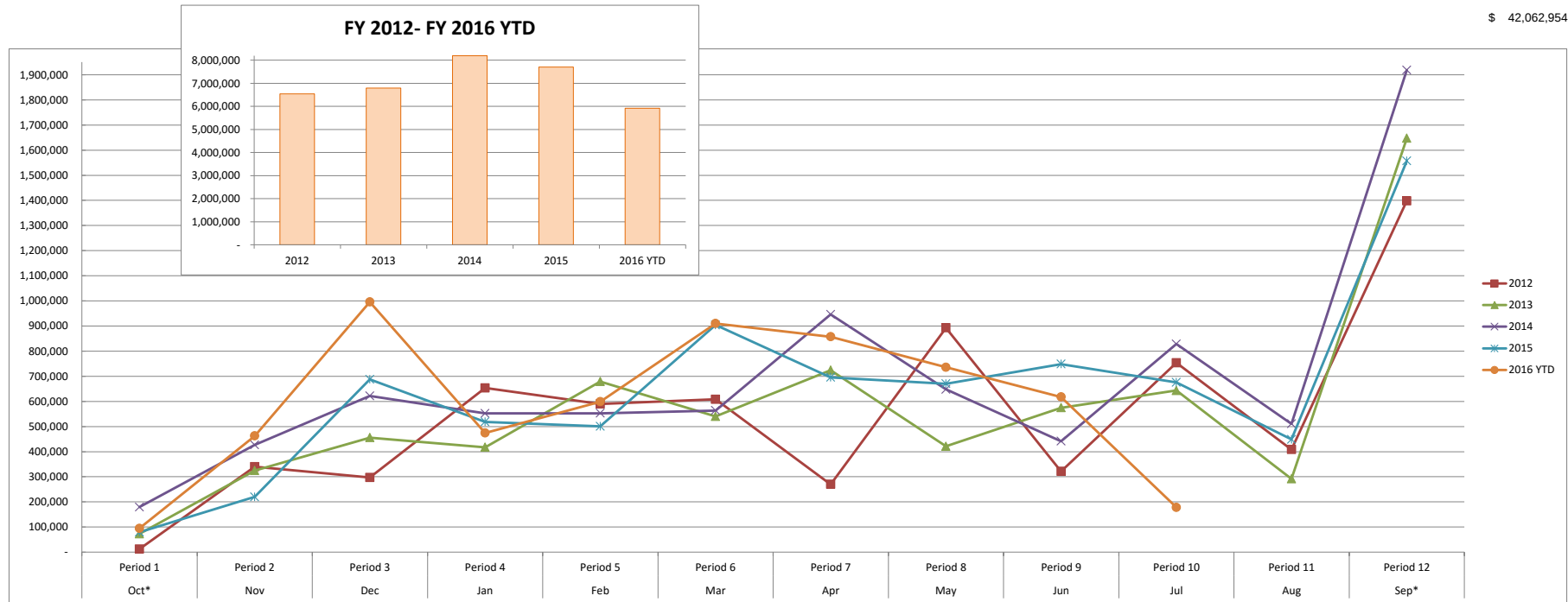

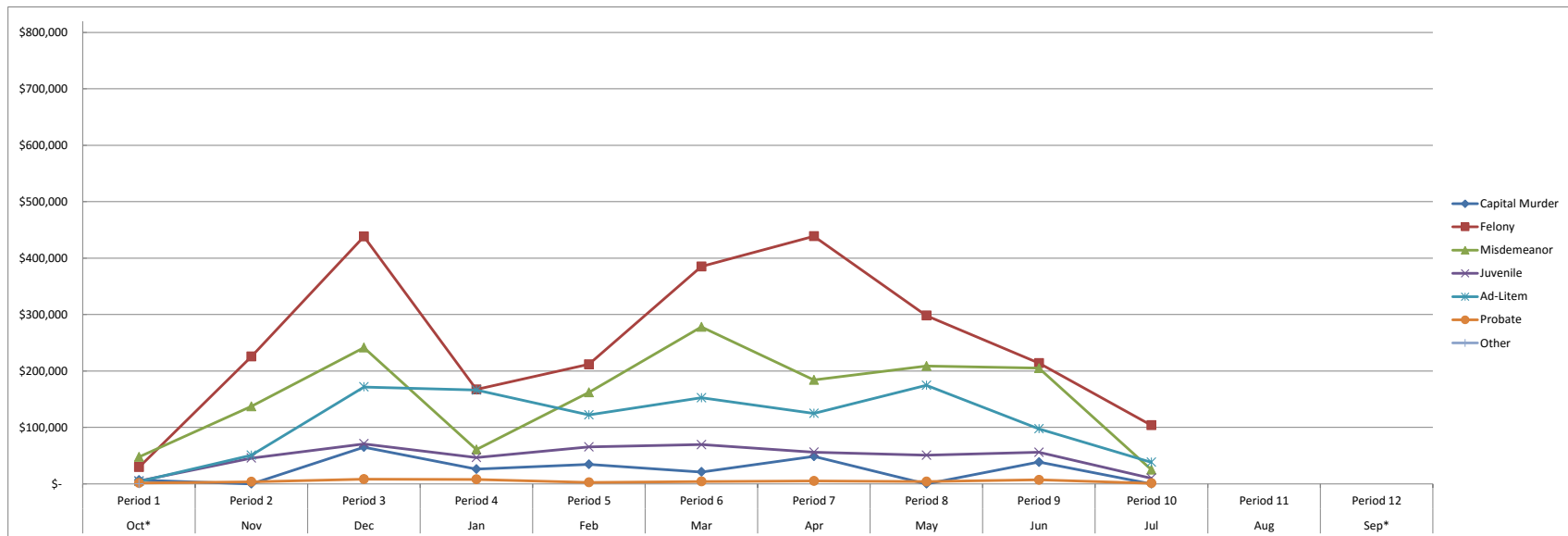
