

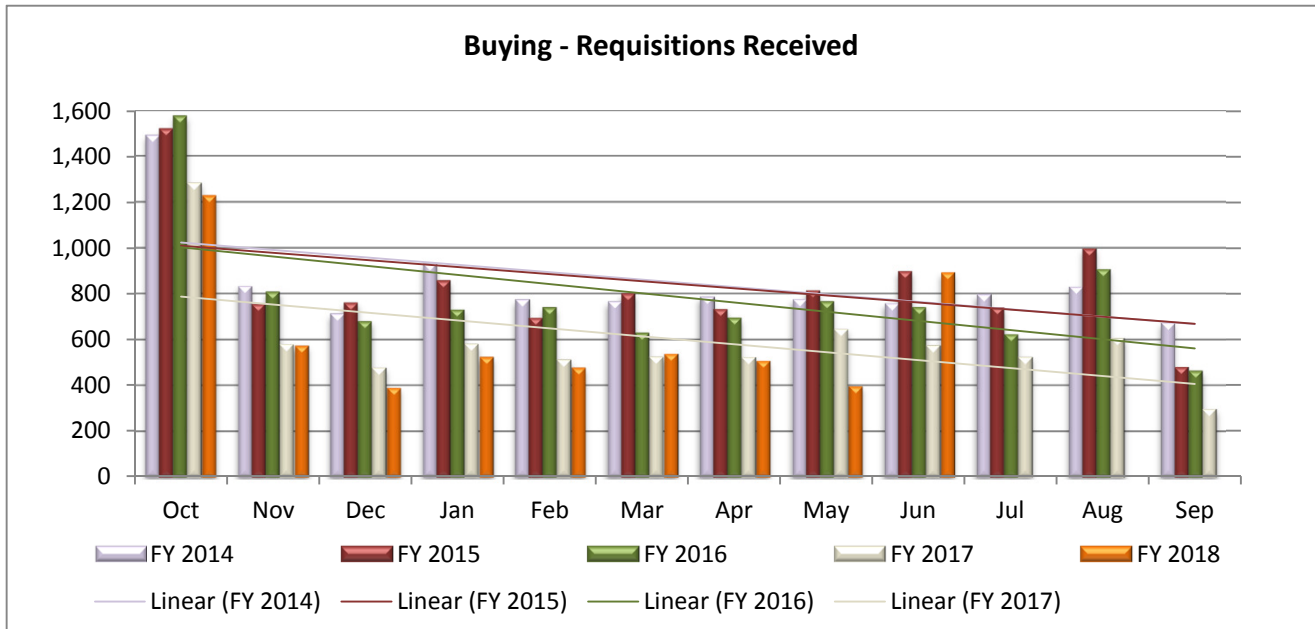

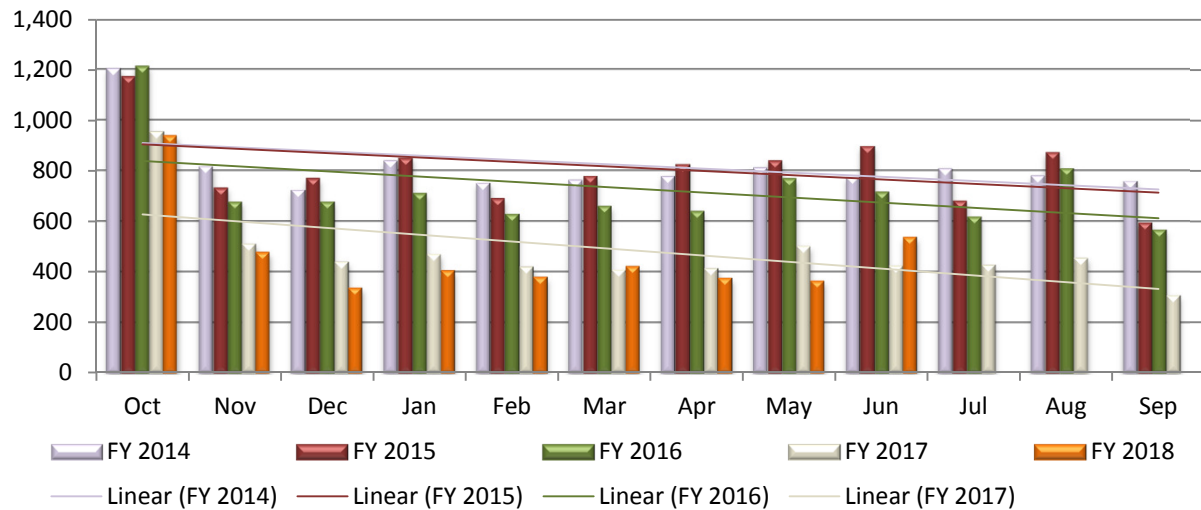

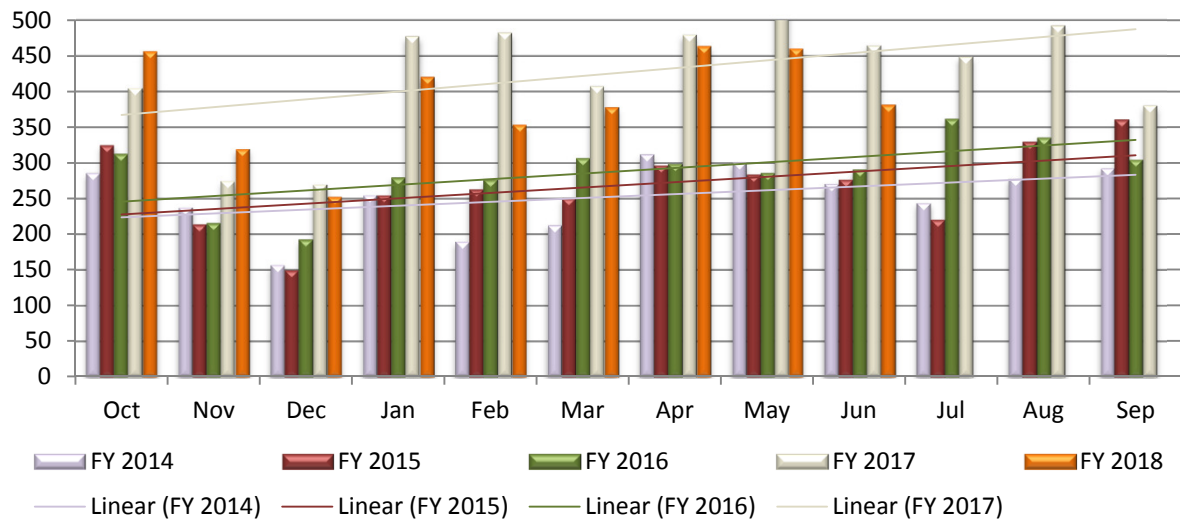

Buying - Purchasing Card Transactions



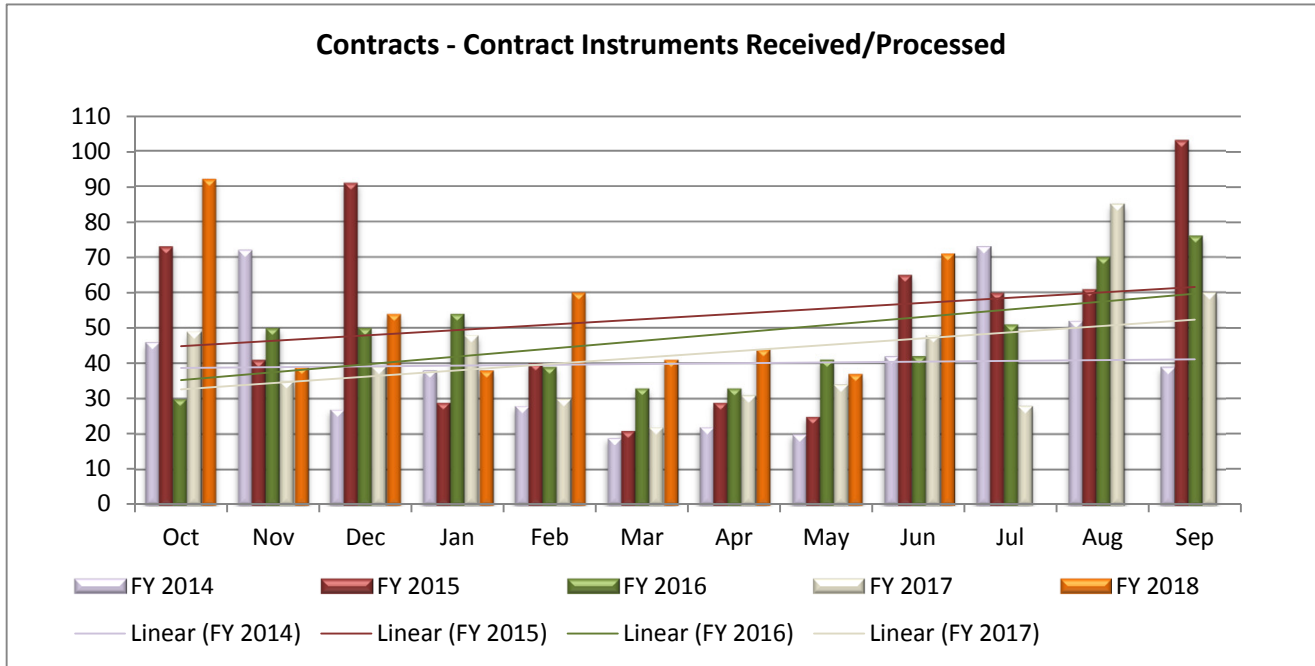

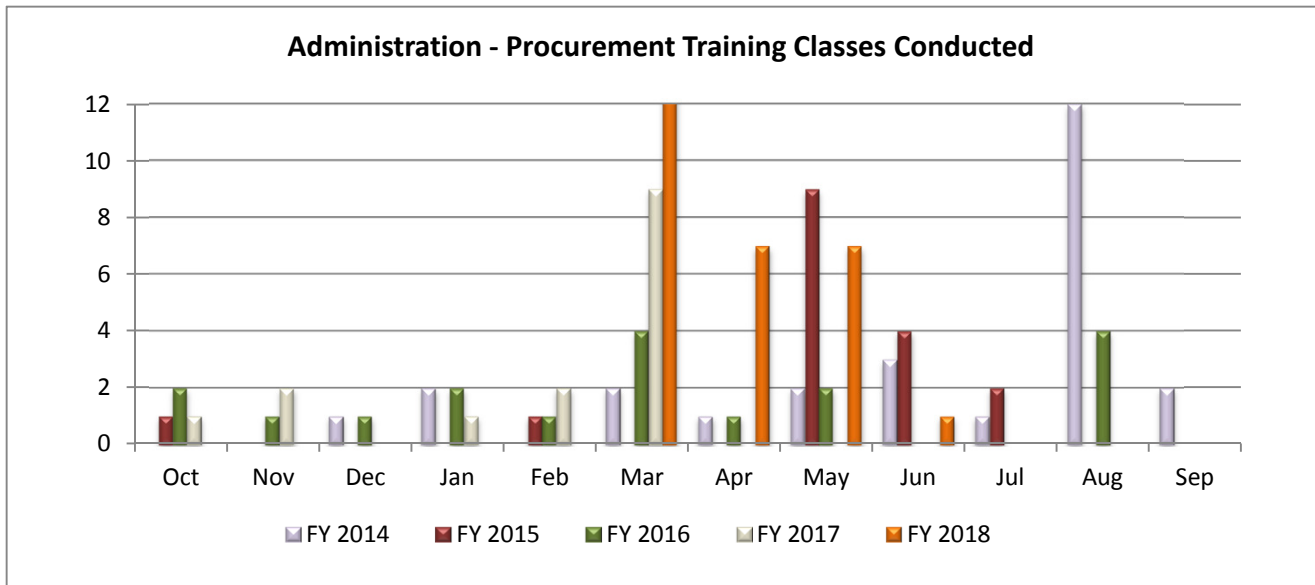

- Provide cost avoidance through competitive processes



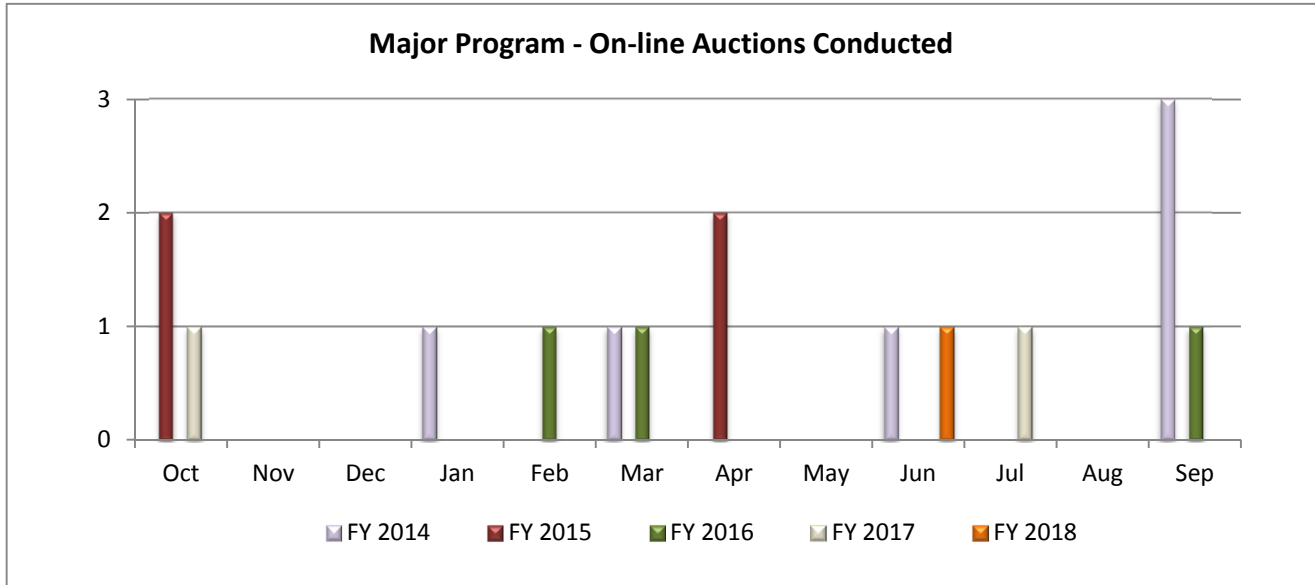
