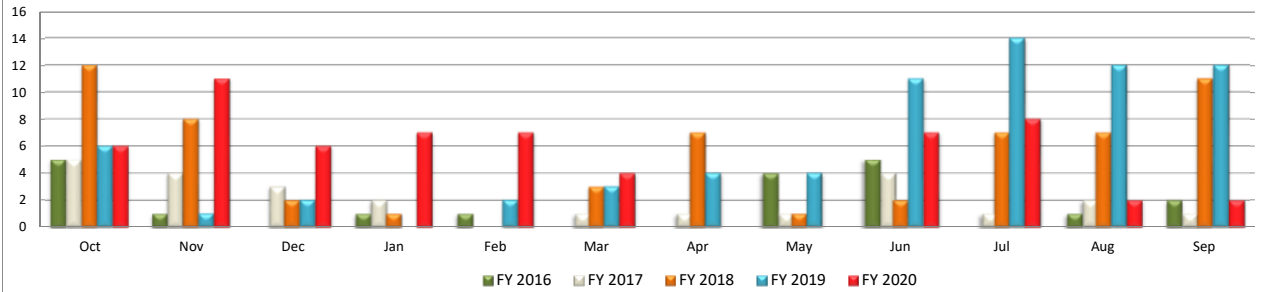

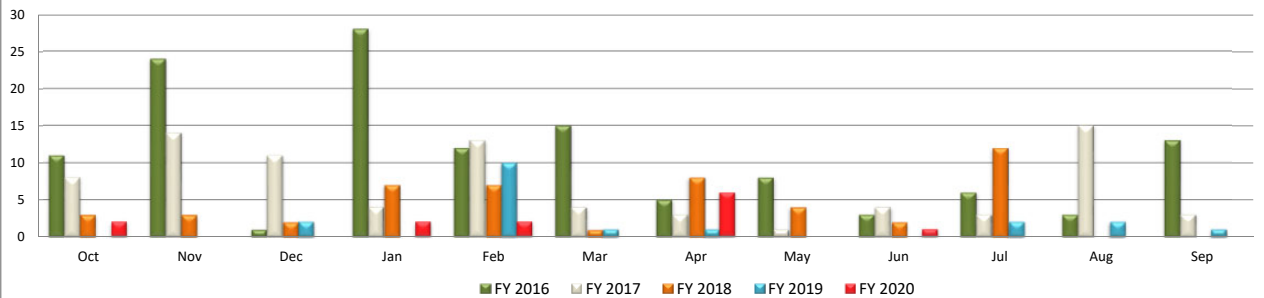

JP 3-1 Cases Appealed



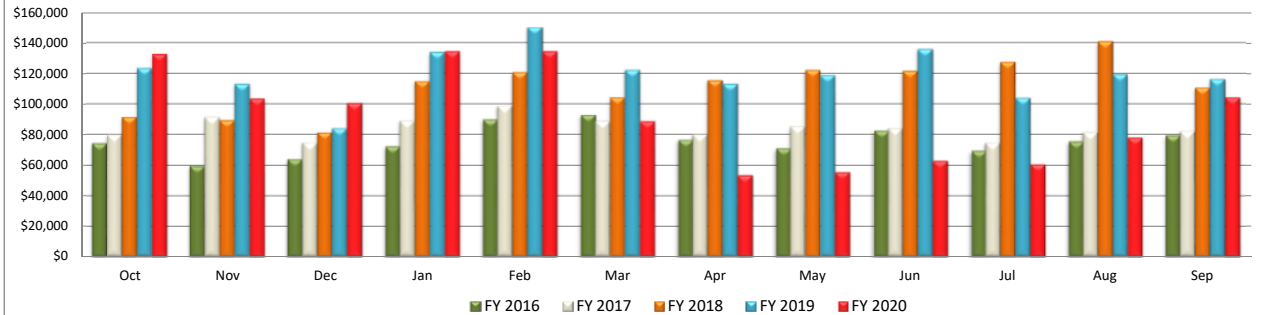

JP 3-1 Arrest Warrants Issued



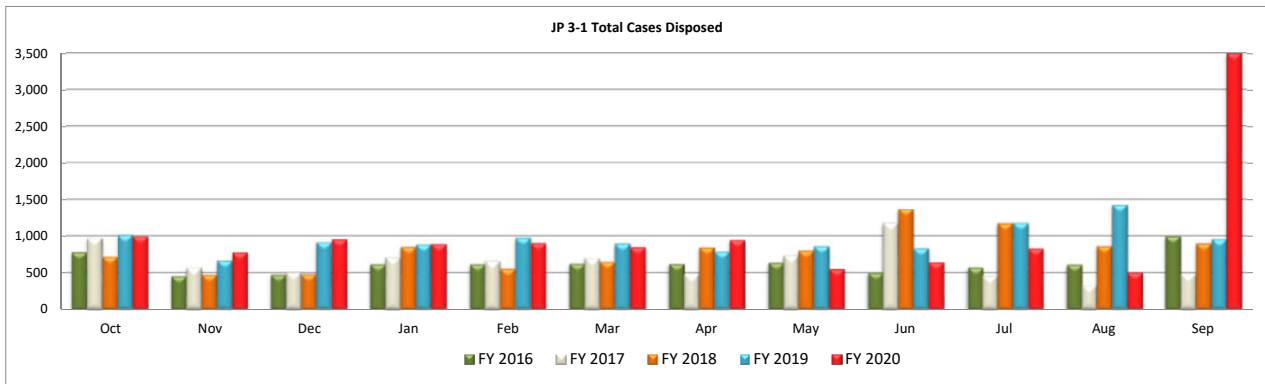
