


CIVIL CASES, CRIMINAL CASES, JUVENILE CASES

Description of measures as reported from District Clerk's Office - Odyssey Software System.


FY 2021 Goals & Objectives


District Courts - Total New Civil Cases Disposed by Court





District Courts - Total New Criminal Cases Disposed by Court




