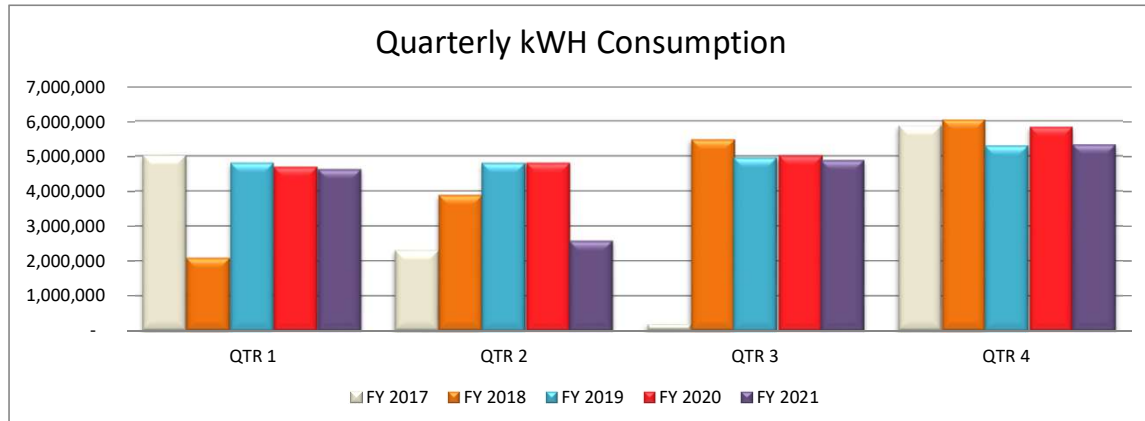
UTILITY USAGE/COSTS

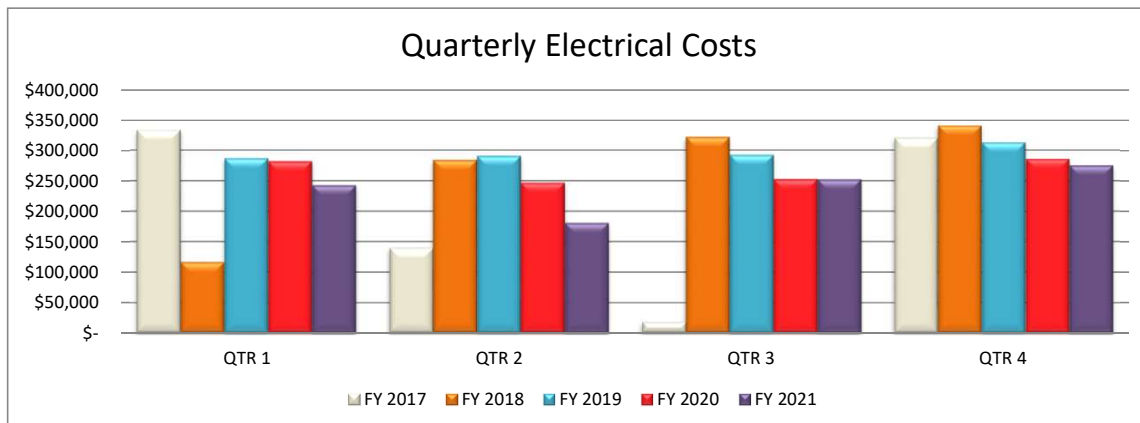

- Cut energy usage by 5% annually for a ten year period, beginning September 1, 2011. Monitoring of electrical metering system.



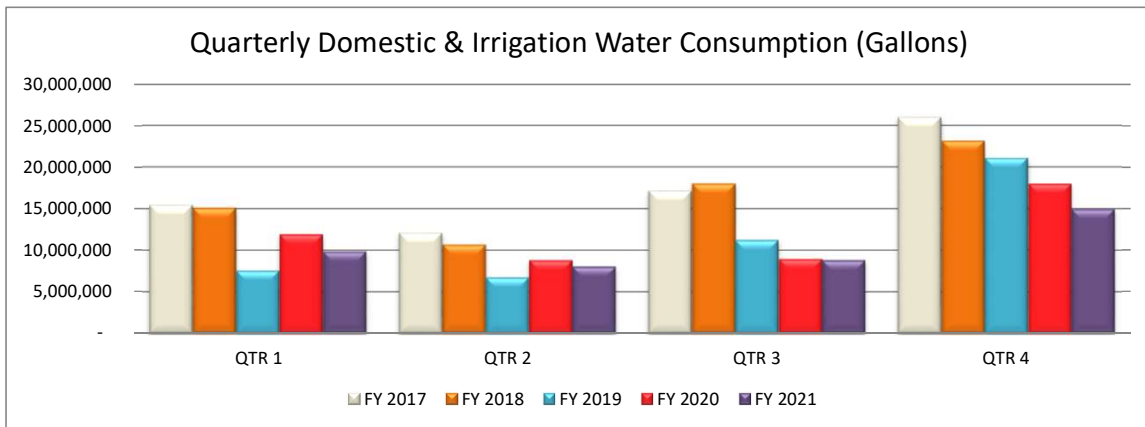

Number of Access Changes**



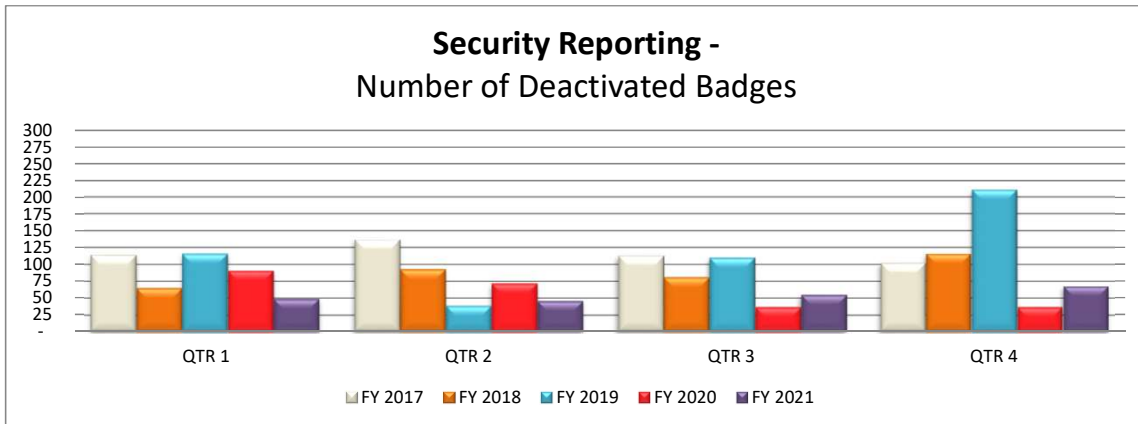
