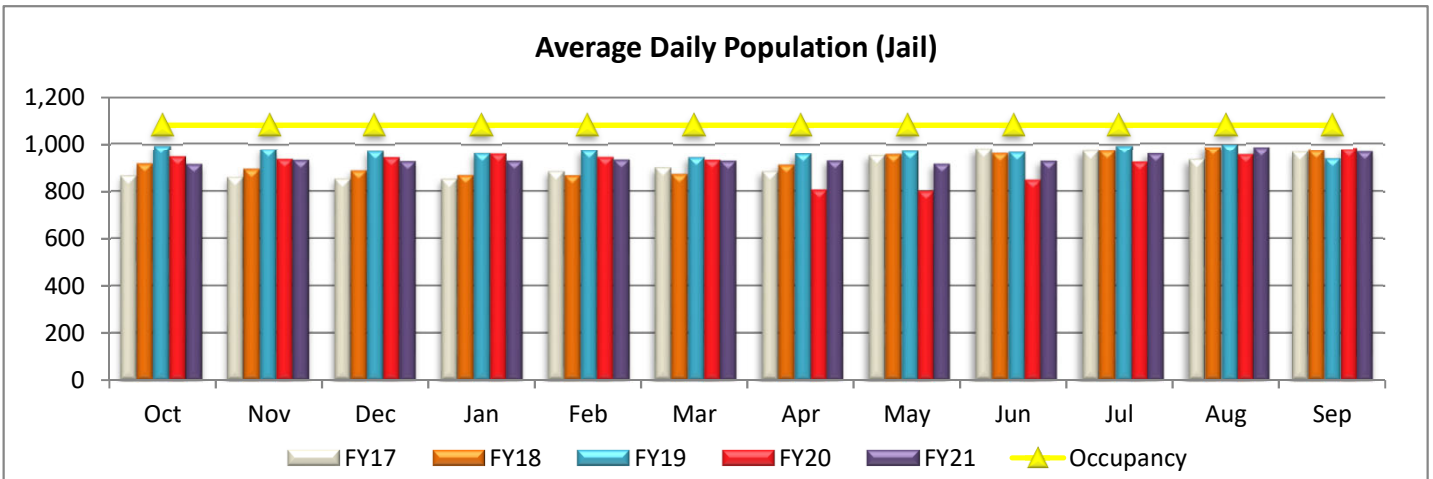

Detention Operations

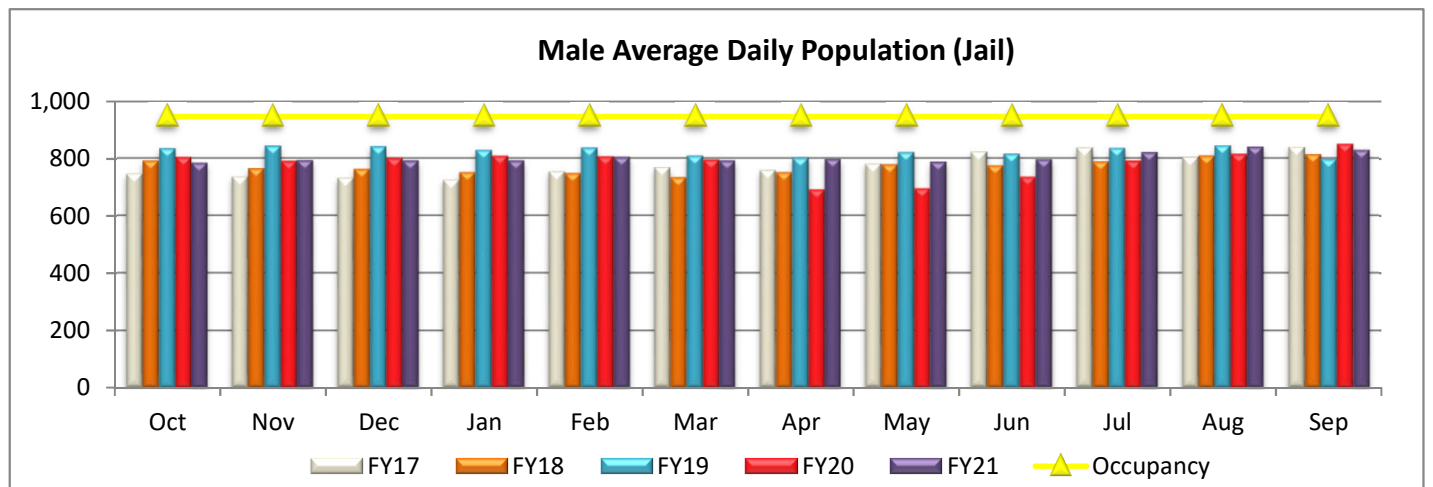

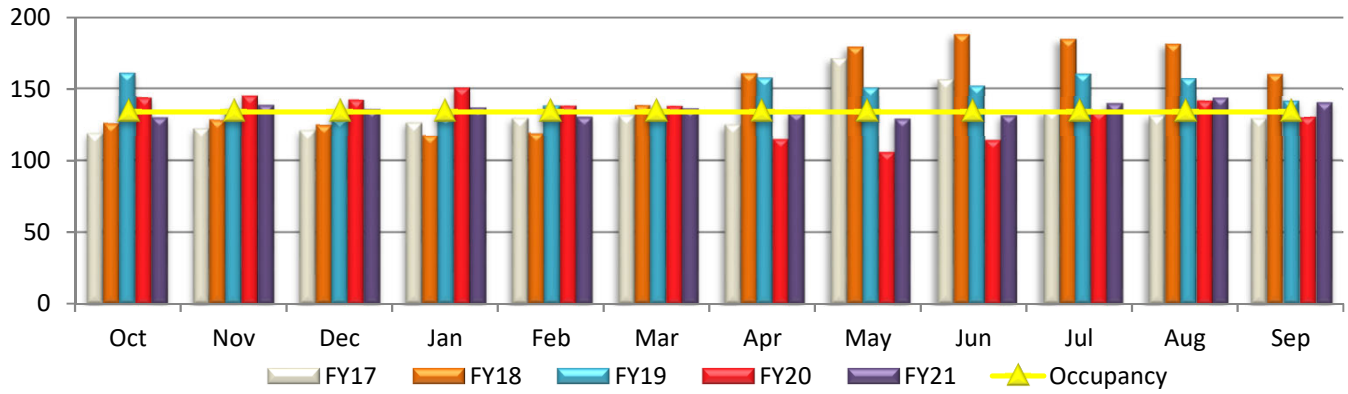

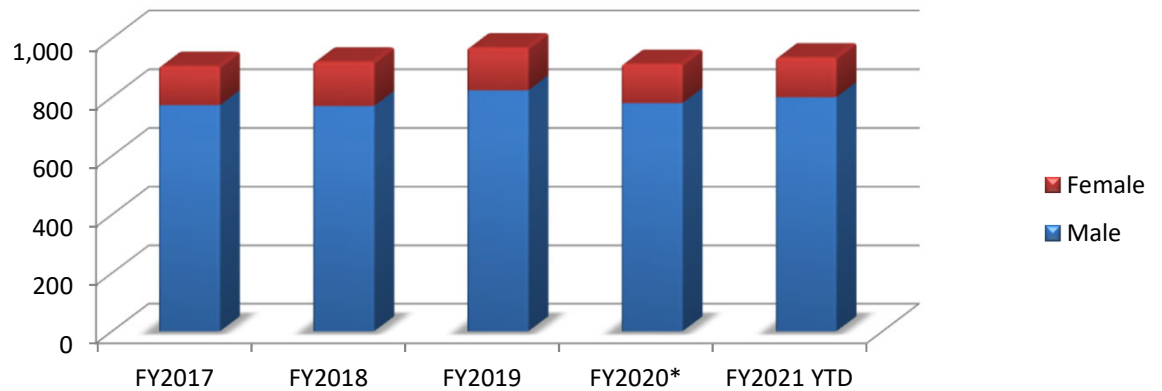
Female Average Daily Population (Jail)

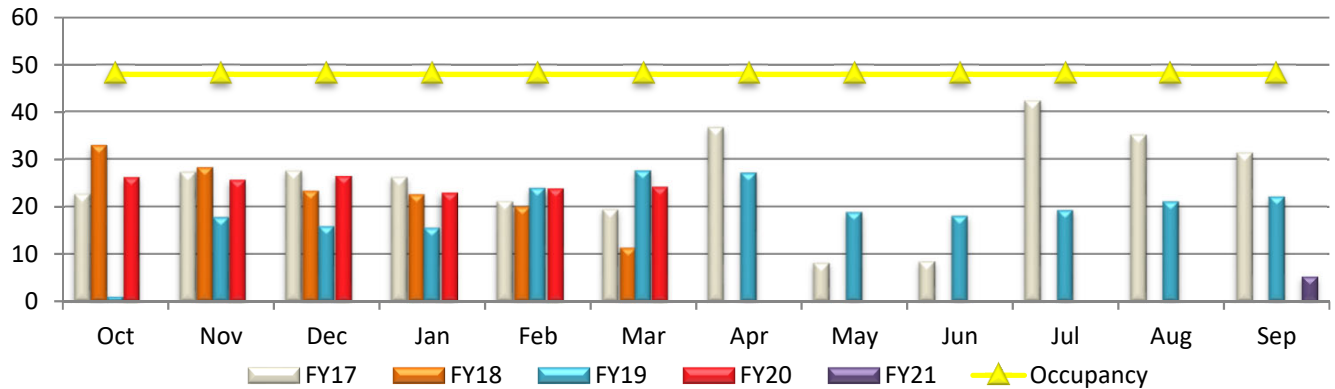

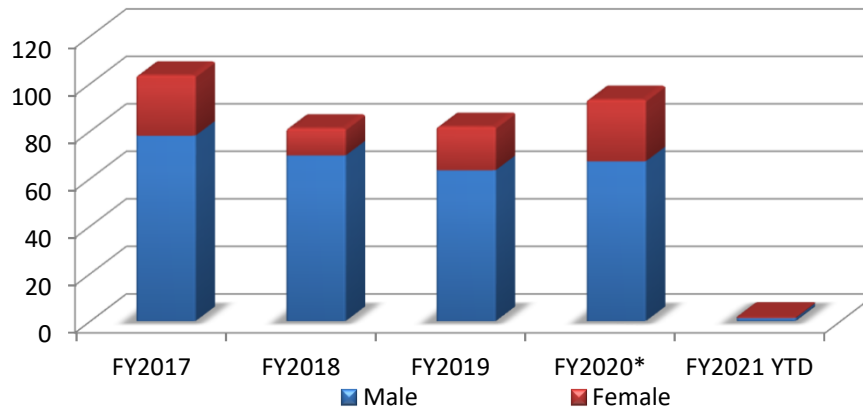

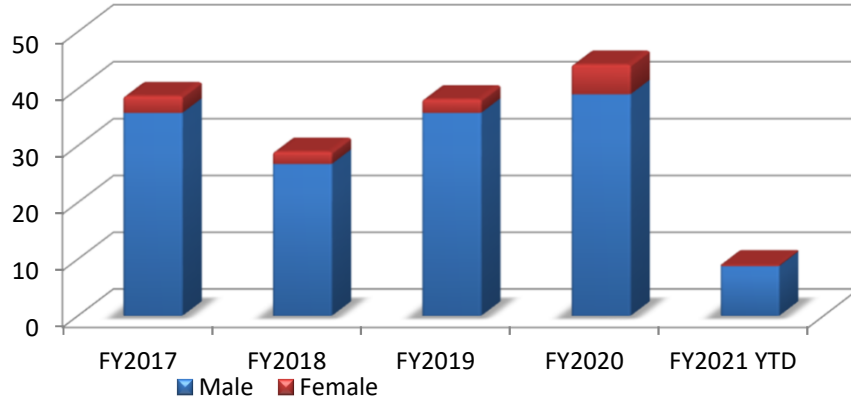

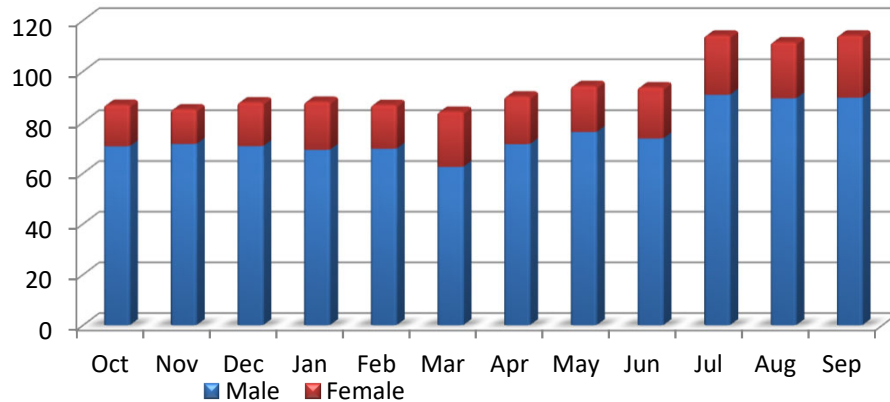

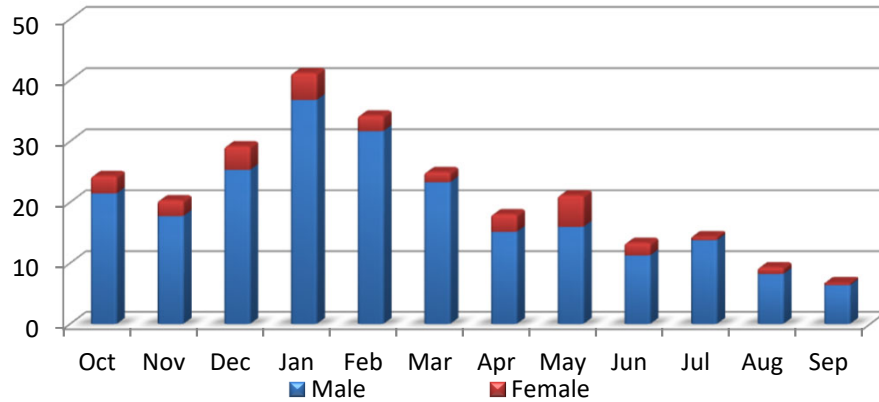
Annual Average Daily Population (Mental Health Holds)

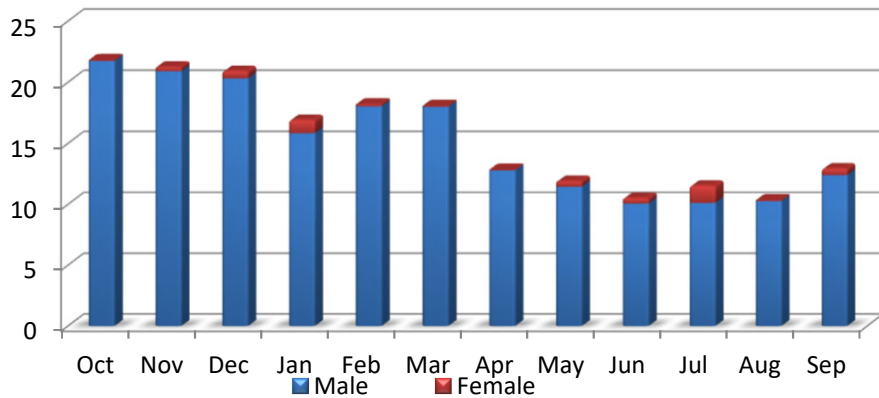

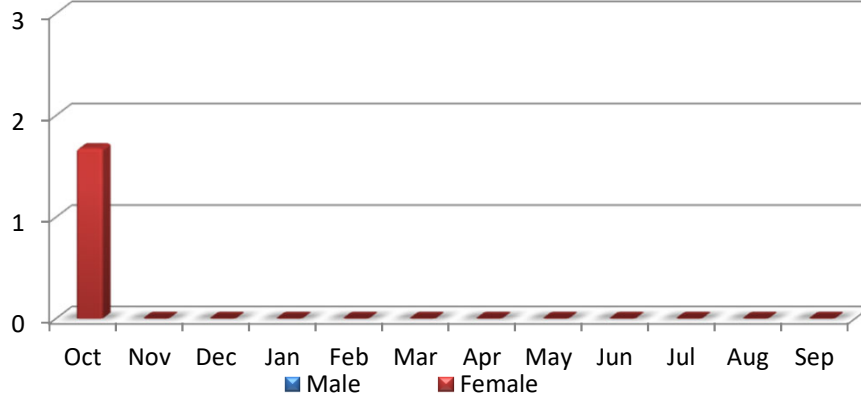
Annual Average Daily Population (Separation)
