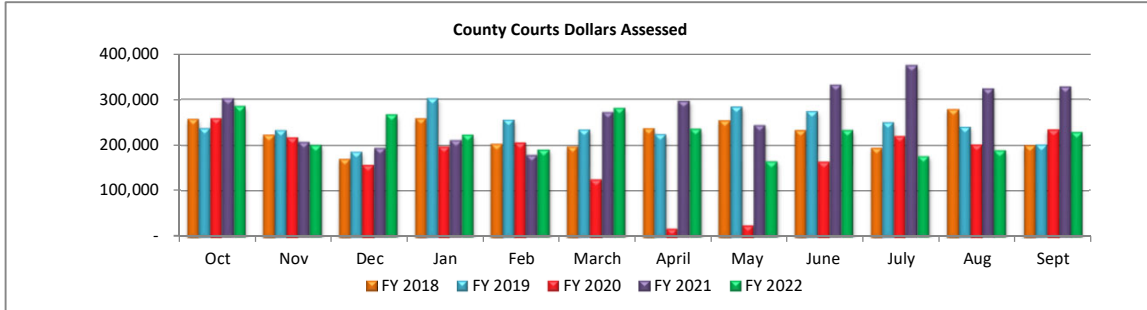
Criminal Court Collections

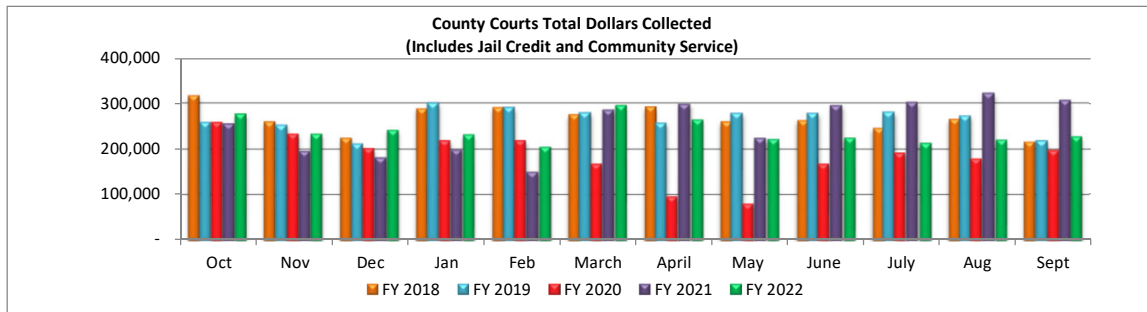

FY 2022 Goals & Objectives

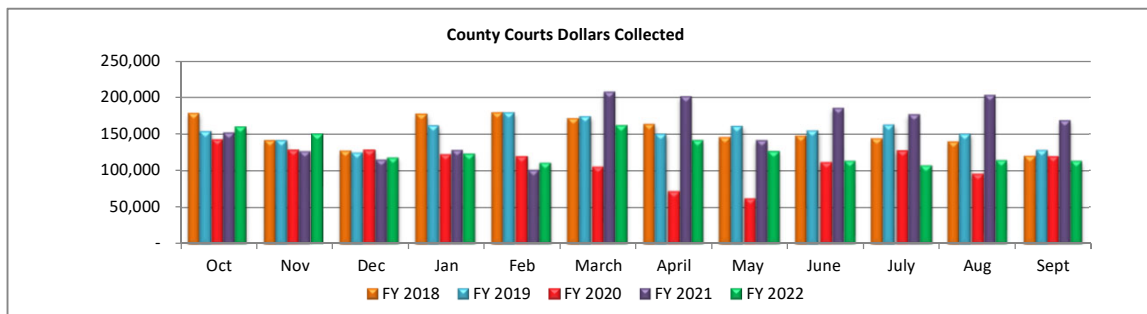
Improve the collection of court costs, fines and fees related to misdemeanor convictions for Collin County.
