
Thank you for letting us help Collin County collect its delinquent property taxes this last quarter. This memorandum provides you with information about changes in your delinquent tax roll made during the July, 2021 through June, 2022 time period. This information is based on data provided to us by the Collin County Tax Office on July 7, 2022, and other internal account data maintained by our office.

COLLECTION OF DELINQUENT 2021 TAXES: FEBRUARY THROUGH JUNE, 2022

On February 1, 2022 there were 26,637 accounts owing 2021 taxes in the amount of \$8,357,541.05 (base levy only) that became delinquent. We are pleased to report that by the end of June 17,057 of those accounts had either no balance due or a decreased balance, reflecting a decrease of \$7,233,682.39, or 86.58%.

The remaining delinquencies have been rolled into our delinquent tax roll as of July 1, 2022 for further analysis and possible litigation. For reference, the July 2022 delinquent tax roll as compared to the July 2021 delinquent tax roll is as follows:
