



Minutes, March 2, 2017**

**1. Call Meeting to Order**

Chairman Bill Cox called the meeting to order at 7:05 p.m. at the NTTA Safety Operations Center, Plano, Texas. The following members were present: Bill Cox (Chair), Buddy Dean, Shep Stahel, Bill Moore, Rusty Glover, Joe Helmberger, Don Thoes, Mark Reid, and Bill Mills. The following members were not present: Sean Merrell, Steven Wright, Z Marshall, and John Muns. Collin County staff present: Clarence Daugherty and Teresa Nelson. Guests: Elizabeth Mow and Eric Hemphill with NTTA, and grandson of Shep Stahel.

**2. Approval of February 2, 2017, Minutes**

Shep made a motion to approve, second by Mark, which passed with a unanimous approval.

**3. Update regarding 2017 Transportation Bond Program**

Shep informed the board members that the sub-committee held the 'transportation summit' on March 1. This initial meeting was for the leaders of the Collin County municipalities to inform them of the upcoming bond program with the funds to be used toward limited access roadways (LARs). Three different sessions were provided with attendance being mediocre yet good representation. Shep stated Clarence did a good job fielding a number of questions/comments. The cities were provided a 'model' resolution to present to their council members to seek support of the bond issue. Members of the court were also represented by County Judge Keith Self, Commissioner Chris Hill, and Commissioner Duncan Webb. Bill Moore said this was the beginning of the process and to expect more work to do.

**5. Adjourn to tour of NTTA Operations Center**

Elizabeth Mow, Assistant Executive Director of Infrastructure and Eric Hemphill, Director of Systems and Incident Management served as the hosts on behalf of NTTA. Elizabeth provided an audio visual presentation of interesting facts about their operations. The members of the board then were able to tour the operations center and were able to observe personnel perform some of their responsibilities like providing assistance to a stranded motorist during our visit. Eric stressed NTTA offers free roadside assistance along their toll roads. #NTTAKnows safety.

The business meeting adjourned at 8:15 p.m.
