Minutes, October 5, 2017**

**1. Call Meeting to Order**

Chairman Bill Cox called the meeting to order at 7:00 p.m. at the Collin County Jack Hatchell Administration Building, Commissioners Court Room, McKinney, Texas. The following members were present: Bill Cox (Chair), Buddy Dean, Shep Stahel, Bill Moore, Steve Wright, Gerald Vokolek, Don Thoes, Mark Reid, and Sean Merrell. The following members were not present: Z Marshall, Rusty Glover, Joe Helmberger, Bill Mills, Steve Terrell, and John Muns. Collin County staff present: Clarence Daugherty and Teresa Nelson. Guests: none.

**2. Approval of June 1, 2017, Minutes**

Shep made a motion to approve, second by Buddy, which passed with a unanimous approval.

**3. Update regarding Transportation**

Clarence provided an audio-visual presentation and addressed the following:

**a) Bond program/budget funding**

Through his presentation Clarence informed the board of the various projects being considered and that \$87 million was needed for projects. He advised that the court decided June 26, to not entertain a bond program at this time, and any monies needed would be funded from surplus via the budget. Clarence further provided 2018 needs approved in budget totaling \$38 million. Gerald asked "how much surplus remains?" Clarence responded roughly \$100 million, enough to maintain good bond rate. Bill Moore asked "for other dollar amounts on chart, how are these funded?" Clarence responded good question, but typically via a bond. Mark commented about the surplus for US75, and Clarence stated some had been moved to cover other expenses.

**b) County studies – new models, update thoroughfare plan**

Clarence stated that Jacobs is to perform additional modeling on the east side of county, such as Outer Loop as a freeway using buildout at 2.1 million vs. 3.4 million.

**c) COG and TxDOT freeway studies**

Clarence presented a slide regarding the three north/south roadways in eastern Collin County. The roadways in gold noted relief if a freeway goes across the lake, but still did not give relief on US75. In his presentation the following 'summary of findings' were listed.

- 1) US75 must be solved independently
- 2) Computer simulation supports theoretical spacing of facilities

- 3) Spur 399 Extension should get significant consideration. Focus on expediting engineering services for TxDOT
- 4) West Corridor to be advanced through operational improvements and targeted capacity enhancement per local thoroughfare plans.
- 5) Lake Corridor alignment should be considered as a staged freeway (with parkway design). Evaluate reversible facility
- 6) SH78/SH205/John King should continue to be advanced as a thoroughfare (US380 to IH30) and proceed through environmental process.
- 7) Collin County Outer Loop should continue to advance as a staged freeway
- 8) North/South corridor roadway system should be (west to east starting at US75): freeway/operational improvements/freeway/thoroughfare/freeway.

Clarence informed the board that the City of St. Paul has passed a resolution against bridge across lake. Also stating two groups have formed.

Clarence further updated the board regarding US380. TxDOT is performing this feasibility study via contract with Burns & McDonnell to provide options. Clarence used Google Earth to show some results of the study. Prosper/Frisco want on the current alignment only.
