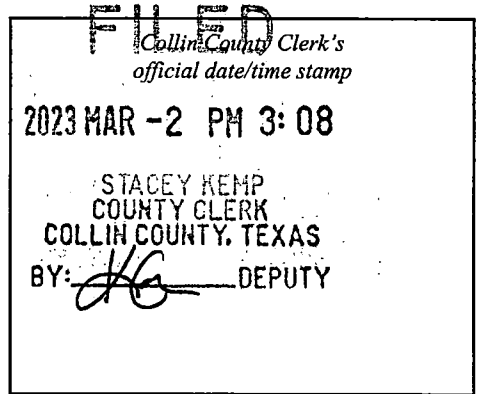

1. Call Meeting to Order

Meeting was called to order at 6:05 pm. The following members were present: Shep Stahel, Steven Wright, Bill Mills, Tim Bennett, Scott Manis, Mark Quinn, Rusty Glover and Joe Helmberger. The following members were not present: Doug Reece ('22 Chair), Steve Terrell, Buddy Dean, Sean Merrell, Sammy Yang, Bill Moore and Terrie O'Donnell. Collin County staff present: Clarence Daugherty.

2. Approval of June 2, 2022 Minutes

Mark Quinn made a motion to approve, second by Bill Mills, which passed unanimously.

3. Update on Projects

Clarence provided an updated on the various County projects.

4. Review of videos and COG's Emerging Technologies website

Clarence encouraged the members to review the videos and information that they could view by going to <https://www.connectntxfutures.org>.

5. New Concept for Transportation Corridors

With the wide ROW that the County is acquiring for the Outer Loop and the new concepts that are emerging in transportation, we should be analyzing the possibility of including more in our corridors. Utility transmission facilities, duct banks for the "wired" information utilities and new transportation modes are all features that could be incorporated in to the Outer Loop corridor.

6. Consideration of New Bond Program

The five year 2018 bond program was scheduled to be completed in 2023. Clarence discussed the need to begin identifying any potential bond projects. Such things as additional funds for cities, funding "mega projects" and converting rural roads that are on the Thor Plan to thoroughfares before they are annexed into cities are examples of types of projects to consider. There seemed to be a general agreement that after the first of the year the Planning Board would take on the development of another bond program.

7. Other Business/ News/ Announcements/Reports

Someone requested that the roster of the Board members be circulated to get any updates to the contacts of all the members, and then to send the updated roster to everyone.

8. Future Agenda Items
