Date:	JURY TRIAL SETTING. This matter is set for Trial by Jury on this date.
Time: 9:00 a.m.	Time for Trial: Each side needs _____ hours. (No more than 5 hours per side unless good cause shown. If additional time is requested, the parties must seek leave of the Court at least 60 days before the first Jury Trial Setting.)
Date:	FORMAL PRE-TRIAL CONFERENCE. This matter is set for pre-trial conference on this date. Parties are encouraged to meet and confer prior to this date to determine agreed exhibits, deposition designations, and motions in limine.
Time:	All pre-trial motions shall be filed at least 10 days before the Formal Pre-trial Conference and will be heard at the Formal Pre-trial Conference. <u>The Court will not hear pre-trial motions on the day of jury selection without prior leave of Court.</u> Unless good cause is shown, all expert challenges (Daubert/Dupont) shall be heard no later than the Formal Pre-Trial Conference, and written objections must be on file at least 10 days before the hearing. Each party must produce the following at the Formal Pre-Trial Conference: (1) Proposed jury charges (questions, instructions, definitions) emailed in editable Word format to the Court Coordinator, (2) Completed witness lists and exhibit lists, (3) All exhibits present and pre-marked for identification.
30 days prior to first Jury Trial Setting	MEDIATION REQUIRED. Parties and their respective attorneys (if represented) shall participate in and attend mediation on or before this date. Failure to participate in mediation is not a basis for continuance of the Jury Trial Setting.
	Unless otherwise ordered, the parties shall select a mediator by agreement. The agreed mediator is _____.
	<i>Parties who fail to mediate are limited to 2 hours per side at jury trial.</i>
30 days prior to first Jury Trial Setting	DISPOSITIVE MOTIONS. All dispositive motions (summary judgment, etc.) must be filed, set for hearing, and heard at least 30 days before trial.
