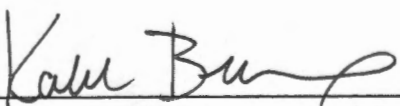


**NOTICE OF DELIVERY OF EARLY VOTING BALLOTING MATERIALS FOR THE
