1. Call to order
 - o The meeting was called to order at 1:07 p.m. by Chairman Derek Borg
2. Approve minutes from March 2, 2017 meeting
 - o John Hebert made a motion to approve the minutes
 - o William Fell seconded the motion
 - o The motion to approve the minutes from the March 2, 2017 meeting passed unanimously
3. Review/approve membership applications:
Danny Ballenger, Ray Byars
 - o Danny Ballenger introduced himself; Ray Byars was unable to attend the meeting
 - o Jim McCrone made a motion to approved the membership applications
 - o William Fell seconded the motion
 - o The motion to approve the membership applications passed unanimously
4. Table top exercise: Operation Release
 - o Jim McCrone presented the table top exercise
 - o This scenario is based on an actual incident in Harris County
 - o Are we prepared to map the plume from the chemical release and possibly close highways and issue a shelter-in-place?
 - o Plan for shifts in the wind
 - o The emergency response guide (ERG) outlines chemical reactions and appropriate responses
 - o First responders need this information to keep themselves and the public safe
 - o Local jurisdictions will be stressed and there would be a need to engage the county Fire Marshal and Emergency Management Coordinator
 - o The Incident Command should be present to coordinate efforts
 - o Media helicopters will be videoing and reporting
 - o The public information officer can help distribute information to the public as quickly as possible through the media



COLLIN COUNTY LEPC

- o Possible contamination could occur due to run-off
 - o NTMWD serves area cities and water conservation may be necessary
 - o Will businesses, shopping districts, vehicles and homes turn off their air conditioning during a chemical release?
 - o Planning with local and regional jurisdictions is important
 - o How should the LEPC reach out to fire chiefs, local establishments, civic organizations and the community in general?
 - o There was discussion of the public response to emergency sirens and if people know to monitor the situation for alerts through the media
 - o The hospitals need early notification to prepare for a contamination area before people are brought in for treatment
 - o Princeton gives people the option of signing up for a code red notification when establishing their water accounts

- o This discussion will be continued as a future item on an agenda
6. Topics and suggestions for next quarterly meeting , place and time TBD
- o What can the LEPC do to make a difference in the community and streamline the dispatch of information to appropriate parties?
 - o The LEPC needs to take opportunities to meet with fire chiefs, rotary clubs and various organizations
 - o The next meeting may be in the City of Allen
 - o There is a possibility of future bi-monthly meetings and forming sub-committees
