 - o Work with County and local jurisdictions to conduct mass casualty incident training and after action review, etc.
 - o Jason Browning gave an update on recent incidents – fertilizer spill-originally reported as 2,000 gallons of liquid fertilizer and actually was 20,000 + gallons of pellet fertilizer; current incident school bus with occupants rear ended by semi truck

8. On July 18, 2018 – will hold a full scale mass casualty/mass fatality exercise
