**#1** The meeting was called to order.

**#2 Review of Minutes Reporting**

A brief review was given on the reporting of January's board meeting minutes, approved via email and posted prior to the meeting on the CCHCF webpage. Future minutes reporting will follow similar suit.

**#3 Review of Non-Profit Grant Awarded Agencies**

Taylor Burton gave a brief overview of the non-profit grant awarded agencies. The Healthcare Foundation Board of Trustees accepted the Advisory Board's recommendations and all five contracts were executed and began on March 1, 2025.

**#4 Presentation by Carevide**

Michael Glas, Deputy Chief Executive Officer of Carevide, delivered a presentation detailing the services offered by their clinic and an overview on how the funding provided by the Collin County Health Care Foundation is utilized. Carevide has over 45 years of experience in providing health care services to the local area. Carevide's services include primary medical care, preventative care for children and adults, and specialized women's health services. They also shared an update about the new clinic site in Farmersville.

**#5      Presentation by CommonGood Medical**

Andrea Naff, Director of Operations and Daniel Moreno, Director of Development, delivered a presentation highlighting the services their clinic offers and how the funding the Collin County Health Care Foundation provides is utilized. CommonGood Medical gave an overview on the preventative care, chronic disease management, and counseling services provided. They also shared an update regarding their new clinic in Farmersville and the planned expansion of their services.

**#6      General Health Care Update**

Candy Blair, Taylor Burton, and Grace Powers gave an overall public health update for Collin County.
