**#1** The meeting was called to order. The minutes from the October 21, 2021 meeting were approved by the board.

**#2 Review of Collin County Health Care Foundation Non-Profit Grant Applications and Award Recommendations**

A presentation was provided on six agencies that applied for grant funding.

- Allen Community Outreach requested \$3,000
- Community Health Clinic of McKinney requested \$50,000
- Community Health Service Agency, Inc. requested \$50,000
- Health Services of North Texas requested \$50,000
- Hope Clinic of McKinney requested \$50,000
- Samaritan Inn requested \$10,350

After review of the grant requests, the board members motioned to advise the Commissioners Court to award partial funding of the total above requested amounts by the agencies. The board motioned to allow the agencies options on their use of grant funds for medical services allowed under the grant terms.

Funding recommendations to Commissioners Court:

- Allen Community Outreach requested \$2,000
- Community Health Clinic of McKinney requested \$50,000
- Community Health Service Agency, Inc. requested \$12,500
- Health Services of North Texas requested \$12,500
- Hope Clinic of McKinney requested \$40,000
- Samaritan Inn requested \$3,000

**#3      Election of Officers**
