



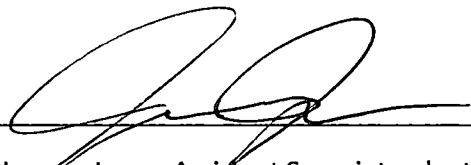

ANNUAL DATA REPORT, FINDINGS AND ACTION PLAN

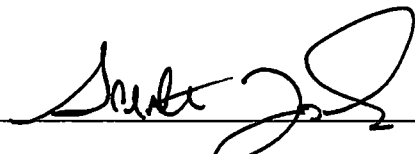

1. Reference: 28 CFR 115.388 – Data Review for Corrective Action
2. The sexual abuse and sexual harassment incident data has been reviewed and the Sexual Abuse and Sexual Harassment Aggregate Data report has been updated for the calendar year 2024.
3. The following was noted for the calendar year 2024 data:
 - a. Collin County Juvenile Detention reported one (1) Youth-on-Youth Nonconsensual Sexual Acts.
 - i. This incident was investigated.
 - ii. This incident was concluded as Unfounded.
 - b. Collin County Juvenile Detention reported zero (0) Youth-on-Youth Abusive Sexual Contact incidents.
 - c. Collin County Juvenile Detention reported twenty-five (25) Youth-on-Youth Sexual Harassment incidents.
 - i. All incidents were investigated.
 - ii. Five (5) incidents were Substantiated.
 - iii. Eighteen (18) incidents were Unsubstantiated.
 - iv. Two (2) incidents were Unfounded.
 - d. Collin County Juvenile Detention reported one (1) incident of staff Sexual Misconduct.
 - i. The incident was investigated.
 - ii. The staff member involved was removed from contact with juveniles until the conclusion of the investigation.
 - iii. The incident was Unfounded.

- e. Collin County Juvenile Detention reported zero (0) incident of staff Sexual Harassment.
 - f. Collin County Juvenile Detention reported zero (0) incidents of reports made by a juvenile of abuse in an outside agency. These incidents are reported appropriately by this facility according to PREA guidelines when received.
4. CORRECTIVE ACTION: Video review and interviews were conducted for all appropriate incidents. When appropriate, the investigation is overturned to TJJD or the Collin County Sheriff's Office. This facility strives to keep anyone involved in these investigations separate, and new policies and rules in the facility are enacted when appropriate.
5. Progress in the Prevention of, Detection of, and Response of Sexual Abuse and Harassment:
- a. Cameras are installed in the facility, adding to the security of all juveniles and staff.
 - b. The facility continues to train new officers on PREA standards, and review PREA standards with all officers annually.
 - c. The PREA Coordinator, Superintendent, and Assistant Superintendent, Training Coordinator along with supervisors, will continue to do unannounced rounds at unexpected times. The unannounced rounds will continue to happen across all shifts.
 - d. The facility will investigate all allegations of sexual abuse/sexual harassment.
