Coming Soon: Law Library Online Public Access Catalog!

The Collin County Law Library is pleased to announce the completion of an online public access catalog! The days of wondering what is in the Law Library collection are over. Everyone will soon be able to search for materials in the Law Library collection simply by clicking a link on the library's web site and searching by either title or keyword.

The task of creating an online catalog of titles contained in the Law Library collection has taken ten years to complete. Collin County is proud to be one of the first county law libraries in the state of Texas to offer this service to our patrons. **The Law Library catalog will come online later this summer.** Watch for announcements in the upcoming issues of *Bar Tabs* and *Truth, Justice, and Information for All*.

Library Catalog Naming Contest

Law Library Newsletter: Proposed Changes

The Law Library is **considering discontinuing the print publication** of *Truth, Justice, & Information For All*, the official newsletter of the Collin County Law Library after 2006. Beginning in 2007, the newsletter would be distributed in an **electronic format only**.

The newsletter currently circulates to nearly **1,200** local attorneys, county officials, and libraries. The cost of printing, supplies, and staff time devoted to preparing the paper newsletter for distribution is considerable.

Internet Spotlight

Search Engine: GigaBlast www.gigablast.com

A new search engine you may want to check out is Gigablast. It functions like most search engines, with an extra feature that helps you narrow your search. After entering your search terms and clicking the “Blast Off!” button to launch the search, the result list will display. In addition to your listing of search results, Gigablast provides you with a list of “Gigabits.” These “bits” are **suggested search terms** that appear on web pages frequently alongside the search terms you entered. Simply click on one of these suggested terms to narrow your search!



CIA World Factbook Online www.cia.gov/cia/publications/factbook/

Want to know the population of Uzbekistan? What about the unemployment rate in the Netherlands? Find the answers to these and other questions about a particular country in the CIA World Factbook online. Updated on an almost daily basis the Factbook provides factual and statistical data about every country on the globe. Information

provided includes geographical facts, population, religion, ethnic groups, form of government, economic data, and more.

Texas Judiciary Online www.courts.state.tx.us

If you're not using Texas Judiciary Online, you should be! This site offers a wealth of information about the Texas courts.

From here, you can access the web sites of Texas trial courts, appellate courts, the Court of Criminal Appeals, and the Texas Supreme Court. Many of these courts, including the appellate courts and the Supreme Court, offer a **case search** feature which enables you to look up opinions that have been issued by that court as well as

view all of the events in the case file. This can be a helpful way of searching for the status of a petition for review, etc.

In addition, this site also offers electronic versions of **court rules**, including the Texas Rules of Civil Procedure, Texas Rules of Judicial Administration, and various rules advisories.

Did you know...?

Did you know that the Law Library has some **older titles available on microfiche**? Our collection of the *General and Special Laws of the State of Texas* (i.e.—the state session laws) reaches back to the 53rd Legislature (1954), with many of those sessions on microfiche. The Law Library also has *Texas Law Review* issues dating back to 1970!

Did you know that the Law Library has a **portable DVD player** available for attorneys to use for viewing CLE materials checked out from the Law Library. The player can be connected to a TV at your home or office; or you can use the player's accompanying DVD monitor to view the materials.

Role and Duties of the Attorney Ad Litem in Child Protection Litigation



The Law Library is now offering the Role and Duties of the Attorney Ad Litem in Child Protection Litigation course. Completion of this course fulfills the 3 hour CLE training requirement to become an Attorney Ad Litem in DFPS termination and conservatorship suits. This is a self-study DVD course worth 3 hours (.5 hour ethics) Self-Study credit. The Law Library is providing this course at no charge to assist attorneys in meeting the requirements to receive **court appointments as Attorney Ad Litem** in termination and conservatorship suits filed by the DFPS in Collin County. The DVDs and coursebook are available for check-out at the Law Library.



Coming Soon: Advanced Guardianship Course 2006



The Law Library will be offering the Advanced Guardianship Course 2006 at no charge to assist attorneys in meeting the requirements to receive **court appointments as Guardian Ad Litem** in the Collin County courts. This course is a self-study DVD course worth 5 hours (2.5 hours ethics) Self-Study credit. In order to qualify for Guardian Ad Litem certification, you must complete a training program that is at least 3 hours in length. Certification lasts two years from the date of the certificate. Attorneys who have been certified twice (four total years consecutively) may be certified a third time for four years. In order to receive Guardian Ad Litem appointments in the Collin County courts, you must submit a resume with a cover letter to each court for which you want to receive appointments.

The librarians wanted to select a book that would reflect the importance of law libraries to the people they serve. This title is now on display at the Law Library.

Law Library Director Attends Conference

Collin County Law Library Director Judy McCullough attended the annual conference of the Southwestern Association of Law Libraries in Austin in April. The theme of the conference was "Information in Motion" and seminar topics included new search engine trends, legislative history research, and legal information blogs, as well as a tour of the University of Texas Tarlton Law Library on the UT campus. Judy also met with other county law librarians from

across Texas and the southwest to share ideas and discuss county law library services.

Assistant Law Librarian Participates in CCYLA Wills for Heroes Program

As a part of the Law Library's commitment to outreach, Assistant Law Librarian Katy Gill volunteered to participate in the Collin County Young Lawyers Association "Wills For Heroes" program held in the Collin County courthouse central jury room in April. Twenty-five police officers, fire fighters, and other emergency personnel were provided with wills and other estate planning instruments free of charge. Many local attorneys participated, interviewing and consulting with the officers while other volunteers typed up the documents. This event was organized by Collin County's own Cynthia Walker and sponsored by the Collin County Young Lawyers Association.
