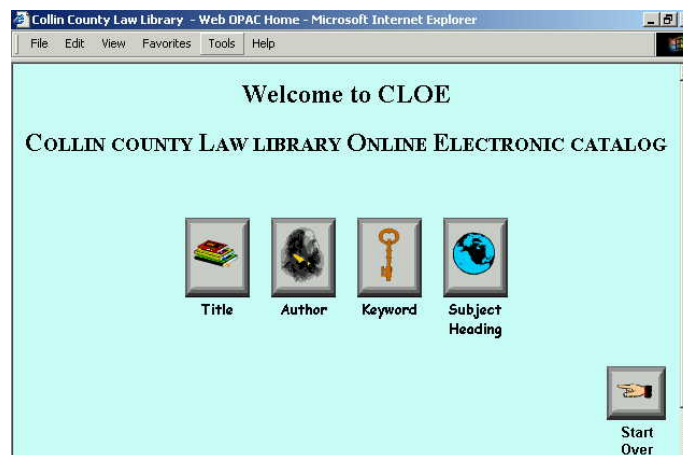

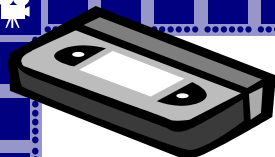

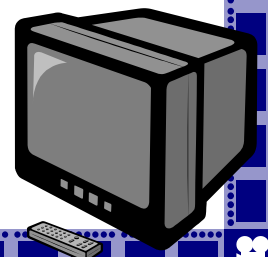


Check It Out: The Law Library DVD / Video Collection

Library News

Librarian Attends Conference

Assistant Law Librarian Katy Gill attended the annual conference of the American Association of Law Libraries in St. Louis, Missouri in July. This year’s conference marked the 100th anniversary of the Association with a centennial celebration. The theme of the conference was “Pioneering Change” and was attended by over 1700 law librarians from around the United States and across the globe. Katy met with other county law librarians from around Texas and the U.S. to discuss library needs and services.

*** ATTENTION ATTORNEYS ***

As Collin County grows, the Law Library is working to accommodate the legal resource needs of a rapidly increasing community of attorneys and citizens. In order for the Law Library to ensure that it can provide adequate space and resources to its users, attorneys are asked to observe the following guidelines for using the library facility. We appreciate your cooperation.

Attorney Workstation Use

The Law Library Workstation is not intended to be used as an office by attorneys. The library's computers should only be used for research or to draft short documents.

Use of the Law Library's Attorney Workstation is permitted in **time slots of 30-minute** increments on a first-come, first-served basis. Users must note their start time on the Sign-In Sheet provided, indicating the time they begin using the Workstation. Users will be limited to a single 30-minute time slot if another person has subsequently requested access to the Workstation. If no one has subsequently requested access to the computer, then the current user may continue past the 30-minute time slot, subject to removal if another user requests access. In addition, attorneys are asked to limit their use of the computers in the Law Library to a **maximum of two hours per week**.

Attorney-Client Meetings

The work tables and study areas in the Law Library are designated for Law Library researchers ONLY. These areas are NOT for use for lengthy attorney-client meetings. Attorneys who need to meet with clients or witnesses at the courthouse for more than just a few minutes are asked to hold such meetings outside of the Law Library. The library can only accommodate short meetings. There are seating areas on the 2nd floor on the east side of the courtrooms as well as seating on the 4th floor on the north side of the courthouse.

Laptop Use

Attorneys wishing to use their laptops in the Law Library are asked to sit in the study areas located in the back of the Law Library to allow library researchers access to the worktables at the front.

Law Library Newsletter: Changes

The Law Library will be **discontinuing the print publication** of *Truth, Justice, & Information For All*, the official newsletter of the Collin County Law Library after 2006. Beginning in 2007, the newsletter will be distributed in an **electronic format only**.

The newsletter currently circulates to nearly **1,200** local attorneys, county officials, and libraries. The cost of printing, supplies, and staff time devoted to preparing the paper newsletter for distribution is considerable.

We ask that all attorneys who wish to continue to receive the Law Library newsletter after printing ceases, **please send us your email address as soon as possible** so that we can include it in the email mailing list.
