Police Deception During Interrogation and Its Surprising Influence on Jurors' Perceptions of Confession Evidence

This article asks: do jurors decide cases differently when the police use false-evidence ploys during interrogation? The writers set up an experiment in which two groups of people read trial summaries of a case. One group's summary contained a false-evidence ploy, the other group's summary contained no such ploy. Participants who read the false-evidence summary also read an interrogation transcript that depicted a demeanor, testimonial or scientific false-evidence ploy. All participants rendered verdicts and those who convicted the defendant also recommended sentences. The people who read the false-evidence ploys rated the interrogations as more coercive and deceptive than the people who did not. This group also recommended lighter sentences than the control group. The authors conclude that "this outcome suggests jurors viewed the defendant exposed to police deception as less deserving of punishment even though the crime, the evidence, and the presence of the confession were identical."

The authors make seven recommendations for attorneys, including: "Defense attorneys should attempt to introduce an expert witness in the

area of false confessions, to educate jurors ...when appropriate, voir dire should include questions concerning false confessions and the degrees to which jurors see themselves and others as capable of making a false confession."

The World Intellectual Property Organization (WIPO) has launched an online database of patent, trademark, copyright, trade secret and competition laws and regulations. The home page includes tabs for member states' profiles, and treaties, and also has a newsfeed for treaty info. Full text search is available, and includes many English translations for countries such as China.

Free Caselaw search in Google Scholar

Google now provides a way to search caselaw for free, via google scholar. Google has made available state appellate and supreme court cases since 1950; US federal district, appellate tax and bankruptcy courts since 1923; and US supreme court case since 1791. You can access it by going to <http://scholar.google.com> and choosing the button for **legal opinions and journals**. For the best results, click on the **Advanced Scholar Search** link. Once in **Advanced Search**, scroll down to the bottom of the page and choose the option for federal courts or State courts (see below).

Google doesn't have Keycite or Shephardizing, but clicking on the **How Cited** tab will get you snippet examples of how the case is cited (in all kinds of documents) as well as a list of **Cited by** cases that cite it and **Related documents**, which are cases similar in structure or content (see below). There is no option for finding a case by citation, but you can "force" one by typing in the citation in quotes and using the **in the title of the article** option.
