Useful Internet Sites and Articles

Texas Justice Court Training Center (TJCTC) (<https://www.tjctc.org/>)

According to its website, the Texas Justice Court Training Center is "an educational endeavor of the Justices of the Peace and Constables Association funded by a grant from the Texas Court of Criminal Appeals" and is affiliated with Texas State University. Justices of the Peace, Court Personnel and Civil Process Personnel have the option of creating a unique login for access to the TJCTC newsletters and updates. However, a login is not necessary to access the number of free resources available through the site. These resources include online deskbooks, charts and checklists and unique learning opportunities through online webinars. Each resource is explained in more detail below and is helpful for either attorneys or self-represented litigants.

Deskbooks

The deskbooks may be downloaded for free and each one contains a clickable table of contents. The following deskbooks are accessible: Administrative Proceedings Deskbook, Civil Deskbook, Criminal Deskbook, Evictions Deskbook, Fines, Fees, and Costs Deskbook, Inquests Deskbook, Juvenile Deskbook, Magistration Deskbook, Officeholding & Ethics Deskbook and Trial Notebook.

Forms

The legal department of the TJCTC created over 100 civil and criminal forms all available free of charge. Forms are available for the following areas: Administrative Proceedings, Criminal Procedure, Debt Claim, Evictions and Landlord-Tenant, General Officeholding, Inquests, Magistration, Repair & Remedy, Small Claims, and Truancy. Spanish forms are available as well as Self-Represented Litigant Packets for eviction, small claims and debt claim cases.

Charts and Checklists

Another unique resource through TJCTC is the access to charts and checklists. These are a quick overview that shows the procedure and order of events in several different areas with more practice areas being added all the time. Some examples of the charts available now are an occupational driver license flowchart, eviction appeal flowcharts, and a truancy adjudication hearing flowchart.

Online Learning

Spotlight on the Supremes

Chief Justice Nathan Hecht was named to lead two national court organizations. On August 3, 2020, Chief Justice Hecht began his term as President of the Conference of Chief Justices (CCJ) and as Chair of the National Center for State Courts (NCSC) Board of Directors. According to its website, the CCJ was founded in 1949 and “provides an opportunity for the highest judicial officers of the states to meet and discuss matters of importance in improving the administration of justice, rules, and methods of procedure, and the organization and operation of state courts and judicial systems, and to make recommendations and bring about improvements on such matters” (<https://ccj.ncsc.org/>). Chief Justice Hecht is the fifth Texas Supreme Court Justice to lead the CCJ.

Did You Know?

On May 26, 2020, the Supreme Court of Texas justices signed the *Order Amending Texas Rules of Civil Procedure 47, 500.3, 509.2, and 509.6*. The amendments to the rules will be effective September 1, 2020, and are summarized below. Rule 47 changes both Rule 47(c)(3) and (4), increasing claims for relief under those sections from \$200,000 to \$250,000. Rule 500.3 increases the recovery amount for justice court cases from \$10,000 to \$20,000 (excluding statutory interest and court costs but including attorney fees, if any) for small claims cases, debt claim cases, repair and remedy cases, and eviction cases. Rules 509.2 and 509.6 govern repair and remedy suits and the amendments to those reflect the increase from \$10,000 to \$20,000. Rule 509.2 will read that the petition must include “a statement that the total relief requested does not exceed \$20,000, excluding interest and court costs but including attorney’s fees” and Rule 509.6 will read that “judgment may be rendered against the landlord for failure to repair or remedy a condition at the residential rental property if the total judgment does not exceed \$20,000, excluding interest and court costs but including attorney’s fees.”

Westlaw Patron Access Extended

The last edition of *The Information Edge* explained how patrons were able to access free Westlaw for a limited period of time. However, since many libraries either remain closed or have reopened with limited service, Westlaw has agreed to continue to provide free access to primary law, secondary sources, litigation and Practical Law through Westlaw Next. While no expiration date has been provided, access is limited to 20 hours of usage over 14 days.
