The Law Library has free public access subscriptions to Lexis Advance and Westlaw.

Notary Policy:

All Collin County Law Library employees are Texas Notaries Public, and notarial services are provided free of charge. However, our notaries may not always be available.

All documents presented for notarization must have a notarial certificate at the end of the document. A notary cannot select the type of notarial certificate used for any document unless they are also an attorney. Our Law Librarians have sample notarial certificates that you can review.

Collin County Law Library notaries will not notarize Wills. Additionally, Texas law does not authorize notaries public to certify an I-9 Employment Eligibility Form, and the Form itself does not contain a notarial certificate.

The Law Library staff can:

- show you the forms we have
- help you find books and resources that might help you with your case
- give you general information about court rules, procedures and practices
- direct you to useful internet sites
- show you how to use our computer legal research tools.

The Law Library staff cannot:

- fill out your form for you or tell you what words to use
- tell you which forms you should use
- analyze your case
- interpret or explain cases and laws
- speculate as to what a judge might decide.
- give any legal advice

89th Legislative Session Updates

- SB 2

Relating to the establishment of an education savings account (ESA) program.

SB 2 provides for education savings accounts administered by the Texas State Comptroller. Every student in Texas may apply and, if accepted, participate in the ESA program. Most participating families will receive approximately \$10,000 per year per child. Children with disabilities will receive up to an additional \$30,000 per year. Home-school students are eligible for up to \$2,000 per year. The law is effective September 1, 2025 and is expected to launch in late 2026.

- SB 14

Relating to creation of a Texas regulation cutting-agency.

SB 14 creates a "Texas Regulatory Efficiency Office" in order to make Texas government more efficient and less costly. The Regulatory Efficiency Office will advise other state agencies on ways to make regulations more effective and efficient. The law is effective September 1, 2025.

Pending Bills of Interest:

- SB 849

Introduces significant changes to Texas family law regarding child custody and parenting arrangements, with a primary focus on promoting equal parenting time. The bill establishes a new "equal parenting order" as the presumptive standard for joint managing conservators, which provides both parents with essentially equal or nearly equal periods of physical possession and access to their child.

- SB 3

Relating to the regulation of consumable hemp products and the hemp-derived cannabinoids contained in those products; requiring a registration; imposing fees; creating criminal offenses; providing an administrative penalty.

ARE YOU REAL ID COMPLIANT?

Are you “STAR” official?

Good news, if your current Texas driver license, or ID is REAL ID- compliant if it has a gold star in the top right corner.

If it does not, than you are not REAL compliant, and may want to request a renewal or replacement.

Getting a Texas REAL ID

You can apply for a REAL ID or driver license in person at Department of Public Safety (DPS) office. You may be eligible to renew your existing ID or license online.

You can still use your current ID or driver license if it is not expired, and for non-federal purposes.

To get a REAL- ID or driver license you will need:

To make an appointment with Department of Public Safety (DPS), if you cannot renew online

You will need to bring an original or certified copy of your Birth Certificate or an unexpired United States Passport Book or Card

Your current Texas Vehicle Registration or Title

Current car Insure Police or Car Insurance Statement

If you name changed, legal documents showing proof of name change from your birth name

Starting May 7, 2025, you will need to be REAL- ID compliant to fly!
