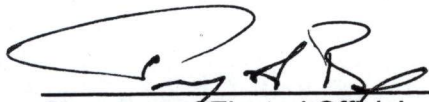

Subject: Medical emergency County Court at Law 2

On March 31, 2015 at approximately 1357 I Deputy Munger #2482, am assigned to the courthouse at 2100 Bloomdale Road in McKinney, Texas; was at the security desk on the north side of the courthouse at the employee entrance. I heard Deputy Gill #2455 call via radio a medical emergency in County Court at Law 2.

I responded to the court room and noticed Deputy Gill on his knee beside a white male who was lying on his back to the left of the prosecutor's table. The subject was later identified as [REDACTED]. Deputy Gill stated that the [REDACTED] had stopped breathing at one point but was breathing at that time I arrived. I kneeled down on the opposite side of where Deputy Gill was. [REDACTED] kept on closing his eyes and when he closed his eyes he appeared to stop breathing. Deputy Gill would give [REDACTED] a sternum rub to get him to wake up and breath. Deputy Gill and Myself pulled up [REDACTED] shirt so Sgt. Henry could put the AED Pads on him. Deputy Gill also patted the side of his face when it appeared that he was going to close his eyes or had his eyes closed but breathing. I gave [REDACTED] a couple of sternum rubs also while Deputy Gill was searching [REDACTED] wallet for a paper. Every time that a sternum rub was used [REDACTED] would wake up and gasp for air. John Bowers (Homeland Security Supervisor, Blue Ridge Fire Chief), who is a certified EMT, came up beside me and started checking [REDACTED] vital signs. [REDACTED] was in and out consciousness at times but was also able to talk to us.

Bowers removed the AED pads due to the AED never advising that [REDACTED] needed a shock. McKinney Fire/EMS showed up on scene and placed [REDACTED] on the gurney. [REDACTED] was then taken to the ambulance by McKinney Fire/EMS to be transported to Medical Center of McKinney.

Dep. Munger assisted Dep. Gill during this incident.
I recommend a GEM award for Dep. Munger.
