department could get to the residence. Maria was able to track the person's cell phone


and contact authorities in Oklahoma concerning the situation. Between working with the



Dear Sheriff Box,

I wanted to take a moment to share with you what I believe to be truly exceptional actions taken by one of your dispatch supervisors that saved a woman's life on March 13th, 2014.

On that date, the Melissa Police Department received a report of an attempted suicide where the person had fled from Melissa before police could reach her. While she was away, the suicidal person advised that she had ingested a large amount of prescription medication and was about to lose consciousness. While her husband was talking to her on the phone, our officer was relaying facts to dispatcher Maria Lemonds, who was working with her cell phone company to ping the phone and then sending local law enforcement in Oklahoma to the area to search for her.

No sooner did the suicidal person pass out on the phone did deputies from the Bryan County, Oklahoma, Sheriff's Office locate the woman and summoned medical aid and thus saved her life. Had it not been for Lemonds' quick work of getting the phone tracked, contacting agencies around the coordinates and relaying information being gathered by Melissa Police at her residence, it is almost certain that the victim would have likely died before being found.

On behalf of the Melissa Police Department, we are very thankful for all that your dispatchers do for us, but especially for the outstanding work Dispatcher Lemonds demonstrated that day.
