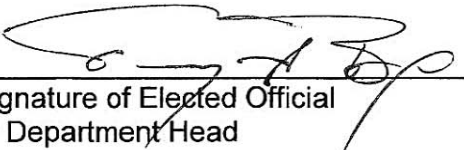

Narrative: On two separate occasions, Officer McDaniel has found methamphetamine in inmates' property. The first occasion was on 12/21/13 when he discovered methamphetamine in Inmate [REDACTED] valuable property while checking the inventory. The substance was tested, a criminal charge was filed by myself and Inmate [REDACTED] was convicted. Again on 01/31/14, while answering an inmate request for phone numbers, Officer McDaniel's thorough search of Inmate [REDACTED] bulk property revealed a small folded paper concealing methamphetamine, leading to an additional criminal charge being filed. In both instances, Officer McDaniel acted quickly to notify me of the possible narcotics without disrupting the evidence beyond the initial discovery. Due to the thorough searches and good job in following up, Officer McDaniel was able to ensure these inmates were not released with additional illegal drugs in hand. The community overall was served by his actions. For these reasons, I am submitting Officer McDaniel for a G.E.M. Recognition award.
